- ROY J. BURROUGHS is an international housing advisor in the Office of the Administrator of the Housing and Home Finance Agency. At the time the survey described by him in this issue was made, he was in charge of the Farm Construction Section of the Division of Agricultural Finance in BAE.
- FRANK LOWENSTEIN, a member of the staff of the Division of Statistical and Historical Research, regularly analyzes the current situation and outlook for cotton.
- GLENN L. BURROWS, a member of the statistical consulting unit of the Bureau, has been active in exploring the possibilities of applying to the solution of economic problems some of the experimental designs used in agronomy, biology, and engineering.
- MAX J. WASSERMAN, long interested in problems of monopoly and free enterprise, is the author of L'Oeuvre de la Federal Trade Commission, which was awarded the France-Amerique prize in 1926. He is Special Assistant, Intelligence and Services, Office of International Trade, Department of Commerce, and teaches an evening class in Government Control of Business at Howard University.
- BUSHROD W. ALLIN, chairman of the Outlook and Situation Board, is a student of economic theory who drew inspiration from John R. Commons and the Wisconsin group.
- GUSTAV F. PAPANEK, formerly with the Office of the Chief of the Bureau, is now on the Program Planning Staff of the Asia Development Service, the Technical Cooperation Administration, Department of State (Point Four).
- NATHAN KOFFSKY is Associate Head of the Division of Statistical and Historical Research and Vice Chairman of the Department's Outlook and Situation Board.
- JOSEPH E. RICKENBACKER, from the University of Oregon, is a Research Interne in the Division of Marketing and Transportation Research under the Department's program in cooperation with the Land Grant College Association to train outstanding graduate students through employment on research projects in the Department.

KARL FOX is Head of the Division of Statistical and Historical Research.

Caroline B. Sherman, who was active in initiating Agricultural Economics Research in January 1949, and who has been one of its editors since that time, retired from the Bureau of Agricultural Economics last October. She was a 'charter member' of BAE, coming into the Bureau when it was created in 1922. Last May, she received the Superior Service Award of the Department for "unusual effectiveness in writing, editing, and disseminating information to farmers and others, and for her skill in helping other authors to present their findings in a way well suited to their readers. . . ." Miss Sherman is succeeded by Charles E. Rogers. He was head of the journalism department at Kansas State College and later at Iowa State College, and was with FAO from 1946 to 1951. Herman Southworth continues to have primary responsibility for the technical content of the magazine.
