1. Policy and procedures for quality assurance

Policies & procedures



EHEA

- **Design of the study programme.** All the universities develop their own strategies linked to the QA on their study programmes.
- **People involved.** Students, administrative staff and other stakeholders are involved in the process

Uzbekistan universities

- **Design of the study programme.** The study programmes are the same in all universities
- **People involved.** The study programmes are designed in the Ministry, with the help of experts.

2. Approval, monitoring and periodic review



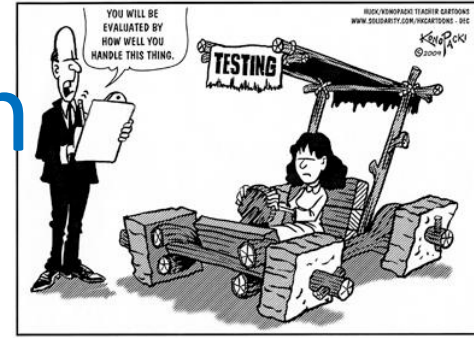
EHEA

- **Internal QA system.**
The faculty is directly involved in the control and review of their study programmes.
- **External QA system:**
National QA agency belonging to an international network and subjected to external evaluation

Uz Universities

- **Internal QA system.** The internal control and review is mainly done by the university.
- **External QA system:** State testing center + Ministry

3. Assessment and selection of students



EHEA

- **Selection of the students:**
 - Each university selects their own students
 - Admission criteria are public
- **Assessment of students:**
 - The students are assessed using published criteria and procedures
 - Published for each of the subjects
 - ECTS is used

Uz universities

- **Selection of the students:**
 - Each university selects their own students
 - Admission criteria are public
- **Assessment of students:**
 - Rating system
 - Testing

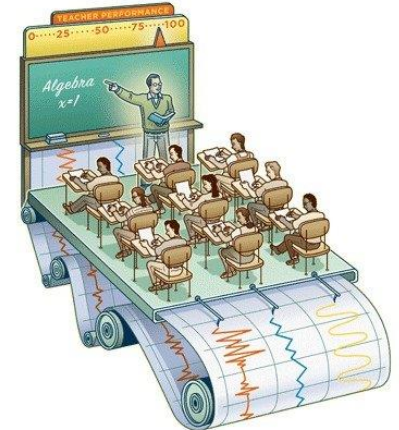
4. Quality assurance of teaching staff

EHEA

- Universities select their teaching staff
- The procedures are available for external reviews
- Information on the academic activity is public

UZ universities

- The teaching staff is selected by the university



5. Learning resources and student support



EHEA

- Publication of facilities in the faculty web page (laboratories, workshops, experimental plots, halls for presentations, meeting rooms, etc.)

Uz Universities

- The information is available on University web pages

6. Public information



EHEA

- University regularly **publish objective information** (quantitative and qualitative), about the programmes they are offering
 - Contents
 - Statistics (Graduation rate: Dropout rate; Efficiency rate; Performance rate)

Uz Universities

- The university and STC webpages provide the information
- Regular “Job Fairs”

2. Internal QA structures

EHEA

- The faculty board evaluates the results, and proposes improvements
- The faculty board is made up by teachers, students and administrative staff

Uz universities

- Educational department and Internal Control and Monitoring departments are responsible for education quality internally

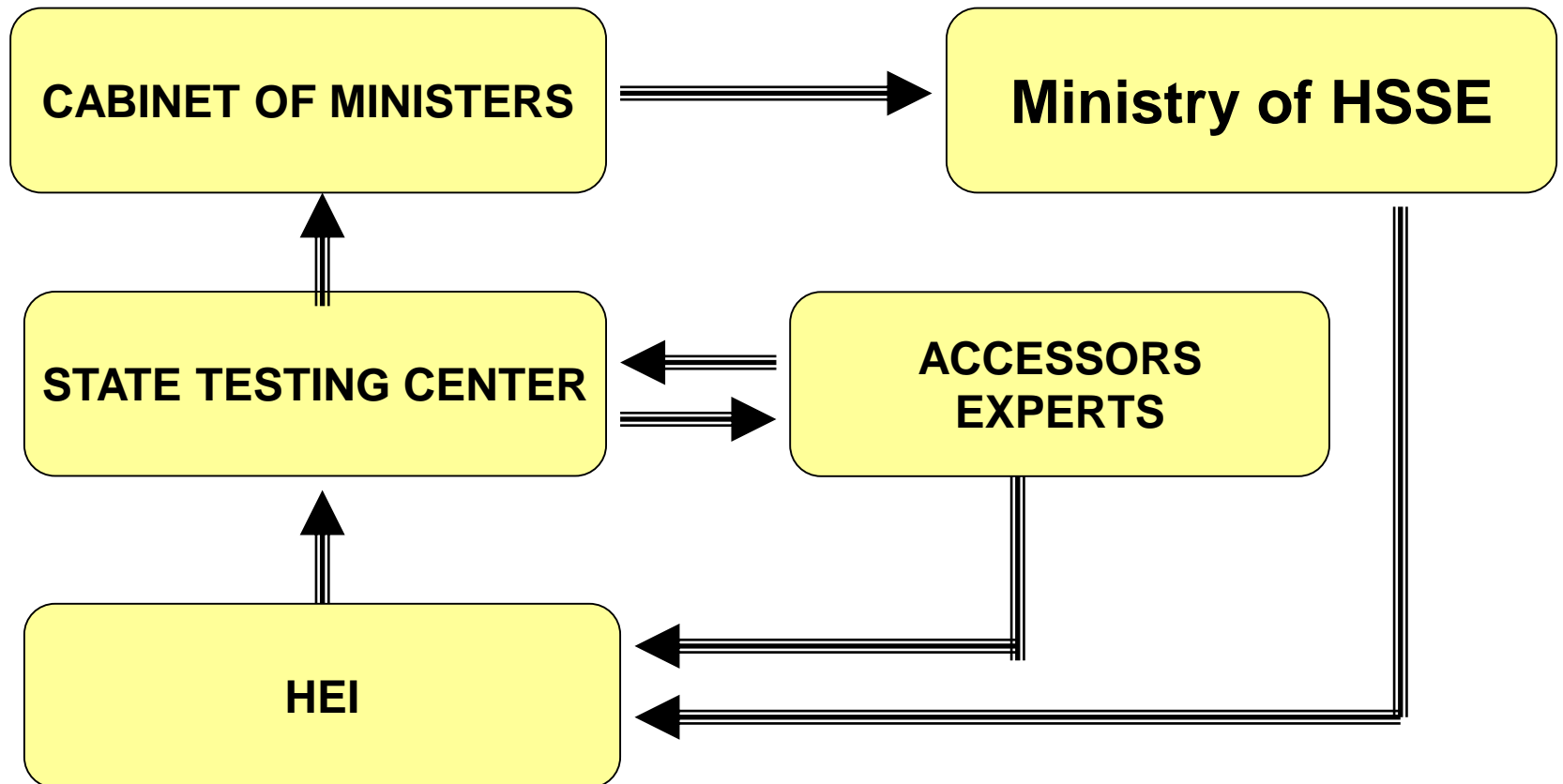
