In accordance with the provisions of Section 65.5 of the Agricultural Code, I hereby submit the annual crop report of Lake County for the year 1953.

Lake County is situated about 100 miles north of the Bay area in the mountainous region between the coast counties and the Sacramento Valley. Its land area is about 812,160 acres. Clear Lake, Lake County, is the largest lake within the boundaries of the state, covering an area of 41,000 acres.

The grand total for 1953 is \$2,693,244 less than that of 1952; PMA payments and timber income which account for \$519,400 of this reduction have been deleted from this year's report. The annual value of some of the agricultural crops for the year 1953 is considerably less than 1952 because of heavy frost damage to deciduous fruits and nuts and considerably lower prices for beef as compared to last year.

The amounts shown as farm income in this report are gross figures; no deductions have been made for cost of production.

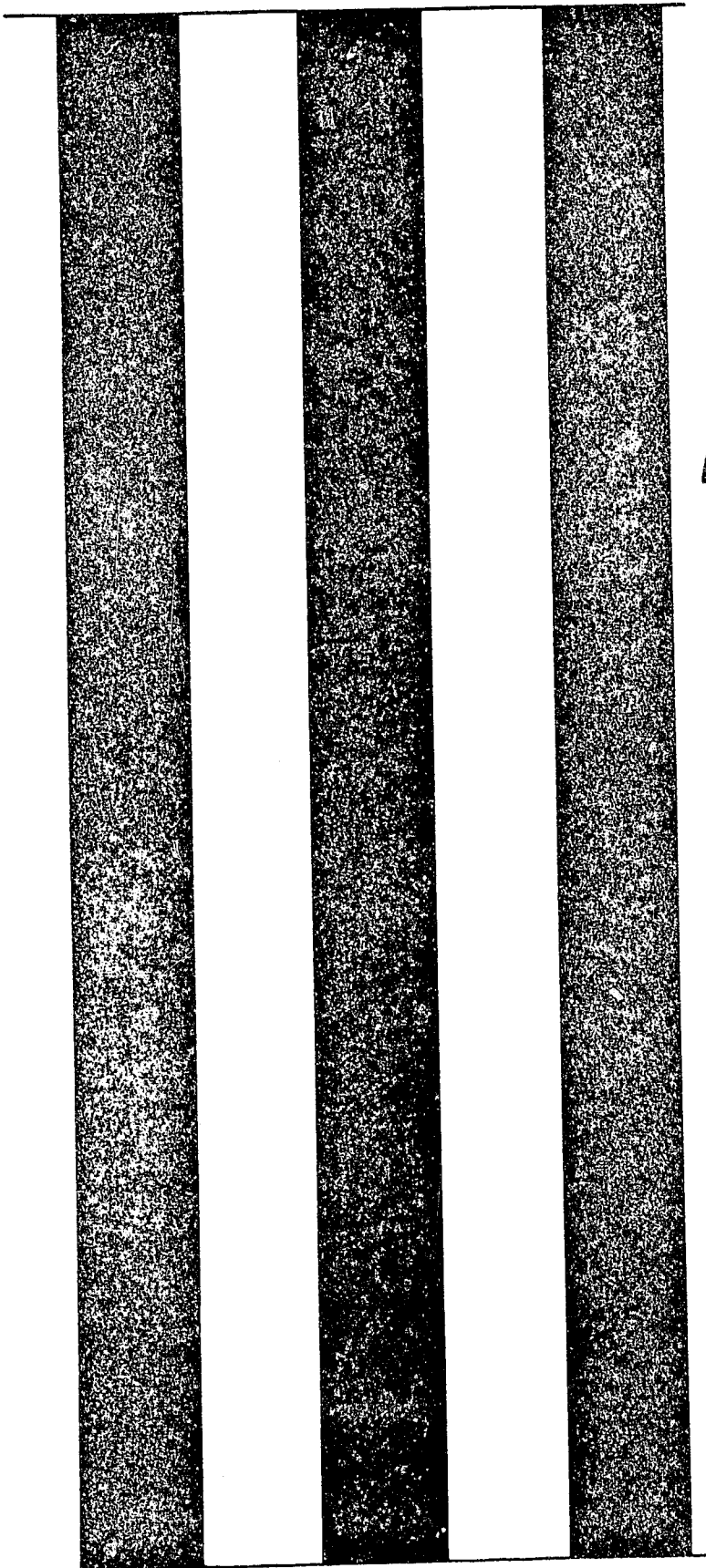

The grand total for 1954 is \$2,125,256 more than the 1953 total. There has been a decided increase in income from deciduous fruits and nuts and a noticeable decrease in poultry income. The amounts shown as farm income in this report are gross figures; no deductions have been made for cost of production.

Gentlemen:

In compliance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the Lake County Agricultural Crop Report for the calendar year 1981. Lake County's gross value for 1981 agricultural crops totaled \$37,157,310, a 0.7% increase of \$267,865 over the previous year and a new high for Lake County.

Pears continue to be the leading agricultural crop in Lake County with a gross value of \$18,407,905. This value is up \$126,670 over the previous year, primarily due to fresh pack pear prices were up a bit and tonnages nearly equal to the previous year. A greater amount of the processed pears went to juice in 1981. Walnut prices were up a bit and total yield down somewhat from last year, thus totaling \$4,278,295. Grape yields and tonnage continue to increase as more vineyards mature. Tonnage unit prices increased somewhat over last year because more of the white grape variety tonnages are reflected in this year's total crop of \$3,603,160. Kiwi production has become significant enough in production and numbers of growers producing that I have reported it as a separate crop item this year in the amount of \$268,500 on 89.5 tons.

Field crops were about the same production, with inclusion of a new crop (wild rice). This increase amounted to \$14,280 over the previous year.

Livestock values were down somewhat from last year. Unit prices were down on cattle and sheep. Sheep numbers are increasing slightly as more small family farm units occur and provide a livestock enterprise along with an off-farm job. Aquaculture dropped off in production substantially from the previous year.

I must emphasize that this Crop Report represents gross values of agricultural products and does not reflect costs of producing these crops nor a net return to the grower.

The Department sincerely appreciates the cooperation of the many growers, packing houses, vintners, livestock producers and various other producers in supplying the information necessary for this report.
