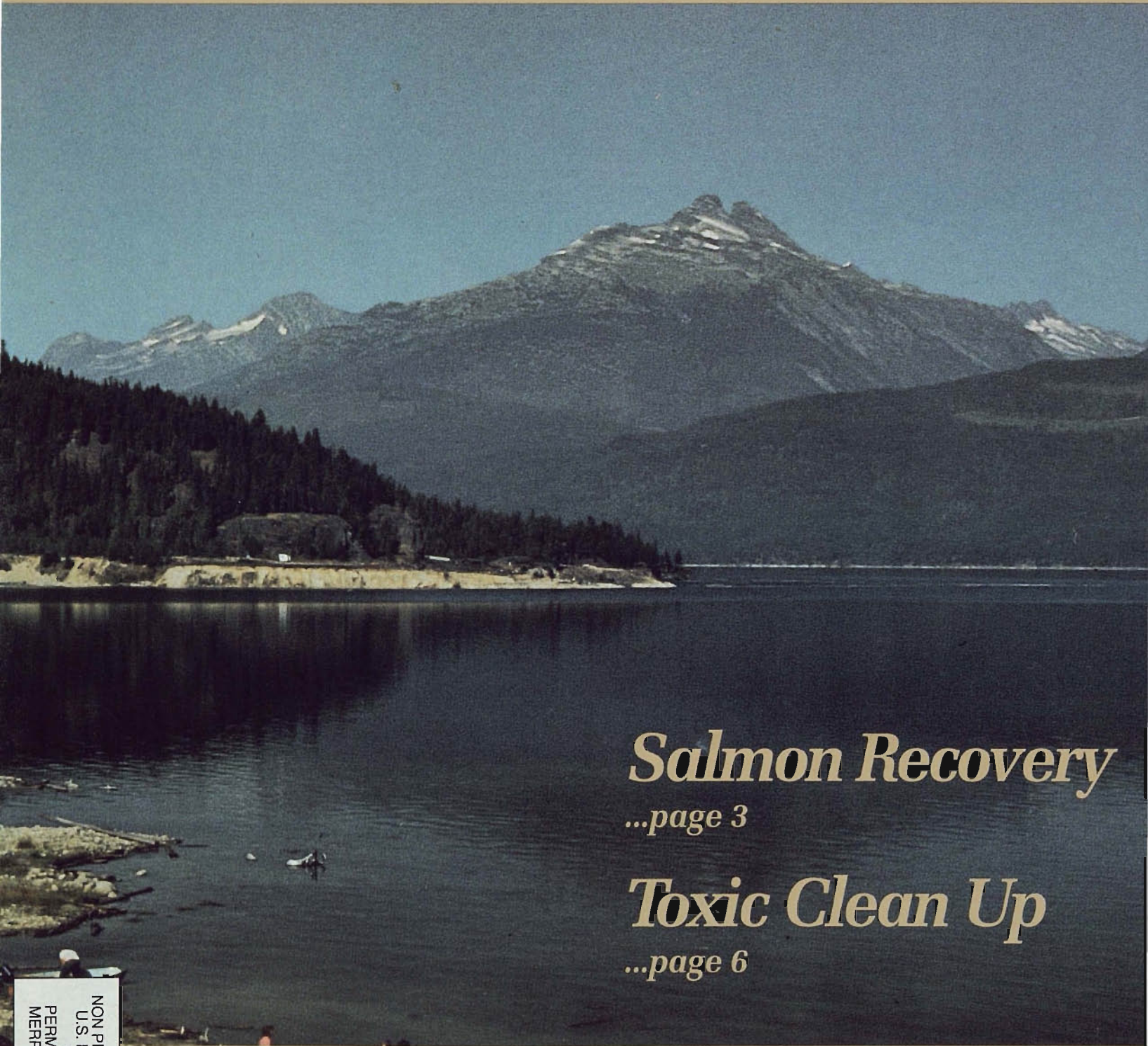

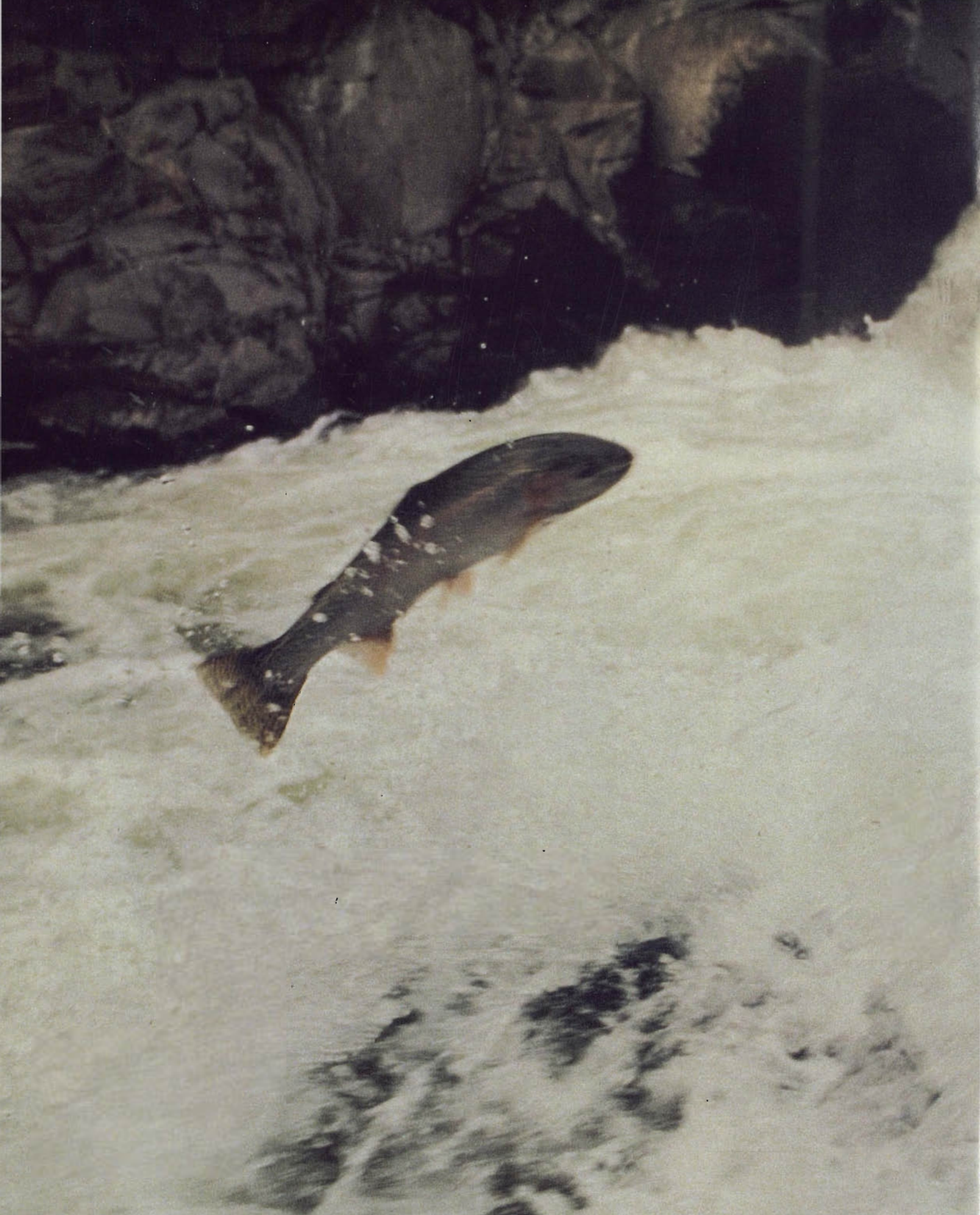

...About the authors



**Norman K. Whittlesey** is Professor of Agricultural Economics at Washington State University. Whittlesey's research and writings have focused especially on the value, management and allocation of water and related policies. In recent years he has studied the effects of

nitrogen pollution from return flows of irrigation water, benefits of pollution abatement, and impacts of irrigation development on energy use. He holds B.S. and M.S. degrees from Colorado State University and a Ph.D. from Iowa State University. In 1987 the American Agricultural Economics Association selected Whittlesey as recipient of its "Distinguished Policy Contribution" award.



**Philip Wandschneider** is Associate Professor of Agricultural Economics at Washington State University. In 1989-1990 he was a Policy Fellow at the Washington Institute of Public Policy. As a Policy Fellow he worked with the Joint Select Committee on Water Policy on

potential changes in state water law. His primary research focuses on water resource economics: water use policy, water use tradeoffs, resource valuation and project evaluation. This research is the basis for numerous papers and reports on Northwest energy and water policy, water use tradeoffs, water management institutions, water use efficiency, and economic valuation methods. He has been at Washington State University since 1979.



**William Liefert** is an economist in the Former Soviet Union Section of the Economic Research Service, USDA specializing in the macroeconomics and foreign economic relations of the former USSR. Liefert received a B.A. from the University of Wisconsin, and his M.A. and

Ph.D. in Economics from the University of Michigan. Before joining ERS, Liefert was an Assistant Professor of Economics at Kent State University. His writings focused on Soviet trade and macroeconomics have been included in the journals: *Review of Income and Wealth*, *Weltwirtschaftliches Archiv*, and *Comparative Economic Studies*.



**Nancy Chapman** has spent the past ten years linking science to policy on food and nutrition issues including nutrition labeling, food safety, advertising, and agricultural practices. She helps food processors understand what consumers want from their food supply. Nancy has

her own firm that assists food companies, biotechnology firms, trade associations and commodity groups improve their communications with consumers. She writes a regular political column that appears in the journal of two societies with a combined circulation over 25,000 in Congress, government, academia, and industry. She began her career in politics with Congressman Leon Panetta as staff to his Subcommittee on Nutrition of the House Agriculture Committee.



**Karen Klonsky** has been an Extension Economist at the University of California since 1981. She holds a Ph.D. in Agricultural economics from Michigan State University. Her research and extension activities are concentrated on farm business management. In recent years she has given special attention to the effects of toxic liabilities on agriculture and on agricultural lending. These activities led her to author several publications and conduct conference throughout California on toxic liability as it relates to agriculture.

**Kim Norris** has been a Staff Research Associate for Agricultural Economics Extension at the University of California, Davis since 1988. In 1987 she directed field research for the National Governors

Association's Rural Development Project. Prior to that, she was an assistant economist at the Federal Reserve Bank of Kansas City. Ms Norris holds an M.S. in economics from Iowa State University.

**Rebekah J. Buckles** is the president of RB & Associates Environmental Finance, an advisory firm specializing in financing a variety of environmental cleanup problems.
