# JTRF EDITORIAL POLICY

## I. EDITORIAL POLICY

Begun in 1987, the purpose of the *Journal of the Transportation Research Forum* (JTRF) is to provide a medium where research, analysis, and management techniques related to local, national, and international transportation issues may be disseminated. Directed toward private industry practitioners, industry consultants, government analysts, and academics alike, the JTRF seeks original articles, book reviews, and commentaries which are timely in scope and germane to transportation issues. Manuscripts predicated on empirical research or "years of personal experience and observation" are equally welcomed for submission to the JTRF as long as each is well documented and logical in its approach, presentation and conclusions.

Unless concisely linked to transportation issues or problems, articles proposing purely theoretical models or analyses are not appropriate to the JTRF. Similarly, sales presentations for products veiled as "research" articles are not suitable for the JTRF.

## II. PUBLICATION INFORMATION

To assure quality in the JTRF, all submitted articles are refereed in a double blind process by at least one academic and one practitioner, not including the Associate Editor(s) and Co-General Editor(s). Commentaries are reviewed by the Co-General Editor(s) along with the appropriate Associate Editor(s). Submitting authors should send *seven (7) copies* of their paper or other submission to either:

Submitting authors will be advised of receipt of their manuscripts in writing and must limit their manuscripts to a *maximum of 25 pages*, including tables figures and endnotes. To insure the integrity of the double blind review process, the author or authors (along with paper title, addresses, telephone and FAX numbers) must only be identified on a separate cover sheet and not on the paper itself. All manuscripts must be *double spaced*. References are given in the form of footnotes which are listed at the end of the paper. Figures are to be original art work, drawn in black ink on separate sheet(s) of paper, in camera-ready format. *Failure to follow these requirements will result in rejection of the manuscript*. Upon acceptance of manuscripts, book reviews or commentaries, authors will be required to submit their work on diskette, in an approved word processing format. Failure to do so will result in a typesetting charge.

Neither the co-editors, associate editors, reviewers, publisher or TRF accept responsibility for the views expressed by the authors of manuscripts, book reviews, or commentaries which are published.
