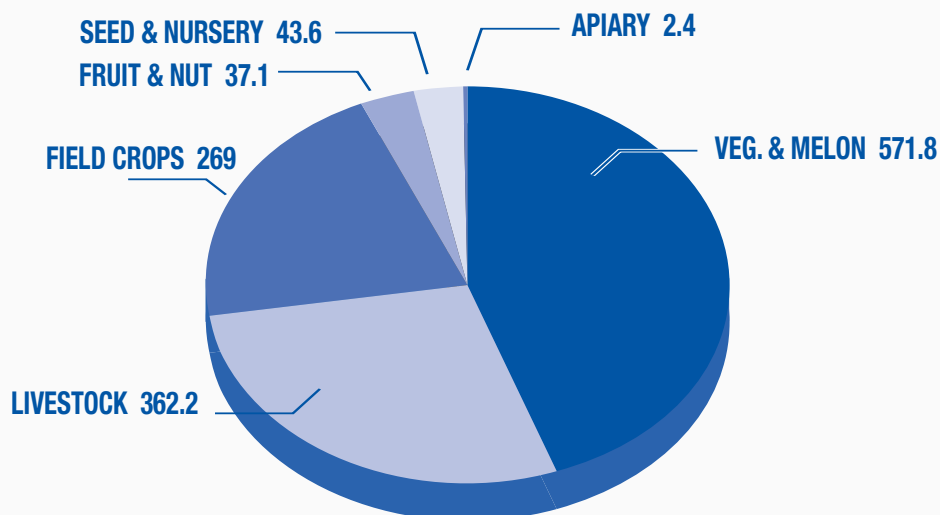

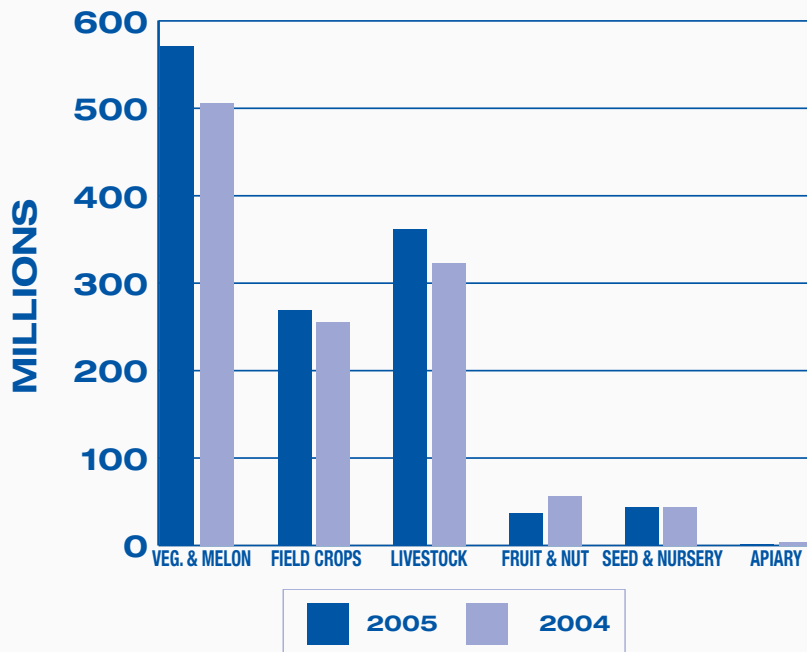

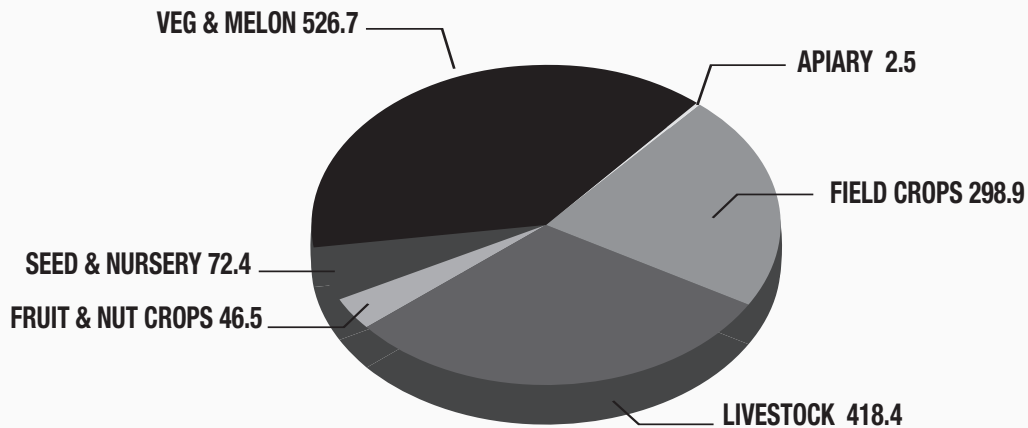

In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the 2007 Annual Agricultural Crop and Livestock Report for the centennial year for Imperial County Agriculture. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. It must be emphasized that the values presented in this report represent **Gross** receipt of producers and **do not** take into account the various costs of production, marketing or transportation. **No attempt is made to reflect net income of the producer.** Also included is a report on the activities for sustainable agriculture as specified in section 2272 of the aforementioned code.

The total gross agricultural production value in 2007 remained relatively stable at \$1,369,147,000. Livestock continues to be the dominant commodity with a minor decrease in value of (1.81%) Increases in value were realized in Field Crops 3.28%, Vegetable and Melon Crops 5.96% and Apiary Products 23.39%. Field Crop acreage decreased slightly with the increased value coming from improved prices varied in both directions. Apiary products benefited directly from increased pollination. Fruit & Nut crops (30.77%) and Seed & Nursery Crops (23.72%) recorded dramatic reductions in value. The freeze in 2007 directly impacted Fruit & Nut values by reducing acreage and yields. The Seed & Nursery Crop acreage declined.

I wish to thank the many producers, agricultural business representatives, and public agencies that have cooperated in providing the information required for the compilation of this report. I would also like to express sincere thanks to the Agricultural Department Staff, particularly project coordinator David Ritter who compiled the report.

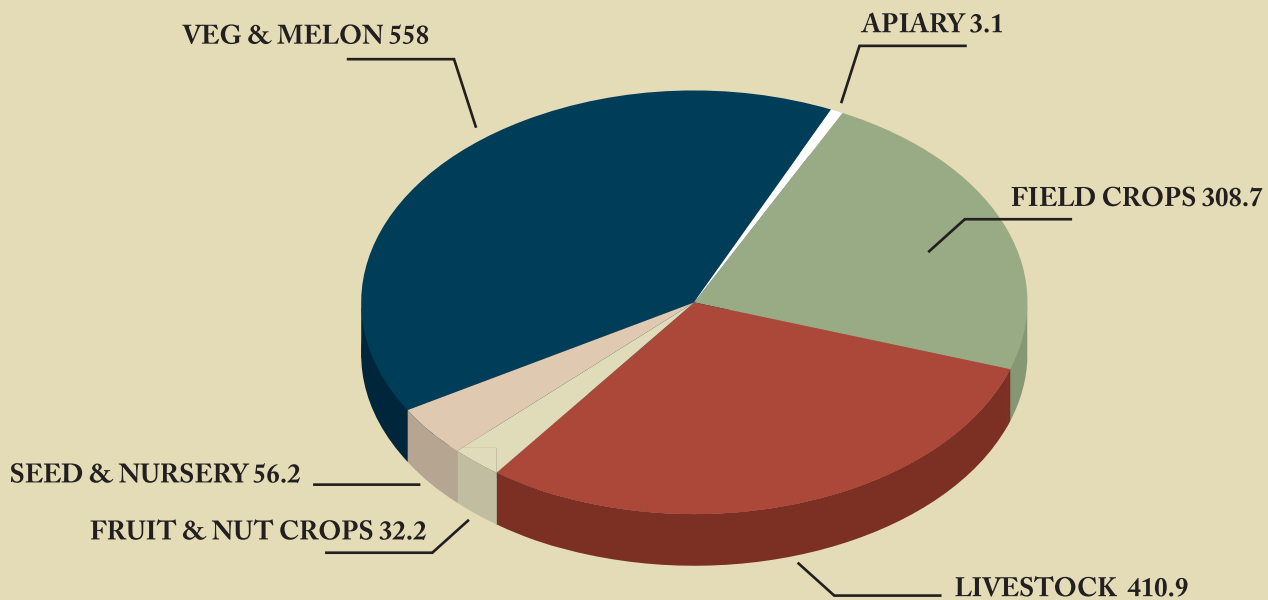

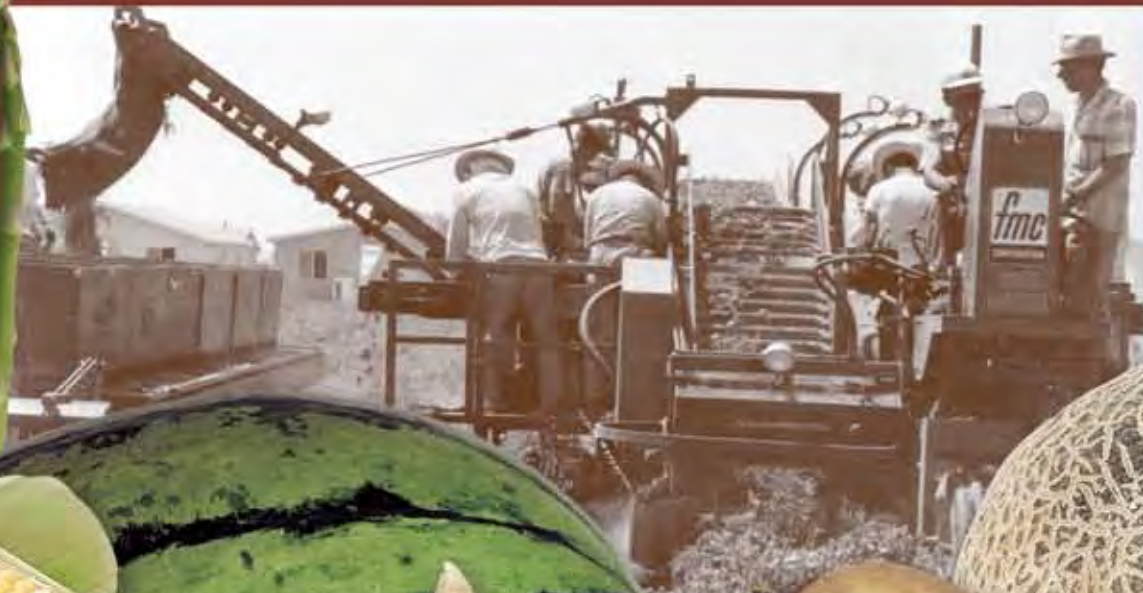

In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the 2008 Annual Agricultural Crop and Livestock Report for the centennial year for Imperial County Agriculture. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. It must be emphasized that the values presented in this report represent **Gross** receipt of producers and **do not** take into account the various costs of production, marketing or transportation. **No attempt is made to reflect net income of the producer.** Also included is a report on the activities for sustainable agriculture as specified in section 2272 of the aforementioned code.

The total gross agricultural production value in 2008 increased to \$1,684,522,000. Values in all the commodity groups either increased or remained relatively stable. Field Crops posted the largest gain at 56.31% largely as the result of a significant increase in wheat acreage and price. Wheat ranking jumped from 14th to 3rd. Seed & Nursery Crops improved by 54.42% and also benefited from increased acreage and prices. Pollination demands and improved honey prices boosted Apiary Products up by 20.17%. An overall increase in acreage, yield and price contributed to the 17.34% gain in Vegetable and Melon Crops. Fruit & Nut crops increased 16.12% due mostly to favorable prices. Livestock remained relatively stable.

I wish to thank the many producers, agricultural business representatives, and public agencies that have cooperated in providing the information required for the compilation of this report.

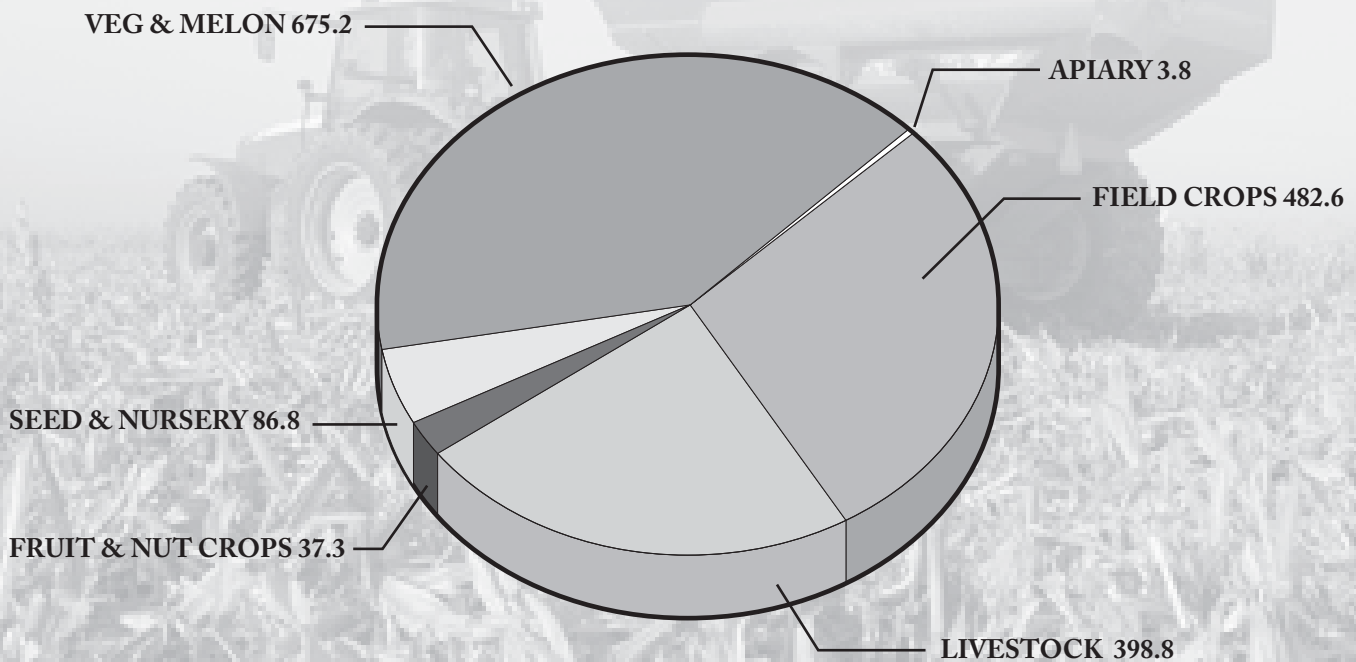

In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the 2009 Annual Agricultural Crop and Livestock Report for Imperial County Agriculture. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. It must be emphasized that the values presented in this report represent **Gross** receipt of producers and **do not** take into account the various costs of production, marketing or transportation. **No attempt is made to reflect net income of the producer.** Also included is a report on the activities for sustainable agriculture as specified in section 2272 of the aforementioned code.

The total gross agricultural production value in 2009 decreased to \$1,452,970,000 for an overall reduction of 13.75%. Several commodity groups showed decreases over last year. Reduced prices were the biggest factor contributing to the decrease. Field Crops and Seed and Nursery Crops posted losses of over 35% while Livestock decreased 13.94%. Apiary Products and Vegetable and Melon Crops remained relatively stable. Fruit & Nut Crops showed an increase of 27.91%.

For the last 25 years it has been my distinct honor to compile and present this report on behalf of the agricultural industry of Imperial County. It memorializes not only the health but also resilience of the agricultural industry and ultimately the economy of Imperial County.

I would also like to thank all of the folks who diligently, each year, provided the statistics for this report. Thanks to the folks who reviewed the drafts and validated the data which are presented here.

And finally, thanks to my staff, without their dedication this report would not be possible.

This will be the last Crop and Livestock report under my signature. To you all, thanks for allowing me the opportunity to serve as your Agricultural Commissioner and Sealer of Weights and Measures — It has been a great ride.

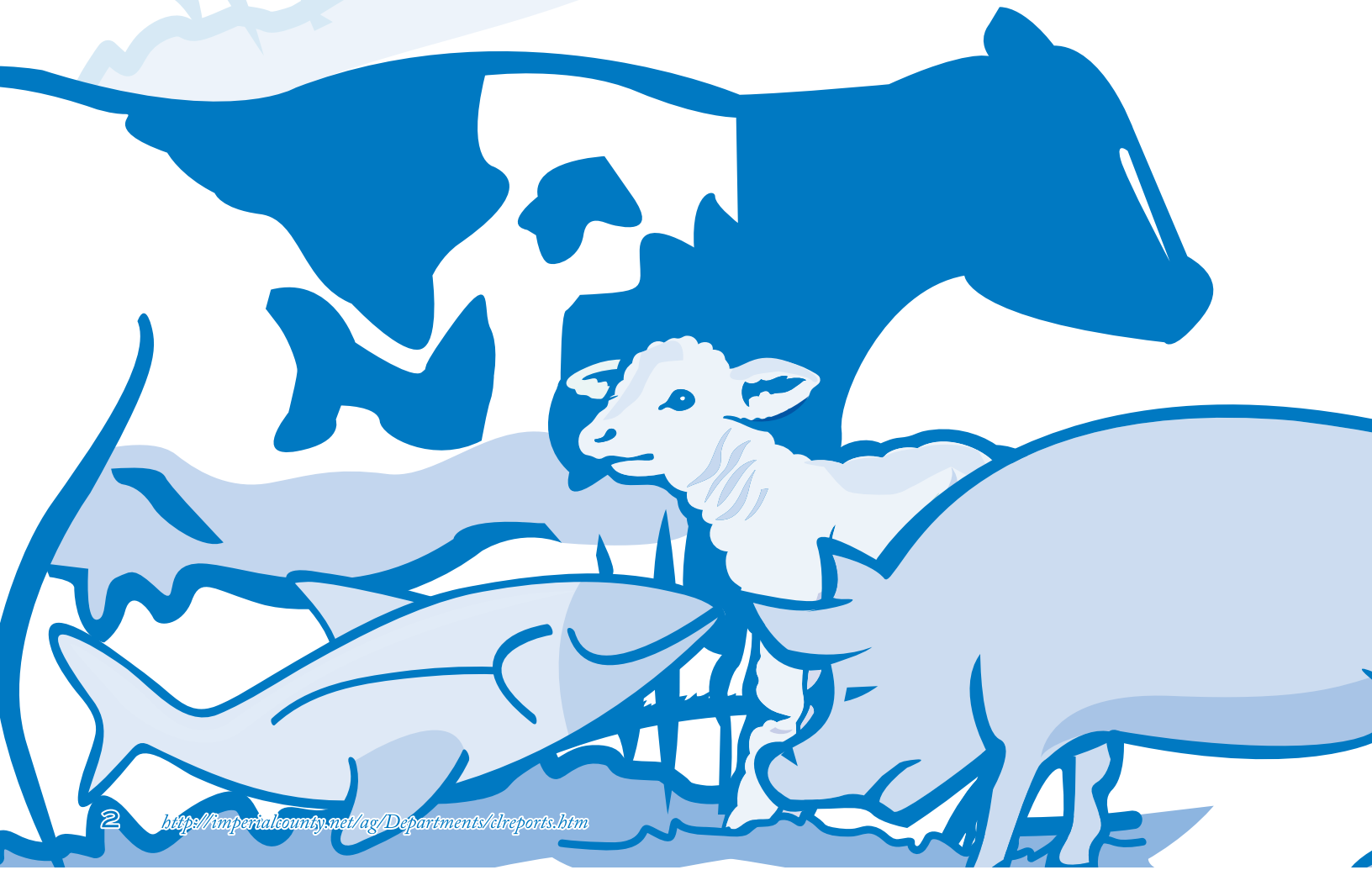
