About the authors



Daniel Halback and Carlisle Ford Runge

Carlisle Ford Runge, an Associate Professor, and Daniel Halbach, a Research Fellow at the University of Minnesota advocate three policy reforms including a national sales tax on food. Runge has a Ph. D. from the University of Wisconsin and a Masters from Oxford as a Rhodes Scholar. He worked on the House Agriculture Committee Staff in 1976-77. This coming year he will be a Fellow of the Council on Foreign Relations. In that position he will be Special Assistant to the Special Trade Representative to the GATT. Halbach, a native of Wisconsin, holds a Masters degree from the University of Wisconsin-Eau Claire and is engaged at the University of Minnesota in the North American Granary Project funded by the Northwest Area Foundation of St. Paul.



Max Lennon

Max Lennon, the President of Clemson University, focuses on forces impinging upon our societies and how land-grant universities should respond. His suggested responses have relevance not only to universities but also to industry, government agencies, and individual families as they prepare for the future. Lennon's entire professional career has been dedicated to agriculture. He has been in private industry with the Central Soya Company, served on the faculties of Texas Tech University, the University of Missouri, and Ohio State University where he was Vice President for Agricultural Administration before becoming Clemson's President in March 1986.



John Carlin

John Carlin completed his second four-year term as Governor of Kansas on January 12, 1987. Governor Carlin was Chairman of the National Governors' Association, a member of the NGA Executive Committee, a member and Chairman of the NGA Committee on Agriculture, and Chairman of the Midwestern Governor's Conference. The Governor was a dairy farmer and currently holds interest in a full-blood Simmental operation. He has taken an active role in promoting agricultural policy reform in Kansas and nationally. He shares his perspectives on farm and community conditions and what he thinks should be done to change them. He is interviewed by CHOICES' Editor Lyle Schertz.
