Thomas N. Urban is Chairman and President of Pioneer Hi-Bred International, Inc. He holds a B.A. in Political Theory and an M.B.A. from Harvard University. The major part of his professional career has been with Pioneer. He joined the company in 1960 and has served it in many locations and in many positions. Urban has also found time to be intimately involved in public affairs and was Mayor of the city of Des Moines, Iowa in the late 1960s and early 1970s.

Stanley R. Johnson is a Charles F. Curtiss Distinguished Professor of Agriculture and Director of the Center for Agricultural and Rural Development (CARD) at Iowa State University. Johnson is also Executive Director of the Food and Agricultural Policy Research Institute (FAPRI) and chair of the board of the Midwest Agribusiness Trade Research and Information Center (MATRIC). In July 1991 he was elected a foreign member (Academician) of the V. I. Lenin All-Union Academy of Agricultural Sciences, Moscow, USSR.

Alexander A. Nikonov is President of the All-Union Academy of Agricultural Sciences (VASKhNIL). Dr. Nikonov participated in the second World War as an officer in the Soviet Army and graduated from the Latvian Agricultural Academy. For many years he worked in Latvia, then for 16 years at the Institute of Agriculture of Stavropol, and since 1978 in Moscow. He is presently in charge of the Agrarian Institute which was closed in the late 1920s and only recently re-created.

Leo C. Polopolus, a Professor at the University of Florida, has studied agricultural labor issues for many years. This work has gained him wide respect. He consults widely on these matters, including with the U.S. Departments of Labor, Agriculture and Health and Human Services, as well as the Florida Citrus Commission. In addition to his research, teaching and consulting, Polopolus has contributed greatly to economic professional organizations and was President of the AAEA in 1983.

Robert D. Emerson received his Ph.D. from Purdue University in 1971. Since then he has been at the University of Florida where he is a Professor in the Food and Resource Economics Department. His research has focused on a wide range of labor issues including:

labor contracting, the H-2 Temporary Work Program, international migration, citrus harvest labor, and unemployment insurance. He is editor of the book, *Seasonal Labor Markets in the United States*, published by Iowa State University Press.

Patricia Kristjanson is an agricultural economist with Abt Associates. She specializes in agricultural policy and marketing analysis in African nations. Her academic work includes a Ph.D. in agricultural economics from the University of Wisconsin and three years of undergraduate work at the University of Manitoba in Winnipeg. Currently she is working with USAID's Africa Bureau on a comprehensive strategy for promoting agricultural marketing and agribusiness development in Sub-Saharan Africa.

Jerry Martin is Vice President and Manager, International Agricultural Group with Abt Associates, Inc. Martin directs Abt Associates' international agricultural activities. In addition, he is project director of the Agricultural Marketing Improvement Strategies Project financed by the Agency for International Development. It is focused on performance and feasible changes in marketing systems. Martin holds a Masters of Arts in Applied Anthropology from State University of New York at Binghamton.

Stan Daberkow is a Section Leader of the Inputs Supply and Demand Section at the Economic Research Service. His work at ERS focuses on the production, consumption, prices and trade of manufactured agricultural inputs. Daberkow was a Congressional Legislative Fellow during the debate on the 1990 Farm Bill when the Circle of Poison legislation was originally introduced. He received graduate degrees in agricultural economics from Iowa State University and the University of California at Davis.

E. Douglas Beach is an Agricultural Economist in the Resources and Technology Division at the Economic Research Service. Beach received a M.Sc. in Agricultural Economics at the Ohio State University in 1985 and received his Ph.D. in Economics at North Carolina State University in 1990. Beach's research interests include agricultural production and natural resource economics. He is currently examining the relationship between pesticide use at the farm level and food safety.
