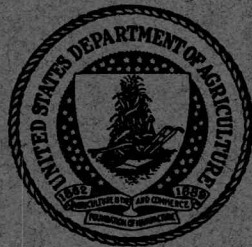

JAMES A BAYTON as a social science analyst has been connected with the Department's consumer preference surveys from their beginning and he is associate professor of psychology at Howard University.

D. B. IBACH conducts studies in farm management and costs that include farm-capital investment problems and input-output relationships. Earlier, with the Extension Service, he helped to initiate the individual farming work which later developed into the Balanced Farming Program in Missouri. He has served also with FSA and SCS.

WAYNE D. RASMUSSEN was responsible for planning the War Records Monograph series. He has been on the staff of the history section for 10 years, except for a period of service in the Army, and is the author of bulletins and articles on agricultural history.
