WHAT IS CWAE?

The Committee of Women Agricultural Economists has been a standing committee of the American Agricultural Economics Association since 1982. The purpose of this committee is to enhance communication among women in the profession; to establish a supportive network for professional growth. Further, it intends to formalize and heighten the status of women in the profession, to facilitate job information and placement, and to encourage and facilitate participation in AAEA activities.

This committee has published a roster of women agricultural economists which is regularly updated and expanded. We publish a newsletter four times a year, and we submit proposals for sessions at the AAEA meetings. We have had a symposium or an invited paper session accepted every year since 1981. We also hold a business meeting, a reception, and a luncheon at the summer AAEA meetings and an open reception at the winter meetings with the AEA.

Our funding has come from the Agricultural Development Council and the Farm Foundation. The AAEA board has recently voted to fund our newsletter costs.

We have a set of working rules which say any agricultural economist may participate in the activities of this committee. The steering committee consists of six persons elected on a rotating basis by the members plus a representative from the AAEA board, the newsletter editor, and the finance subcommittee chair. As a committee of AAEA, the president officially appoints the steering committee that the members elect. There are eleven subcommittees whose members are appointed by the steering committee chair each year.

FROM THE CWAE CHAIR

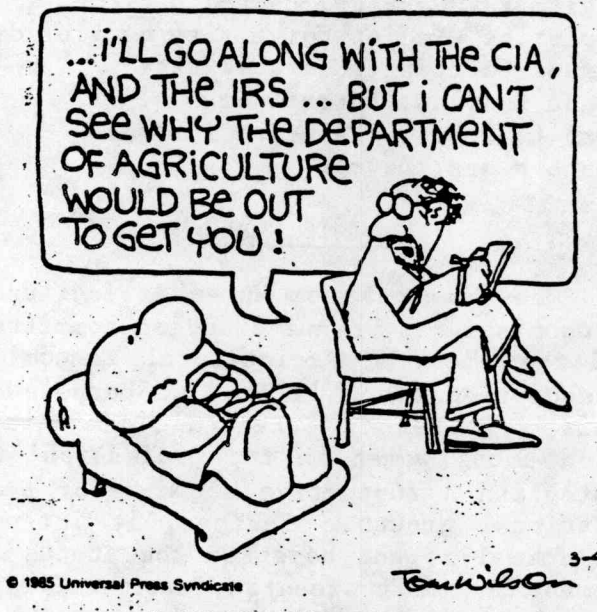

EXCERPTS FROM THE 1984 ANNUAL REPORT
OF THE COMMITTEE ON THE STATUS OF WOMEN
IN THE ECONOMICS PROFESSION

In 1983-84, the group of economics departments that grant most of the Ph.D's (the so-called Chair's Group) reported that 16 percent of their doctorates went to women. While this is an advance from the levels of the 1970's, it is below the proportion of women among newly trained lawyers (32 percent in 1980-81), physicians (25 percent), and chemical engineers (19 percent).

Promotions for women within departments are less frequent than for men, given their representation in junior

faculty positions. In 1983-84, the situation with respect to the senior ranked positions is shown in Table 1.

What is perhaps just as damaging is the fact that the ability of women to move from one school to a senior position in another school appears to be virtually nil. Of the 34 economists hired for senior positions by the departments of the Chair's Group, only 1 was a woman. In all departments throughout the country, only 2 women made such a move.

WOMAN ECONOMIST OF THE YEAR

Barbara R. Bergmann, professor of economics at the University of Maryland, has been chosen Washington Woman Economist of the Year.

The award was presented by the Washington Women Economists, a professional association founded in 1979 to promote the status of women economists.

Bergmann has served as a consultant to the President's Council of Economic

Advisors, the Rand Corp., the Ford Foundation, and the German Marshall Fund. She has published more than 40 articles and testified before numerous congressional committees.

Bergmann is chairman of the Committee on the Status of Women in the Economics Profession, which is a subcommittee of the American Economics Association.

FEMALE FARMERS

Although the number of U.S. farms is decreasing the number of female farmers is rising. In 1978, about 128,000 (or 5.2 percent) of all U.S. farmers were women. By 1982, females represented 5.4 percent of all U.S. farmers and there were 9,000 more farms run by women. Female farmers tend to run smaller farms and earn less than their male counterparts. On the average, they are also older than male farmers. Both men and women most often operate livestock or cash grain farms. Women not engaged in livestock or cash grain farming most often run tobacco, other field crop, fruit and nut, or animal specialty farms (mostly horse breeding).

DESCRIPTION OF PROPOSED AAEA MAGAZINE

CHOICES, focusing on food, farm, and resource issues will be published six times a year beginning August 1985, conditional on available financing.

A primary aim of the magazine is to reach people who are not agricultural economists. Thus, the target audience includes (1) implementers of policy such as state and county ASCS officials, (2) those affected by policies such as farm producers and people in companies marketing inputs to producers, (3) people who work closely with those affected by policies such as rural lawyers and bankers, and (4) other groups who are involved in the agricultural sector such as agronomists and university deans.

Publication of the first issue on August 1 is also contingent on availability of good articles and material. The goal is to obtain at least four articles per issue, of four to five pages each. Longer manuscripts would either be condensed or divided and printed in successive issues. Schertz says that he is relatively optimistic on this matter at this time. But more articles are needed. All topics that have a policy orientation are appropriate for the magazine. Examples of possible topics include: The Economics of Farm Debt Relief; New Dairy Legislation; Who Receives Food Stamps?; Who Benefits From Market News?; The Connection Between Federal Deficits; Value of the U.S. Dollar and U.S. Farm Exports; and The Effects of Commodity Programs on Soil and Water Conservation. RESEARCH JOB OPPORTUNITIES
IN THE FARM CREDIT SYSTEM

The Farm Credit System is a nationwide cooperative extending credit to farmers and farm cooperatives through Production Credit Associations, Federal Land Bank Associations, and the Bank for Cooperatives. Many of the twelve Farm Credit districts have a research department located at the main banks. Farmbank Services in Denver provides research services to all districts. FCA in Washington, DC has an economic analysis division. The type of work varies greatly from economic and policy analysis to association specific risk assessment. A masters degree and an ag background are usually required for research positions. Opportunities also exist in credit, reviews, accounting, and MIS. Interested applicants should contact either the personnel department or the department in which they are interested. For jobs in research, the latter is more apt to yield results, since a promising applicant will be kept in mind when a position becomes available.
