





#### Abstract

This bulletin complements the *Processed Food Trade Concordance* (1995), Agricultural Handbook No. 707, which summarizes the procedures used to convert Bureau of the Census trade data to U.S. processed food industry data. Together, both bulletins provide the procedure used to compile processed food and beverage trade data for the period covering 1990 through 1994. Processed food trade trends are also discussed for the period covering 1990-94. The database was produced from Bureau of the Census CD-ROM data.

#### Summary

This bulletin complements the *Processed Food Trade Concordance* (1995), Agricultural Handbook No. 707, which summarizes the procedures used to convert appropriate Bureau of the Census trade data to U.S. processed food industry data. Together, both bulletins provide the procedure used to compile processed food and beverage trade data for the period covering 1990 through 1994. Information is also presented for processed food imports and exports by Standard Industrial Classification Industries for the period covering 1990 through 1994.

Processed food trade trends are also presented in the last portion of this bulletin. In brief, processed food exports increased over \$7 billion from 1990 through 1994--reaching slightly less than \$26 billion in 1994. Imports increased slightly over \$3 billion during the same period, rising from \$20.1 billion in 1990 to \$23.3 billion in 1994. Processed food trade reached a surplus in 1991 of \$156 million and rose to a 1994 high of \$2.6 billion. The data are derived from CD-ROM data produced by the Bureau of the Census.

#### Introduction

This bulletin complements the *Processed Food Trade Concordance* (1995), Agricultural Handbook Number 707, which summarizes the procedures used to convert appropriate Bureau of the Census trade data to U.S. processed food industry data. Together, both bulletins provide the procedure used to compile processed food and beverage trade data for the period covering 1990 through 1994. Jointly, both products comprise a self-contained reference for use in statistical and analytical work where imports and exports of individual products and industry must be jointly evaluated.

Prior to publication of these two bulletins, researchers in the Economic Research Service were applying a processed food trade concordance procedure to earlier Bureau of the Census data. However, the results of the translations were fragmented and not summarized in a consistent series. Moreover, the Harmonized Coding System (see later sections for a description of this system) was formally adopted by the United States in 1989. Calendar year 1990 was the first full year of comparable data. CD-ROM data from the Bureau of the Census have been used to construct the industry level information discussed in this bulletin. To the author's knowledge, no product is available that specifically summarizes processed food trade, especially as a consistent series as presented in this bulletin.

This bulletin and the information contained within should prove valuable to policymakers, researchers, and trade interests who follow trade policy and issues. The data mentioned in this publication are available on the Internet at HTTP://WWW.ECON.AG.GOV or in electronic form as ERS data product, stock no. 95011. The data provide industry- and country-level detail for 1990-94.

The data discussed in this document were compiled from U.S. Exports History: Historical Summary 1990-1994 and U.S. Imports History: Historical Summary 1990-1994, U.S. Department of Commerce, Bureau of the Census, in a CD-ROM format. The CD-ROMs do not contain revisions or adjustments made to the data after the CD-ROM release. Future publications of the Economic Research Service will use updated data that reflect revisions and adjustments.

#### **Processed Food Trade Trends**

The United States is among the world leaders in both exports and imports of processed foods and beverages. These products account for over 50 percent of U.S. agricultural and food exports, surpassing bulk commodity exports in the early 1990's. Changes in income levels, changes in demographics, and westernization of diets in importing countries are largely responsible for this growth.

U.S. processed food firms buy and sell in a multi-billion-dollar world market. In 1994, U.S. processed food industries exported \$25.8 billion worth of processed foods coupled with \$23.3 billion of imported processed foods (fig. 1). Processed food exports increased over \$7 billion during the period covering 1990 through 1994. Imports increased slightly more than \$3 billion over the same period. These trade movements led to a continuing trade surplus of \$156 million in 1991, rising to \$2.6 billion in 1994.

The United States exported \$111 billion of processed food during 1990-94 to 227 countries including 15 nations of the former Soviet Union. Five countries accounted for nearly 60 percent of exports for the 5-year period. Japan was the leading destination for U.S. processed food exports with a 5-year total of nearly \$29.6 billion (fig. 2). Canada and Mexico followed with nearly \$17 billion and slightly over \$9 billion, respectively, for the 5-year period. South Korea and the Netherlands followed with \$6 billion and \$4 billion.

Five countries accounted for nearly 40 percent of U.S. imports of processed foods. Canada was, by far, the major source for U.S. imports of processed food, with nearly \$20 billion over the 1990-94 period (fig. 3). Rounding out the top 5 were Thailand with \$6.5 billion; Mexico, \$5.5 billion; Australia, \$5.3 billion; and France, \$5 billion.

The soybean oil milling industry generated more than an \$8 billion total trade surplus over the 5-year period covering 1990-94 (fig. 4). The meatpacking industry was second with nearly \$8 billion, and the wet com milling industry was third with over \$5 billion. Poultry processing and rice milling produced surpluses of more than \$5 billion and \$3 billion, respectively.

#### **Industry and Product Classification Systems**

The Standard Industrial Classification (SIC) system is a Federal classification system that is used to assign economic establishments to industry groups based on principal economic activity. The SIC system underlies all establishment-based Federal economic statistics that are classified by economic industry. The system was developed by a technical committee under the authority of the Office of Management and Budget. The SIC system was designed to facilitate the collection, tabulation, presentation, and analysis of data on economic establishments and to promote uniformity and comparability in its presentation.

The SIC system classifies establishments or plants that produce similar products, use similar processes, or provide similar services. Establishments or plants that fit into these guidelines are assigned the same two-digit code number. Establishments that process food and related products constitute SIC 20 under this system. Particular kinds of food processors are differentiated by additional code numbers. For example, processors of meat and related products constitute SIC 201. Within three-digit groups, plants of specialized producers are further differentiated by the addition of an additional digit. The four-digit SIC code is the system's lowest level of disaggregation, and the collection of establishments or plants under a particular four-digit SIC code is called an industry. The 49 four-digit SIC industries discussed in this bulletin are presented in table 1. The 1987 Standard Industrial Classification Manual contains details of the SIC system for all U.S. industries.

The Harmonized System (HS) is a classification system for all internationally traded goods. This system was designed to replace individual nations' systems with commonly accepted nomenclature and descriptions of traded goods. The United States adopted the Harmonized System in 1989. The Harmonized Tariff Schedule of the United States (HTS) is the legal text that sets forth product descriptions and code numbers, rules of interpretation, article provisions, and other matters pertaining to participation of the United States in the Harmonized System convention. These provisions are applied to merchandise classification for rate duty and statistical purposes.

The HS assigns products unique 10-digit code numbers based on form and processing methods. For example, fresh, chilled, or frozen whole turkeys are designated by one code number but fresh, chilled, or frozen cuts of turkey by another, since their forms differ. The first six digits of each HS product code are the same for all countries. The remaining digits differentiate domestic standards.

#### **Data Translation Procedure**

The processed food trade concordance outlined in the separate bulletin provides a procedure for joining the two systems. Each of over 2,000 processed food products classified according to the international harmonized convention is paired with a corresponding domestic industry among the 49 SIC industries designated under SIC 20. The pairing criterion is conformity of the Harmonized System's description to establishment activity and product line of the SIC system. For example, fresh or chilled veal carcasses have been assigned to Meat Packing (SIC 2011), the industry in which establishments slaughter and process cattle, hogs, sheep, lambs, and calves.

Harmonized codes are revised twice each year. The data mentioned in this bulletin are based on a concordance that differs slightly from those used for previous data translations. Tables 2 and 3 present changes made in the concordance procedure since publication of Agricultural Handbook No. 707. For more information on specific harmonized codes and descriptions see *Processed Food Trade Concordance* (1995).

#### Table 1--SIC industry descriptions

#### 2011 - Meat Packing

Establishments primarily engaged in the slaughtering, for their own account or on contract basis for the trade, of cattle, hogs, sheep, lambs, and calves for meat to be sold or to be used on the same premises in canning, cooking, curing, and freezing, and in making sausage, lard, and other products.

#### 2013 - Sausage and Other Prepared Meat Products

Establishments primarily engaged in manufacturing sausages, cured meats, smoked meats, canned meats, frozen meats, and other prepared meats and meat specialities, from purchased carcasses and other materials.

#### 2015 - Poultry Slaughtering and Processing

Establishments primarily engaged in slaughtering, dressing, packing, freezing, and canning poultry, rabbits, and other small game, or in manufacturing products from such meats, for their own account or on a contract basis for the trade.

#### 2021 - Creamery Butter

Establishments primarily engaged in manufacturing creamery butter.

#### 2022 - Natural, Processed, and Imitation Cheese

Establishments primarily engaged in manufacturing natural cheese (except cottage cheese), processed cheese, cheese foods, cheese spreads, and cheese analogs (imitations and substitutes).

#### 2023 - Dry, Condensed, and Evaporated Dairy Products

Establishments primarily engaged in manufacturing dry, condensed, and evaporated dairy products.

#### 2024 - Ice Cream and Frozen Desserts

Establishments primarily engaged in manufacturing ice cream and other frozen desserts.

#### 2026 - Fluid Milk

Establishments primarily engaged in processing (that is, pasteurizing, homogenizing, vitaminizing, bottling) fluid milk and cream and related products, including cottage cheese, yogurt (except frozen), and other fermented milk.

#### 2032 - Canned Specialties

Establishments primarily engaged in canning specialty products, such as baby foods, nationality specialty foods, and soups, except seafood.

#### 2033 - Canned Fruits, Vegetables, Preserves, Jams, and Jellies

Establishments primarily engaged in canning fruits, vegetables, and fruit and vegetable juices; and in manufacturing catsup and similar tomato sauces or natural and imitation preserves, jams, and jellies.

#### 2034 - Dried and Dehydrated Fruits, Vegetables, and Soup Mixes

Establishments primarily engaged in sun drying and artificially dehydrating fruits and vegetables or ingredients manufacturing packaged soup mixes from dehydrated ingredients.

#### 2035 - Pickled Fruits and Vegetables, Vegetable Sauces and Seasonings, and Salad Dressing

Establishments primarily engaged in pickling and brining fruits and vegetables and in manufacturing salad dressings, vegetable relishes, sauces, and seasonings.

#### 2037 - Frozen Fruits, Fruit Juices, and Vegetables

Establishments primarily engaged in freezing fruits, fruit juices, and vegetables.

#### 2038 - Frozen Specialties, Not Elsewhere Classified

Establishments primarily engaged in manufacturing frozen food specialties not elsewhere classified, such as frozen dinners and frozen pizza.

#### 2041 - Flour and Other Grain Mill Products

Establishments primarily engaged in milling flour and meal from grain, except rice.

#### 2043 - Cereal Breakfast Foods

Establishments primarily engaged in manufacturing cereal breakfast foods and related preparations, except breakfast bars.

#### 2044 - Rice Milling

Establishments primarily engaged in cleaning and polishing rice and in manufacturing rice flour or meal.

#### 2045 - Prepared Flour Mixes and Doughs

Establishments primarily engaged in preparing flour mixes or doughs from purchased flour.

#### 2046 - Wet Corn Milling

Establishments primarily engaged in milling corn or sorghum grain (milo) by the wet process and producing starch, syrup, oil, sugar, and byproducts, such as gluten feed and meal.

#### 2047 - Dog and Cat Food

Establishments primarily engaged in manufacturing dog and cat food from cereal, meat, and other ingredients.

#### 2048 - Prepared Feeds and Feed Ingredients for Animals and Fowls, Except Dogs and Cats

Establishments primarily engaged in manufacturing prepared feeds and feed ingredients and adjuncts for animals and fowls, except dogs and cats.

#### 2051 - Bread and Other Bakery Products, Except Cookies and Crackers

Establishments primarily engaged in manufacturing fresh or frozen bread and bread-type rolls and fresh cakes, pies, pastries and other similar "perishable" bakery products.

#### 2052 - Cookies and Crackers

Establishments primarily engaged in manufacturing fresh cookies, crackers, pretzels, and similar "dry" bakery products.

#### 2053 - Frozen Bakery Products, Except Bread

Establishments primarily engaged in manufacturing frozen bakery products, except bread and bread-type rolls.

#### 2062 - Cane Sugar Refining

Establishments primarily engaged in refining purchased raw cane sugar and sugar syrup.

#### 2063 - Beet Sugar

Establishments primarily engaged in manufacturing sugar from sugar beets.

#### 2054 - Candy and Other Confectionery Products

Establishments primarily engaged in manufacturing candy, including chocolate candy, other confections, and related products.

#### 2066 - Chocolate and Cocoa Products

Establishments primarily engaged in shelling, roasting, and grinding cacao beans for the purpose of making chocolate liquor, from which cocoa powder and cocoa butter are derived, and in the further manufacture of solid chocolate bars, chocolate coatings, and other chocolate and cocoa products.

#### 2067 - Chewing Gum

Establishments primarily engaged in manufacturing chewing gum or chewing gum base.

#### --Continued

#### 2068 - Salted and Roasted Nuts and Seeds

Establishments primarily engaged in manufacturing salted, roasted, dried, cooked, or canned nuts or in processing grains or seeds in a similar manner for snack purposes.

#### 2074 - Cottonseed Oil Mills

Establishments primarily engaged in manufacturing cottonseed oil, cake, meal, and linters, or in processing purchased cottonseed oil into other than edible cooking oils.

#### 2075 - Soybean Oil Mills

Establishments primarily engaged in manufacturing soybean oil, cake, and meal, and soybean protein isolates and concentrates, or in processing purchased soybean oil into other than edible cooking oils.

#### 2076 - Vegetable Oil Mills, Except Corn, Cottonseed, and Soybean

Establishments primarily engaged in manufacturing vegetable oils, cake and meal, except corn, cottonseed, and soybean, or in processing similar purchased oils into other than edible cooking oils.

#### 2077 - Animal and Merine Fats and Oils

Establishments primarily engaged in manufacturing animal oils, including fish oil and other marine animal oils, and fish and animal meal; and those rendering inedible stearin, grease, and tallow from animal fat, bones, and meat scraps.

#### 2079 - Shortening, Table Oils, Margarine, and Other Edible Fats and Oils, Not Elsewhere Classified

Establishments primarily engaged in manufacturing shortening, table oils, margarine, and other edible fats and oils, not elsewhere classified.

#### 2082 - Malt Beverages

Establishments primarily engaged in manufacturing malt beverages.

#### 2083 - Malt

Establishments primarily engaged in manufacturing malt or malt byproducts from barley or other grains.

#### 2084 - Wines, Brandy, and Brandy Spirits

Establishments primarily engaged in manufacturing wines, brandy, and brandy spirits.

#### 2085 - Distilled and Blended Liquors

Establishments primarily engaged in manufacturing alcoholic liquors by distillation, and in manufacturing cordials and alcoholic cocktails by blending processes or by mixing liquors and other ingredients.

#### 2086 - Bottled and Canned Soft Drinks and Carbonated Waters

Establishments primarily engaged in manufacturing soft drinks and carbonated waters.

#### 2087 - Flavoring Extracts and Flavoring Syrups, Not Elsewhere Classified

Establishments primarily engaged in manufacturing flavoring extracts, syrups, powders, and related products, not elsewhere classified, for soda fountain use or for the manufacture of soft drinks, and colors for bakers' and confectioners' use.

#### 2091 - Canned and Cured Fish and Seafoods

Establishments primarily engaged in cooking and canning fish, shrimp, oysters, clams, crabs, and other seafoods, including soups; and those engaged in smoking, salting, drying, or otherwise curing fish and other seafoods for the trade.

#### 2092 - Prepared Fresh or Frozen Fish and Seafoods

Establishments primarily engaged in preparing fresh and raw or cooked frozen fish and other seafoods and seafood preparations, such as soups, stews, chowders, fishcakes, crabcakes, and shrimpcakes.

#### 2095 - Roasted Coffee

Establishments primarily engaged in roasting coffee, and in manufacturing coffee concentrates and extracts in powdered, liquid, or frozen form, including freeze-dried.

#### 2096 - Potato Chips, Corn Chips, and Similar Snacks

Establishments primarily engaged in manufacturing potato chips, corn chips, and similar snacks.

#### 2097 - Manufactured Ice

Establishments primarily engaged in manufacturing ice for sale.

#### 2098 - Macaroni, Spaghetti, Vermicelli, and Noodles

Establishments primarily engaged in manufacturing dry macaroni, spaghetti, vermicelli, and noodles.

#### 2099 - Food Preparations, Not Elsewhere Classified

Establishments primarily engaged in manufacturing prepared foods and miscellaneous food specialties, not elsewhere classified, such as baking powder, yeast, and other leavening compounds; peanut butter; packaged tea, including instant; ground spices; and vinegar and cider.






