## Address By President, Africa Farm Management Association

Distinguished Guests, Ladies and Gentlemen,

It is with utmost pleasure that I present this address on the occasion of the opening ceremony of the 8<sup>th</sup> Africa Farm Management Association's Congress here in Nairobi, the green city in the sun and home to local and international businesses and organizations. The African Farm Management Association (AFMA) was formed in November 1992 in Harare, Zimbabwe as a non-political, non-sectarian voluntary organization. AFMA was established to further the knowledge and practice of farm business management on the African continent. It is in furtherance of this that congresses are held on rotational basis all over the countries in the continent on topical issues. In this vein, permit me to highlight the discussions at the last two AFMA congresses.

The 6<sup>th</sup> AFMA congress with the theme: *'Realities of Improving Farm Management and Commercialising the Subsistence Sector in African Agriculture'*, was held in Maputo, Mozambique in 2002. The major issues discussed included: alternative farming systems, theories and approaches to commercialising small scale farmers, agricultural commercialisation for food security improvement, impact of forest management regimes on agricultural productivity and shareholders' incomes, constraints to the commercialisation process of semi-subsistence agriculture, how the business or entrepreneurial spirit can be developed, government agricultural policy and its impact on commercialisation and finally, using the concept of comparative advantage in targeting agricultural production for local and global markets.

The 7<sup>th</sup> congress with the theme: *'Agri-business in the African Century'* was held in Abuja, Nigeria in 2004. It featured two lead papers titled; *'Food Security and Livelihood Improvement in Africa through Agri-business Development'* and *'Effective Economic Farm Management Guidelines'*. Forty-six papers were presented under six sub-themes namely: Institutions and Agricultural Organisations; Basic Skills Development; Appropriate Technologies; Financing Agri-business; Food Processing and Agri-industry and finally, Food Security and Livelihood Improvement.

Deliberations at the last two congresses were incisive and rewarding and I am very positive that the 8<sup>th</sup> congress here in Nairobi in the next four days with the theme: *'Repositioning African Agriculture through Productivity, Market Access, Policy Dialogue and Adapting to Climate Change'*,
