Message From The Chair

Last year (1987-88) proved to be another productive one for the Committee on the Opportunities and Status of Blacks in Agricultural Economics. The Committee published its first Newsletter in the Summer of 1987, two other newsletters followed in the Spring and Summer of 1988. The Committee continued to work on a number of projects, sponsored invited paper sessions, organized symposia, and receptions at the AAEA meetings. On behalf of members of the Committee, I wish to extend appreciation to Joyce Allen for the outstanding leadership provided on these and other activities as Committee Chair. Recognition is also extended to former chairpersons (Richard Robbins, Sidney Evans, and Ralph Christy) for the valuable leadership provided from the committee's inception. Special Thanks to those individuals who rotate off of the Committee this year: Joyce Allen, Tesfa Ghebremedhin and Vin Samuel. The Committee welcomes Eugene Jones, Hezekiah Jones, and Patricia McLean-Meynsse. Your comments, suggestions and new ideas are welcomed.

The 1988-89 year is shaping up to be both exciting and challenging. A number of projects which have been in the planning stages for several months are scheduled for completion in 1989. Attention will also focus on plans for the Committee beyond the 1988-89 period.

For several months the Committee has been in the process of planning a project aimed at commemorating the Centennial of the 1890 Land-Grant Institutions. Significant progress has been made. Much work remains. Three major activities associated with the Committee project are: (1) Pre-Conference Program to be held during the 1989 AAEA meetings (Louisiana State University, Baton Rouge, Louisiana, July 30, 1989), (2) development and dissemination of a brochure on Contemporary Black Agricultural Economists, and (3) exhibits on the 1890 Land-Grant Institutions to be displayed at the 1989 AAEA meetings. This is a significant Committee effort and will require some attention to details in order to be successful. Leadership on this Committee project is as follows:

The Newsletter has served as an important vehicle for disseminating information on Committee activities, notable activities of Black Agricultural Economists, professional meetings and employment opportunities.

Ralph D. Christy and Doris Newton will continue to serve as Co-Editors of the Newsletter. Your comments, suggestions, or information that you wish to submit are welcomed.

The Directory of Black Agricultural Economists has enjoyed wide circulation and use for communication purposes. The Committee is in the process of updating the directory and anticipates distribution in November. The revised directory will include the names, addresses, educational background, place of employment and other information on each of the more than 130 Agricultural Economists. Donald McDowell will provide the leadership on this project. If you have names that you wish to have included in the Directory, please forward them to Donald.

The Committee is in the process of fine tuning a proposal which will be submitted to the Editor of the "Review of Black Political Economy". The anticipated result of this project is a special issue of the "Review" with articles written by agricultural economists focusing on topics which have appeal to both rural and urban audiences. Leadership on this Committee project will be provided by Donald McDowell, Joyce Allen, Patricia McLean-Meynsse, and Alton Thompson.

The Committee will continue its efforts to encourage Black Agricultural Economists involvement in all activities of both the American Association of Agricultural Economics and the Southern Association of Agricultural Scientists. Pre-meeting Conferences, Organized Symposia Sessions, Invited Paper Sessions, AAEA Committees, SAAS Committees, and other professional meetings provide excellent opportunities for our involvement. Leadership on this project will be provided by Ivery Clifton, Bernard Ervin, Eugene Jones, and Tesfa Ghebremedhin.

The Committee has established an excellent record of accomplishments during its relatively short existence. Results of a survey conducted by Vin Samuel indicate your desire to have the Committee address a number of issues which I believe to be important. To respond to your requests, a long range planning committee is being appointed to draft a set of long range plans which are compatible with the Committee's original mission. Your input will be especially needed in this process. Leadership on this project will be provided by Carlton Davis, Joyce Allen, Richard Douglas, Ralph Christy, and Lionel Williamson.

The Committee will continue to meet twice a year - during the annual meetings of the SAEA and the AAEA. CLIFTON R. WHARTON, JR., NAMED AAEA FELLOW

NEW YORK, NY -- Clifton R. Wharton, Jr., Chairman and Chief Executive Officer of Teachers Insurance and Annuity Association - College Equities Fund, is one of four distinguished economists elected a Fellow of the American Agricultural Economics Association, the most prestigious award in the Agricultural Economics profession. Dr. Wharton's election was announced last Summer by AAEA President David Padberg at the AAEA's annual awards dinner in Knoxville, Tennessee.

The AAEA is the national professional association of agricultural economists whose members range from Kenneth Galbraith of Harvard University to Theodore Schultz, the Nobel Laureate at the University of Chicago, who was Dr. Wharton's major professor while he was earning his doctorate. Dr. Wharton is the first Black to be elected a Fellow by the AAEA.

In its tribute to Dr. Wharton, the AAEA stated that:

"During his executive years, Dr. Wharton has remained active and widely recognized as a world leader in economic development. He has been appointed to several Presidential commissions and task forces. History will record his unique role in serving as the Chairman of the Presidentially appointed Board for International Food and Agricultural Development from 1976 to 1983. During that period of unease he helped guide cooperative relationships between Land Grant Universities and the Agency for International Development.

Dr. Wharton must be recognized as a world-class professional who established a solid career in the academic field. His work affected the lives of many, not only the millions of subsistence farmers over the world, but also the orientation of professionals in development. Wharton mastered an exceedingly difficult area of economic analysis and stands tall in the profession in obtaining a wider understanding and application of the fundamentals in development."

Dr. Wharton has been Chairman and Chief Executive Officer of the \$64 billion TIAA-CREF since February 1, 1987. He was Chancellor of the State University of New York for the previous nine years, and was President of Michigan State University for eight years prior to that.

In 1957, Dr. Wharton began his professional career with the American International Association for Economic and Social Development, set up by Nelson A. Rockefeller to work on development in Latin America. From 1958 to 1964, he directed the work of the Agricultural Development Council in Southeast Asia. During these years he was also a visiting Professor at the University of Malaya engaged in teaching and research on the development problems of the region.

Other past winners of the AAEA Fellow Award include Professor Schultz of The University of Chicago, and Dr. Arthur T. Mosher, former President of the Agricultural Development Council, who was one of Dr. Wharton's early mentors.

PRESIDENT'S FELLOWSHIP PROGRAM, The University of California.

In order to improve the quality and diversity of university faculty and to encourage outstanding minority and women Ph.D. degree holders to pursue academic careers at the University of California, The Regents of the University in 1984 established the President's Fellowship Program. Appointments are for one academic year, beginning July 1, with renewal for a second year pending demonstration of satisfactory progress. The stipend is \$22,000 to \$28,000, depending on discipline and experience.

Applicants must be U.S. citizens or permanent residents, and must hold or receive a Ph.D. from an accredited university. Preference is given to minority and women candidates historically underrepresented in higher education. Applications are encouraged from Afro-Americans, American Indians, Asian Americans, Filipinos, Mexican Americans and Puerto Ricans, and from women in Physical Sciences, Mathematics or Engineering.

POSTDOCTORAL FELLOWSHIPS

ROCKEFELLER FELLOWSHIPS

The Rockefeller Foundation is offering social science research fellowships to up to 10 persons holding recent social science doctorates for two-year appointments in developing countries. Fellows will be assigned to international agricultural research institutes in developing countries and will be expected to participate fully in the work of the host centers.

Candidates should have received a Ph.D. after December 1984 or should expect to do so before September 1989. The program is open to citizens of the USA and Canada and sub-Saharan African countries. The deadline for North American residents is December 31, 1988. For persons applying from Africa, the deadline is January 31, 1989.

ROCKEFELLER INTERNSHIPS

Doctoral students enrolled in U.S. universities who are from sub-Saharan Africa are invited to apply to the Rockefeller Foundation for dissertation research support. Priority will be given to research topics in the fields of agricultural, health and life sciences, but other proposals are welcome.

Applicants are responsible for arranging an affiliation with an African Institution able to provide needed research support, such as laboratory facilities, access to study sites, and technical advice. The candidate's U.S. faculty advisor, the host institution in Africa, and the funding agency with primary responsibility for financing the student's graduate work must all endorse the application.

Deadline for applications is March 1, 1989. Preliminary inquiries are encouraged to determine the appropriateness of the research topic and the proposed institutional setting in Africa. Candidates should apply well in advance of the expected field work starting date.
