#### MESSAGE FROM THE CHAIR

In 1980, the American Agricultural Economics Association (AAEA), established "The Committee on Opportunities and Status of Blacks in Agricultural Economics." The original charge was to survey and ascertain information on the opportunities of Blacks in the agricultural economics profession. Since that time, the committee has undertaken a number of projects including: sponsoring invited paper sessions at AAEA meetings; organized symposia; a directory of black agricultural economists which is updated biannually; newsletter; a survey of agricultural economists in conjunction with the AAEA committee on employment services; co-sponsored a pre-meeting conference entitled "The Future for Agricultural Economists -Career Opportunities and Planning;" and hosted a number of receptions during AAEA annual meetings. Over the past year, the committee sponsored: a pre-meeting conference entitled "Agricultural Economics and Rural Development Programs at the 1890's: Past, Present and Future"; continued to update the directory; began the development of a brochure of "Outstanding Black Agricultural Economists"; began the development of papers for a special issue of the "Journal of Black Political Economy"; developed and submitted a proposal for an invited paper session at SAEA annual meeting; and, continued working on long range plans.

The coming year (1989-90) marks my second term as committee chairman. I appreciate your vote of confidence. Several projects initiated during the past year: the pre-conference program proceedings; the directory; the brochure of outstanding Black Agricultural Economists; the special issue of the "Journal of Black Political Economy"; and the SAEA invited paper session, are scheduled for completion this year. A number of new initiatives are planned. The committee appreciates the valuable input provided by James Houck, AAEA Board Representative. Appreciation is also extended to a number of other individuals who have continuously provided guidance, input and support to the committee. Your continued assistance is appreciated.

Each year new members are nominated to serve on the committee and approved by the President of AAEA. We welcome the active involvement of the following new members to the committee: Magid A. Dagher (University of Arkansas), Samuel Donald (Alcorn State University), Abdulhakeem Salaam (Southern University), Winston Smart (Smart Agricultural Research Service), and Lawrence W. Libby (University of Florida) Board Representative for 1989. Our next committee meeting will be held in conjunction with the SAEA meetings in Little Rock, Arkansas. These meetings are scheduled for February 4 - 7, 1990. Specific information relative to our committee meeting will be provided in the near future. If you plan to attend the SAEA meetings, please stop in on our committee meeting if your schedule permits.

#### A LOOK AT SOUTHERN UNIVERSITY

[Editors Note: We continue our highlight of 1890 institutions with this issue featuring the "Host" for the recent AAEA preconference on 1890 schools].

Southern University was established in 1880 in New Orleans, Louisiana. The College of Agriculture was organized in 1890 as a department subsequent to the passing of the Second Morrill Act. In 1914, Southern University was relocated to Baton Rouge, Louisiana.

The agricultural program at Southern University has had several changes and modifications in purpose since 1890. From 1890 until 1925, the program aimed to give practical agricultural instruction at the high school level. Beginning in 1925 and continuing until 1940, the program aimed to prepare teachers to teach vocational agriculture in the high schools. From 1940 to 1959, the program was designed to train teachers as well as offer undergraduate degrees in several of the technical fields of agriculture.

A two-year pre-professional curriculum in veterinary medicine and a four-year curriculum in animal science were added in 1940. In 1949, a curriculum in general horticulture was added. These programs represented the first non-teaching curricula offered in agriculture. Since 1958, the agricultural unit has been designed as a college and in 1986 it was combined with the College of Home Economics to form the College of Agriculture and Home Economics.

Presently, the College is composed of six academic departments. They are the Departments of Agricultural Economics, Animal Science, Plant and Soil Science, Clothing and Textiles, Family Life, and Foods and Nutrition.

The Department of Agricultural Economics was established in 1974 for the purpose of combining technical core courses or specialized training in agricultural economics and/or agribusiness (i.e., resource economics, public policy, economic development, price analysis, and marketing) along with liberal arts courses and business and economic theory. This process formed a well-rounded, quality program of study, while allowing ample opportunity for interdisciplinary study and development for work and/or further study in many areas.

Students majoring in Agricultural Economics gain valuable work experience as research assistants. During the regular semester, students may be assigned to work on research projects with school professors via the work-study program, or they may have co-op assignments at private companies or government agencies. Summer internships arranged through the University also provide students with work experiences: including research assignments with various universities; and job-related experiences with private industry and government. The program presently has 35

majors. As of 1989, one hundred forty-eight students have graduated from the program.

The faculty of the Department of Agricultural Economics have terminal degrees and are friendly, helpful professionals who strive to teach practical, applied economics and business along with classroom theory and principles.
