Moving COSBAE Forward - A Few Thoughts from the Chair

According to the AAEA website, "COSBAE, the Committee on the Opportunities and Status of Blacks in Agricultural Economics (COSBAE) was established in 1980 for the purpose of promoting the welfare of Black agricultural economists by representing their interests and by engaging in activities that encourage their professional advancement." It seems clear that COSBAE has met with some success in its objectives by holding its own sessions and thus encouraging wider participation of its membership at the annual meetings of the AAEA.

However, COSBAE needs to do more to enhance the status of its traditional target group. For example, there ought to be maintained, a register of all potential members of COSBAE (including students) and they should be encouraged to join the Association and this Section. There could also be a regular link with this wider grouping, via the modern communication technology including the social media. COSBAE should also consider holding other sessions within the year, to stimulate papers and collaborative research among its members. In addition, one area that we have already agreed to venture into is to have more Invited Paper Sessions by the membership, in the Annual meetings, and the

sharing of information on member publications.

However, now is perhaps also the time for COSBAE to move on. And the issue is where to? Now the AAEA has a wide range of Sections and as COSBAE may look to expand its focus, recognition must be paid to this reality. In particular, the AAEA in adopting its new name (Agricultural and Applied Economics Association) has widened its appeal and focus internationally. However there is already an International Section. However, the objectives of this International Section still leave a lot of room for further international effort. So

specifically, according to the AAEA website:

“The International Section of the AAEA develops activities and programs that educate and inform AAEA members about the expanding and intertwining nature of global economics as it relates to food, natural resources, agriculture trade and development, policies, and politics.”

This somewhat narrow focus leaves room for COSBAE to take on the role of developing the capacity and opportunities of its target group in countries worldwide. This can be achieved by linkages with agricultural economists and their

societies in Africa, the Caribbean and Latin America and elsewhere, so that COSBAE would be raising the status of its target group, not only in North America, but throughout the world. So for example, what opportunities exist for raising the status of agricultural economics in Haiti or Tanzania or Panama or Jamaica? How can we make use of these opportunities?

One example of linkages with societies that may be possible is the case of the Caribbean Agro-Economic Society. This Society linked with the AAEA in 1993 at the Annual Meeting that was held in Orlando, Florida. This Society hosts the West Indies Agricultural Economics Conferences, and the 30th such Conference was held in

Trinidad and Tobago in July of this year. COSBAE could develop links with such societies in target countries to hold joint meetings, seminars etc. The mechanism of the AAEA Symposium is available to assist in such efforts.

So exciting times may lie ahead for COSBAE and it is my hope that the younger members of this Section will rally to take COSBAE to greater heights.

Awudu Abdulai, is a Professor of Food Economics and Food Policy, and Head of Department of Food Economics and Consumption Studies at the University of Kiel, Germany. Prior to joining the faculty at the University of Kiel in 2004, he taught at the Swiss Federal Institute of Technology, Zurich (ETH-Zurich) and also held visiting positions at the Departments of Economics at Yale University and Iowa State University, as well International Food Policy Research Institute, Washington, DC. He spent 2010-2011 as Cargill Visiting Professor at the Center for Food Security and the Environment at Stanford University.

Awudu has taught courses in economic development, global food security, industrial organization, consumer behavior and applied econometrics. His research focuses on the impact of new agricultural technologies on household welfare, effects of land tenure arrangements on investment in soil and productivity-enhancing measures, as well as food security policies in developing countries. He has co-authored several peer-reviewed articles and book chapters. Some of his recent publications include Abdulai, A., V. Owusu and R. Goetz (2011). Land Tenure Arrangements and Investment in Land Improvement Measures: Theoretical and Empirical Analysis. *Journal of Development Economics*, 96(1): 66-78, and Kuhlitz, C. and A. Abdulai (2012). Food Aid and Malnutrition in Developing Countries: Evidence from Global Food Aid Allocation. *Journal of Development Studies* Vol. 48(12), pp. 1765-1783. His most recent work investigates the effects of time-related characteristics of tenancy contracts on investment in soil conservation practices. Other more recent work include impacts of policy reforms on the nature and speed of transmission of

world prices to domestic prices in developing countries, how international trade affects poverty and food security in developing countries, and consumers preferences and willingness-to-pay for organic food products.

Awudu obtained his PhD in Agricultural Economics in 1994 from the Swiss Federal Institute of Technology, Zurich. His dissertation won the Faculty outstanding PhD Dissertation Award. He also received an MSc in Agricultural Economics from the ETH-Zurich in 1990, and a BSc in Agriculture from the Kwame Nkrumah University of Science and Technology, Ghana in 1983.

Awudu is currently Co-Editor-in-Chief of *Agricultural Economics* (Journal of the International Association of Agricultural Economists). He is also an Associate Editor of *American Journal of Agricultural Economics* and member of the Editorial Advisory Board of *Food Policy*.
