





Agricultural Trade of the European Economic Community: 1965 and 1966 (see page 6). Agricultural imports by the European Economic Community (EEC) totaled \$12,888 million in 1966, an increase of 7 percent from 1965. Exports of farm products from the EEC totaled \$5,784 million, an increase of 3 percent from 1965. Trade in agricultural products among the Common Market countries -- intra-community trade -- totaled about \$3.2 billion in 1966, 25 percent of their imports and 55 percent of the exports. This was 8 percent above the 1965 level. Intra-community trade grew slightly faster than trade with nonmember countries.

* * * * *

U.S. Agricultural Imports Totaled \$4.5 Billion in Fiscal Year 1966/67 (see page 19). U.S. agricultural imports for consumption totaled \$4,454 million in 1966/67, about the same as a year earlier. Increases in imports of supplementary (partially competitive) products were about offset by declines in complementary (noncompetitive) products. The increase in supplementary products to \$2,667 million was brought about by larger imports of beef and veal, dairy products, sugar, vegetables, and fruits. For animals and animal products, the increases in meats and products, and dairy products were about offset by declines in apparel wool, hides and skins, and dutiable cattle. Complementary imports fell to \$1,786 million, 10 percent below the \$1,982 million in 1965/66. Nearly all of the decrease was due to a 17 percent drop in imports of coffee to a total of \$978 million in 1966/67. The value of cocoa beans increased sharply, while quantity was considerably below the previous year. Smaller production resulted in a rise in prices to more normal levels. Other declines were noted for crude natural rubber, tea, and carpet wool. Imports of bananas advanced to a record 3,826 million pounds. Non-agricultural products totaled \$22 billion in 1966/67, up 16 percent from a year earlier.

Customs Duties on U.S. Agricultural Imports (see page 29). Customs duties on U.S. agricultural imports averaged 5.6 percent for all commodities and 10.7 percent on dutiable agricultural items in 1966. Dutiable agricultural commodities had a value of \$2,363 million, or 53 percent of total agricultural imports. Duties collected on these items aggregated \$255 million, most of which were derived from specific rates. Tariffs were lowered on a number of agricultural commodities in return for reductions by many other countries during the recently concluded "Kennedy Round" negotiations in Geneva, Switzerland. The tariff reductions will affect U.S. agricultural imports with a current value of \$639 million; reductions will take place on most items in equal steps over a 5-year period, beginning in January 1968.

U.S. Exports by Destination, Calendar Years 1961-66 (see page 41). Exports of U.S. agricultural products to all world regions increased over the 5-year period 1961-66, bringing the total value up to a new record of \$6,879 million. Shipments to Asia over the period rose 60 percent, mainly because of expanded commercial sales to Japan, the Republic of Korea, the Philippines, and Taiwan. Europe remains the major destination for U.S. farm exports, though the proportion to that area declined. Members of the European Economic Community and the European Free Trade Association are the major markets in Europe, but nonmember European countries such as Spain and Yugoslavia are also growing markets.



U.S. Agricultural Exports: July-June 1966/67 (see page 66). U.S. agricultural exports for fiscal year 1966/67 surpassed the record volume of 1965/66 by approximately \$89 million, reaching \$6,766 million. This was \$12 million below the estimated value of agricultural exports reported in the August issue of Foreign Agricultural Trade of the United States. The record level of exports during 1966/67 resulted from greatly expanded shipments of cotton and tobacco, accompanied by smaller gains in oilseeds and products and vegetables and preparations. These increases were sufficient to offset the declines in animals and animal products, grains and preparations, and fruits and preparations. Cotton exports rose sharply this past fiscal year to 4.6 million bales, 50 percent higher than those of 1965/66. Exports of unmanufactured tobacco were 39 percent above those of 1965/66. Exports of oilseeds and products were about 2 percent higher due to an increase in value. Increased exports of grain sorghums and rice partly offset declines in corn, barley, and oats.

AGRICULTURAL TRADE OF THE EUROPEAN ECONOMIC COMMUNITY: 1965 and 1966

Agricultural trade of the member countries of the European Economic Community totaled \$18,672 million in 1966, 6 percent more than in 1965. Agricultural imports were \$12,888 million, 69 percent of the total agricultural trade. Exports were 31 percent of the total. The EEC countries are net importers of agricultural products, and imports exceeded exports by \$7,105 million.

Agricultural imports by the EEC in 1966 rose 7 percent from \$12,000 million in 1965 (table 3). Substantial increases took place in imports of animals and animal products, grains and preparations, vegetables, animal feeds, tobacco, oilseeds, and cotton. Much of the growth occurred in products related to increased demand associated with improved living standards, such as the increase for meat products, and the resulting greater demand for animal feeds. For instance, imports of animals and animal products were up 6 percent. Grains and preparations -- mainly feed grains -- and animal feeds were up 8 percent and 22 percent, respectively. Oilseeds, from which byproducts used for animal feeds are produced, were also up 18 percent.

Exports of farm products by the EEC increased, but by a less substantial amount than imports (table 5). Exports of animals and animal products were higher in 1966 than in 1965, but exports of grains and preparations were down.

Intra-community trade (trade among the EEC countries), which amounted to \$3.2 billion, was 25 percent of total EEC imports, and 55 percent of the agricultural exports. From 1965 to 1966, intra-community trade increased 8 percent. Imports from third countries (non-EEC members) rose 7 percent, a slightly slower rate than the increase in intra-community trade. Exports to third countries were about the same as 1965.

This article is based on trade data reported to the United Nations by the individual EEC countries. It updates statistics of principal commodity groups reported in a similar article published in the January 1967 issue of Foreign Agricultural Trade of the United States.^{2/} The agricultural imports of the EEC countries are the c.i.f.

value at port of entry, and exports are reported f.o.b. at port of exit. The EEC countries' reported imports of farm products from the United States, if compared with the U.S. agricultural exports based on Bureau of the Census data, are about 12 percent greater. This difference results partly because U.S. exports are f.o.b. port of origin and EEC imports from the United States are reported in c.i.f. values. It is not discernible whether any, or part of, transshipments through the European ports were included in the U.N. data. However, a comparison of the import data reported by the individual EEC countries to the United Nations, and the data on U.S. agricultural exports to the EEC indicate that the U.N. data do not contain transshipments. Table 2 shows imports from the United States by the EEC countries, and the U.S. agricultural exports to the EEC. Imports by the Netherlands from the United States, for instance, are much less than the U.S. exports to the Netherlands which are known to contain transshipments. On the other hand, West Germany's reported imports from the United States are substantially larger than the reported U.S. exports to West Germany. The differences result from U.S. exports to the Netherlands, which are shipped to West Germany.

Agricultural Imports by the EEC

Of total agricultural imports by the EEC countries, \$3.2 billion were received from within the EEC, and \$9.7 billion were imported from third countries (table 3). The United States was the largest supplier to the EEC among the third countries, followed by the Latin American Free Trade Association, Asian and African countries not associated with the EEC, the Associated overseas countries, and the European Free Trade Association.

In 1966, imports of agricultural products from the United States totaled \$1.8 billion, 10 percent above those of 1965. Imports from the United States have increased 57 percent since 1960 (figure 1). However, the increase that occurred from 1960 through 1963 (13 percent) was gradual compared with the sharp increase from 1963 to 1964 (20 percent). From 1964 through 1966, the increase was again more gradual, rising 16 percent.

West Germany was the largest importer of agricultural products from the United States. In 1966, it received farm products valued at \$662 million, 12 percent higher than 1965. The Netherlands ranked second, receiving a total of \$385 million in agricultural products.



Belgium-Luxembourg's agricultural imports totaled \$1,177 million, up 5 percent from 1965 (table 4). The largest share of their imports originated in the EEC countries, and for 1966, imports from EEC countries were \$417 million, 35 percent of the total. Animals and animal products accounted for about one-fourth of Belgium-Luxembourg's imports from EEC countries, primarily meats (including poultry), dairy products, and wool. The Netherlands was the principal source for Belgium-Luxembourg's imports from the EEC, accounting for about two-thirds.

Imports from the United States totaled \$185 million, 16 percent of Belgium-Luxembourg's agricultural imports. The United States was principally a source for grains and preparations. These made up 57 percent of the imports from the United States; oilseeds, amounting to \$24 million, ranked second.

The Latin American Free Trade Association provided imports for Belgium-Luxembourg valued at \$148 million. Their largest contribution was animals and animal products, followed by animal feeds, coffee, tea, and cocoa, and grains and preparations. Argentina, Brazil, and Colombia supplied four-fifths of the imports from LAFTA.

Imports from "other" countries totaled \$206 million, and major suppliers were Canada, Greece, Turkey, other European countries (including Eastern Europe) and Oceania. Imports from Australia and New Zealand -- mainly wool -- accounted for 35 percent of the "other" total.

France imported agricultural products valued at \$2,827 million in 1966. Imports by France from the other EEC countries totaled \$435 million. The Netherlands was the major supplier, followed by Italy, and Belgium-Luxembourg. Imports from the Netherlands totaled \$150 million, with meats (including poultry) accounting for 39 percent. Pork

was the principal meat. Fruits, nuts, and vegetables accounted for over half of the total Italian exports to France. France's purchases from Belgium-Luxembourg were \$104 million, principally of animals and animal products, and vegetables.

About 20 percent of France's imports originated in "other" countries (table 4). France imported farm products from Australia and New Zealand valued at \$226 million, of which wool and animal hair made up the largest part -- \$146 million.

Imports from African countries totaled \$343 million. The principal countries were Morocco, South Africa, and Nigeria; France's imports from these 3 countries totaled \$240 million. Morocco shipped fruits, nuts, vegetables, and preparations to France valued at \$117 million. South Africa was a principal source for wool, and Nigeria for ground nuts.

The countries of the Latin American Free Trade Association supplied agricultural products valued at \$227 million. Argentina, Brazil, Mexico, Uruguay, and Peru accounted for 92 percent of France's imports from LAFTA.

Argentina and Uruguay accounted for the bulk of animal product shipments to France. Brazil was the principal LAFTA source for coffee, and Mexico was the major cotton supplier.

French imports from the United States in 1966 totaled \$219 million, 6 percent higher than in 1965. The U.S. share of French imports was about the same as in 1965. Grains and preparations imported by France from the United States totaled \$61 million in 1966, up one-fifth from \$51 million in 1965. Wheat and corn were the major items. Animal feeds ranked next to grains and preparations in total value, amounting to \$57 million in 1966; oilcake and meal was the major product. Animal products, fruits and nuts, oilseeds (soybeans) and cotton also accounted for 6 percent or more of imports from the United States.

West Germany was the largest importer of agricultural products among the EEC countries (figure 2). In 1966, their agricultural imports totaled \$4,942 million, 38 percent of total agricultural imports by the European Common Market.


Intra-community imports of farm products totaled \$1,634 million, one-third of West Germany's total agricultural imports. Animals and animal products were the principal commodities imported from other EEC countries, followed by fruits and nuts, grains and preparations, and vegetables.

West Germany's imports of farm products from the Netherlands totaled \$591 million in 1966; they were 36 percent of total intra-community agricultural imports by West Germany. Principal commodities moving from the Netherlands were animals and animal products, vegetables, bulbs, and cut flowers. Of the animals and animal products imported by West Germany from the EEC, the Netherlands accounted for 51 percent. These included such products as fresh, chilled, and frozen meats (including poultry) dairy products, eggs, and vegetables. France -- also a major source for West German imports -- provided animals and animal products, and grains and preparations. Italy was a principal source for fruits and nuts.

Of the \$927 million in agricultural imports received from "other" countries by West Germany, European countries (including Eastern Europe, Greece, and Turkey accounted for 61 percent of this total. Fruits and nuts, animals and animal products, and coffee, tea, and cocoa were the principal commodities imported from "other" countries.

The United States supplied the largest individual share of West German imports, and in 1966 accounted for 13 percent of the total. The principal commodities imported

from the United States were oilseeds -- mainly soybeans -- grains and preparations, and tobacco. Soybean imports from the United States were valued at \$185 million, and feed grains at \$122 million. Wheat imports totaled \$39 million. Oilseeds, grains, and tobacco increased from 1965, but imports of animal products, fruits and nuts, vegetables, fats and oils, and cotton declined.

Italy ranked third among the EEC countries as an importer. In 1966, its imports totaled \$2,585 million, 20 percent of the agricultural imports by the EEC. The principal commodities imported by Italy were animals and animal products, and grains and preparations, which together accounted for 64 percent of total agricultural imports. Cotton, oilseeds, and coffee, tea, and cocoa were also important imports.

Italy's imports from LAFTA totaled \$531 million in 1966, up nearly a fourth from 1965. Argentina's share was 57 percent of the LAFTA total. Of the total imports from Argentina which amounted to \$300 million, \$205 million were in grains and preparations, and \$85 million were in animals and products.

The EEC countries were the second largest source for Italy's imports. They totaled \$464 million in 1966, 18 percent of Italy's total agricultural imports. Twenty-six percent of Italy's imports of animals and animal products were from the EEC, with France contributing the largest share, the Netherlands the next largest. French shipments of animals and animal products -- notably live animals, dairy products, and hides and skins -- totaled \$120 million. The Netherlands was a major supplier of meats.

Imports of farm products from the United States were \$330 million, 13 percent of Italy's agricultural imports in 1966. Fifty-eight percent of the imports from the

United States were grains and preparations. Of total imports of grains and preparations, 35 percent were received from the United States. The United States was also a major supplier of oilseeds, accounting for about one-third of Italy's oilseed imports.

The Netherlands' imports of agricultural products in 1966 totaled \$1,356 million, 5 percent above 1965. The principal commodities imported were grains and preparations, animal products, animal feeds, coffee, tea, and cocoa, oilseeds, and fruits and nuts.

The United States was the principal supplier for the Netherlands and accounted for 28 percent or \$385 million of the Netherlands' total agricultural imports in 1966. The United States was an important source for grains and preparations -- especially corn. U.S. corn receipts by the Netherlands totaled \$110 million in 1966.

The EEC accounted for 21 percent of the Netherlands' imports in 1966, and totaled \$285 million. Imports of animal products accounted for about a fourth, with Belgium-Luxembourg the major supplier. Meats, wool, and dairy products were the main animal products imported from Belgium-Luxembourg.

Fruits and nuts, grains and preparations, and vegetables were other important commodities shipped to the Netherlands from EEC countries. Belgium-Luxembourg and Italy supplied 77 percent of the Netherlands' fruit and nut imports. Belgium-Luxembourg was also a large supplier of grains and preparations and vegetables.

LATFA countries were important for coffee, tea, and cocoa, and animals and products. Argentina, Brazil, Peru, and Colombia were the principal suppliers.

Agricultural Exports by the EEC

Agricultural exports from the EEC totaled \$5.8 billion (table 5). The principal exports were animals and products, which totaled \$1,803 million -- nearly one-third of total agricultural exports. Grains and preparations, and vegetables ranked second and third, respectively, as major products for export. Intra-community exports accounted for the largest share.

Most of the agricultural exports from the EEC were limited to other European countries including the European Free Trade Association and Comecon (Eastern Europe). Combined, the European countries other than the EEC countries received agricultural exports valued at \$1,430 million, or 25 percent of the EEC exports.

France was the largest EEC exporter of farm products (table 6). French agricultural exports in 1966 totaled \$1,848 million, nearly a third of EEC exports. Fifty-nine percent of the French exports were animal products and grains and preparations. Over half of France's exports were shipped to other EEC countries, and one-fourth was exported to countries outside the EEC, including Eastern Europe.

The Netherlands ranked second as an exporter of agricultural products, and in 1966 accounted for 31 percent of the EEC's agricultural exports. Animals and animal products, vegetables, and fats and oils were the principal items exported from the Netherlands, and made up 65 percent of their exports in 1966.

About three-fifths of the exports of farm products from the Netherlands were intra-community shipments, and one-fifth were to other European (including Comecon) countries. About 70 percent of the exports of vegetables from the Netherlands was shipped to the other EEC member countries. Fifty-nine percent of the animals and animal products were exported to the EEC countries.

Italy's 1966 exports of agricultural exports totaled \$968 million, with 54 percent being shipped to other EEC countries. Italy was a heavy exporter of fruits and vegetables, and most shipments were to European countries. There were large exports of fruits and vegetables to other EEC countries, and EFTA countries also received a substantial share.

Belgium-Luxembourg's exports of farm products totaled \$592 million in 1966. Two-thirds were shipped to other EEC countries. The EFTA countries received the second largest share. Animals and animal products were the principal exports from Belgium-Luxembourg.

West Germany, while being the largest importer of agricultural products, was the smallest exporter of farm products. Its exports in 1966 totaled \$558 million, 10 percent of total EEC agricultural exports. Animals and animal products, grains and preparations, vegetables, and fats and oils were the principal commodities exported. The EEC countries were the major markets, receiving 41 percent of West Germany's exports. The EFTA countries accounted for 32 percent of West Germany's agricultural exports.

EXPLANATORY NOTES FOR TABLES

The trade groups shown in the tables contain the countries listed below.

The EEC-Associated Overseas Countries (AOC) include: Algeria, Burundi and Rwanda, Caldonia, Cameroon, Central African Republic, Chad, Congo (Brazzaville), Congo (Leopoldville), Dahomey, French Somaliland, Gabon, Guadeloupe, Ivory Coast, Malagasy Republic, Mali, Martinique, Mauritania, Netherlands Antilles, Niger, Reunion, Senegal, Somali Republic, Surinam, Togo, and Upper Volta.

The European Free Trade Association (EFTA) includes: Austria, Denmark, Norway, Portugal, Sweden, Switzerland, and the United Kingdom.

The Council of Mutual Economic Assistance (Comecon) includes: Bulgaria, Czechoslovakia, East Germany, Hungary, Poland, Romania, and USSR (Russia).

The Latin American Free Trade Association (LAFTA) includes: Argentina, Brazil, Chile, Colombia, Ecuador, Mexico, Paraguay, Peru, and Uruguay.

Other African Countries include: Angola, Comoro Islands,^{1/} Ethiopia, Gambia, Ghana, Guinea, Kenya, Liberia, Libya, Mauritius, Malawi, Morocco, Mozambique, Nigeria, South Africa, Southern Rhodesia, Sudan, Tanganyika, Tanzania, Tunisia, Uganda, United Arab Republic (Egypt), Zambia, and Zanzibar-Pemba.

Other Asian Countries include: Aden, Afghanistan, Burma, Cambodia, Ceylon, China (Mainland), China (Taiwan), Hong Kong, India, Indonesia, Iran, Iraq, Israel, Japan, Jordan, Korea Republic, Kuwait, Laos, Lebanon, Malaysia, Mongolia, Nepal, North Korea, North Vietnam, Pakistan, Philippines, Saudi Arabia, Singapore, Syria, Thailand, Vietnam Republic, and Yemen.

Other European Countries include: Albania, Cyprus, Finland, Iceland, Ireland, Spain, and Yugoslavia.

^{1/} Although Comoro Islands data are included with the other African countries, it is a member of the EEC-AOC countries. In 1966, EEC agricultural imports from the Comoro Islands were \$5,000 and exports were \$370,000.



U.S. AGRICULTURAL IMPORTS TOTaled \$4.5 BILLION IN FISCAL YEAR 1966/67

U.S. agricultural imports for consumption totaled \$4,454 million in fiscal year 1966/67 -- the same as in the previous year. The import picture in 1966/67 was dominated by a sharp rise (8 percent) in supplementary (partially competitive) products, while complementary (noncompetitive) products were down 10 percent. Coffee imports accounted for nearly all of the decrease. Of animals and animal products, increased imports of beef and veal, and dairy products were offset by declines in apparel wool, hides and skins, and dutiable cattle. Imports of sugar, vegetables, fruits, and wines increased.

For the past decade, total agricultural imports have been relatively stable, although some significant shifts have occurred in the various commodities imported. Supplementary imports now represent about 60 percent of total agricultural imports, compared with only 44 percent during the 1950-54 period. This increase in the supplementary share occurred from larger imports of animal products, which increased over 57 percent from the 1950-54 average. Supplementary vegetable products gained one-third in the comparable period. There has been a trend toward imports of larger quantities of fresh fruits and vegetables during the domestic off-season. Higher income and demand for time-saving food preparations have encouraged imports of dairy products -- primarily cheese -- and meats for manufacturing prepared meat products such as ready-to-cook hamburgers, luncheon meats, and other ready-to-serve meat products.

Nonagricultural imports were \$22 billion in 1966/67, up 16 percent from a year earlier. A continued high level of economic activity and the war in Vietnam have encouraged larger imports of raw materials and manufactured products.

Supplementary Products

Imports of supplementary products rose to \$2,568 million in 1966/67, 8 percent larger than the \$2,472 million in the previous year (table 7). The increase was brought about by larger imports of beef and veal, dairy products, sugar, vegetables, and fruits. This level of supplementary imports is an all-time high.

Animals and animal products.--Imports of animals and animal products totaled \$1,105 million, 1 percent above the level of a year earlier. The gain in imports of meats and meat products, primarily beef and veal, and dairy products was offset by declines in imports of apparel wool, hides and skins, and dutiable cattle.

Dutiable cattle imports declined to 890,000 head in 1966/67 from the record 1,265,000 head in 1965/66. Most dutiable cattle imports were feeders and stockers imported

primarily by farmers and ranchers for feeding. Mexico and Canada were the principal sources for dutiable cattle imports. Mexico supplied nearly 60 percent in 1966/67 and Canada most of the rest. In fiscal year 1965/66 when feeder cattle prices in the United States were relatively high and supplies were plentiful in Mexico and Canada, U.S. imports rose sharply. In 1966/67, U.S. prices weakened and the availability of cattle from these two sources was somewhat reduced, causing imports to decline sharply. In the past year, the average unit value of imported dutiable cattle was \$21 per hundred pounds compared with \$20 a year earlier. About 80 percent of imports were cattle weighing between 200 and 700 pounds.

Imports of dairy products rose sharply to \$134 million in 1966/67 from \$94 million in 1965/66. The increase was in products not regulated under Section 22 of the Agricultural Adjustment Act, as amended. Of these commodities, Colby cheese rose to 76 million pounds in 1966/67 from 20 million in 1965/66, and butterfat/sugar mixtures rose to 140 million pounds from 61 million in 1965/66. Imports of cheese increased sharply in 1966/67 and represented over one-half of total dairy product imports. In recent years there has been a sharp rise in the demand for imported as well as domestic cheeses in the United States. Most imported cheeses are special types, such as pecorino, that sell for relatively high prices compared with domestic cheeses.

President Johnson issued a proclamation under Section 22 of the Agricultural Adjustment Act, as amended, on June 30 to extend import quotas to several dairy products not previously controlled. The new quota includes butterfat/sugar mixtures such as junex used for ice cream mixtures, Colby and other American type cheeses, and frozen cream. The new quotas aim at reducing dairy product imports to about 1 billion pounds, milk-equivalent, annually.

Meat imports rose 14 percent to \$632 million in 1966/67 as imports of boneless beef used in processing meat products continued to increase. Imports of beef and veal totaled 911 million pounds in 1966/67, up from 796 million a year earlier. Much of the value increase was due to a higher unit value of imports. While the value of beef and veal imports was up 27 percent, the volume was up only 14 percent. Imports in the first half of 1966/67 were up 44 percent, and only 10 percent in January-June. Boneless beef accounted for over 80 percent of the total beef and veal imports in 1966/67. Australia and New Zealand -- the major suppliers -- accounted for 60 percent of the total imports of beef and veal. Imports of fresh, chilled, and frozen cattle meat and meat of goats and sheep, excluding lambs, which are subject to possible import quotas authorized under Public Law 88-482, totaled 824 million pounds in 1966/67.

Imports of pork and products totaled 296 million pounds, slightly below the 300 million pounds a year earlier. About two-thirds of the pork imports are canned hams and shoulders from the Netherlands, Denmark, and Poland. Most other imports consist of fresh Canadian pork.

Hides and skins.--Imports of hides and skins fell to \$67 million in 1965/66 from \$81 million a year earlier. Sheep and lamb skins, the major products imported, accounted for over half of total imports of hides and skins.

Apparel wool.--Imports of apparel wool declined to \$113 million in 1966/67 from \$173 million in 1965/66. Mill activity in the United States was at a lower level than in the previous year. Furthermore, a considerable part of wool imports was in the form of finished materials and fabrics.

Cotton.--Imports of cotton excluding linters totaled 102,000 bales in fiscal year 1966/67, down slightly from the previous year. Except for short Asiatic cotton, imports are

regulated by quotas. Long-staple cottons were limited to 95,000 bales on an August 1-July 31 year, while imports of upland cotton (under 1-1/8 inches) were limited to 30,000 bales on a September 19-September 18 year. In fiscal year 1966/67, the United Arab Republic was the main source for cotton imports, with two-thirds of total U.S. imports.

Fruits and preparations.--Imports of fruits and preparations increased to \$133 million in 1966/67 from \$122 million in 1965/66. The increase reflected an increase in imports of apples, olives-in-brine, and canned pineapples. Part of the rise in the value of olive imports was due to a 14 percent increase in unit values of imports. Imports of berries declined slightly in 1966/67 to \$19 million from \$22 million the previous year. Other declines were noted for dates, figs, grapes, and melons. Melon imports declined to 233 million pounds in 1966/67 from 249 million in 1965/66 because of increased production and lower prices in the United States.

Grains and preparations.--Imports of grains and preparations were \$44 million in 1966/67 compared with \$40 million in the previous year. Imports of wheat, rye grain, and oats increased, while declines were registered for barley grain, barley malt, and rice. Wheat imports were regulated under Section 22 of the Agricultural Adjustment Act, as amended, while imports of other grains were unrestricted. Most of the grain imports originated in Canada.

Sugar.--Imports of sugar into the United States totaled 4.7 million short tons, tel quel basis, compared with 3.9 million in the previous year. The value advanced by over \$100 million to \$572 million. The increase for the most part reflects increased consumption in the United States in 1966, resulting in increased quotas for importing of sugar for domestic consumption. In addition, part of the value increase was due to higher unit values, which averaged \$121.16 per ton in 1966/67 compared with \$116.05 in 1965/66. In 1966/67, imports of sugar represented about two-fifths of U.S. consumption.

Oilseeds and products.--U.S. imports of oilseeds and products totaled \$187 million in 1966/67, up slightly from a year earlier. Imports of copra declined substantially to \$40 million in 1966/67 from \$50 million from the previous year. This decline was offset mainly by larger imports of cacao butter, coconut oil, olive oil, and palm oil. The United States is a net exporter of oilseeds and products. However, imports are demanded because of the special properties and characteristics of oils required in food processing and for other industrial use in the United States.

Vegetables and preparations.--U.S. imports of vegetables and preparations rose \$156 million in 1966/67 from \$136 million in the previous year. The 15 percent rise in imports included larger imports of canned tomatoes, canned mushrooms, and fresh vegetables, except tomatoes. The rather cold spring in the United States caused production to decline and resulted in larger imports to meet consumer needs.

Tobacco.--Tobacco imports totaled 185 million pounds in 1966/67, compared with 174 million pounds in the previous year. Cigarette leaf represented about three-fourths of the tobacco imports, while most of the remainder was imported for use in cigars. Most tobacco imports were oriental types that come mainly from Turkey and Greece.

Wines.--U.S. imports rose to \$81 million in 1966/67 from \$74 million in 1965/66. Imports have been increasing for the past decade as a result of higher income and a demand for more luxury foods and beverages. Most of the wines are imported from Europe.

Complementary Imports

Complementary imports fell to \$1,786 million in 1966/67 from \$1,982 million in the previous year. A substantial part of the decline was represented by coffee, which dropped 17 percent to \$978 million in 1966/67. Gains for bananas and cocoa beans somewhat offset the sharp decline in coffee imports. Other declines were noted in imports of crude rubber, tea, and carpet wool.

Bananas.--U.S. imports of bananas in 1966/67 advanced to a record 3,826 million pounds from the previous year's 3,534 million pounds. Imports generally have been stimulated by lower import prices as new banana plantings came into production in Central America. The United States accounts for about two-fifths of world banana imports. The principal suppliers were Ecuador, Honduras, Panama, and Costa Rica. Improved technology and marketing techniques have helped to expand world banana exports. An example is the transition from the stem delivery of the past to box packaging and shipping, which has contributed to better condition of the fruit after delivery and has allowed for wider distribution.

Coffee.--U.S. imports of green coffee totaled 2,800 million pounds in 1966/67, down 11 percent in quantity from the previous year. The average unit value of imports in 1966/67 fell to 35 cents a pound from 37 cents a year earlier. Latin America continued to be the major supplier in the U.S. market, although its share has declined in recent years. In fiscal year 1966/67, Latin America accounted for about two-thirds of total U.S. imports of coffee. Africa's share of the U.S. coffee market increased to 27 percent in 1966/67 from only 15 percent in 1960. Imports from Africa are mostly the Robusta types of coffee, used mainly for blending and for instant coffee. In recent years the United States has accounted for about half of world coffee imports.

Cocoa beans.--U.S. imports of cocoa beans totaled 645 million pounds in 1966/67, compared with 938 million pounds in 1965/66. The average unit import value in 1966/67 was 22 cents per pound compared with 14 cents in the previous year. The decline in production in the past year has caused prices to rise to more normal levels. The 1966/67 crop is estimated at 1.3 million tons compared with the 1965/66 crop of 1.2 million. The United States has accounted for nearly one-third of world cacao imports in recent years. The major suppliers to the United States include Ghana, Nigeria, Ivory Coast, Dominican Republic, and Brazil.

Rubber.--Crude natural rubber imports declined further in 1966/67. They totaled 922 million pounds, compared with 1,048 million in the previous year. Imports of rubber generally have been declining for the past decade. The principal U.S. suppliers have been Indonesia, Malaysia, and Liberia.

Carpet wool.--U.S. imports of carpet wool fell to 111 million pounds in 1966/67 from 143 million pounds in 1965/66. U.S. carpet manufacturers are relying more on man-made fibers for making carpets. In the past year wool accounted for about two-fifths of fibers used in U.S. carpet manufacturing.

Tea.--U.S. imports of tea totaled 140 million pounds in 1966/67 compared with 135 million in 1965/66. However, value declined to \$58 million from \$60 million in the previous year. The major suppliers were Ceylon, India, Indonesia, and Kenya.



CUSTOMS DUTIES ON U.S. AGRICULTURAL IMPORTS

U.S. customs duties on agricultural imports averaged 5.6 percent in calendar year 1966. The ad valorem equivalent rate on dutiable agricultural commodities was 10.7 percent. In comparison, the rate of duty on total imports for consumption was 7.6 percent; for all dutiable imports the rate was 12.0 percent. Import duties on agricultural commodities in 1966 totaled \$255 million (table 10).

Dutiable agricultural imports, which accounted for 53 percent of the total agricultural purchases in 1966, included commodities from the following groupings: live animals except cattle and horses for breeding; meat and meat products; dairy products; bovine hides; long-staple wools; most miscellaneous animal products such as bristles, feathers, fats and oils, and gelatin; prepared cocoa products and coffee extract; raw cotton; fruits and their preparations; vegetables and their preparations except edible rootstocks; nuts and their preparations except fresh chestnuts; grains and most preparations; some oilseeds and products; essential oils; certain spices; sugar and related products; unmanufactured tobacco; wines and malt beverages; crude drugs; nursery and greenhouse stock; and field and garden seeds. Most of these commodities have specific duties. Ad valorem rates applied on canned beef, cheeses, bovine hides, some spices, some essential oils, and most crude drugs. Compound duty rates were in effect for mixtures of gelatin, vegetable glues, animal and vegetable salts and acids, candied cherries, and mushrooms. Table 11 shows agricultural commodities or commodity groupings with import values in excess of \$1 million and the ad valorem equivalents of their dutiable values.

The bulk of dutiable U.S. agricultural imports had ad valorem equivalent duty rates of less than 10 percent. Commodities with ad valorem equivalent rates of less than 5 percent included pork, bovine hides, bristles, inedible molasses, and maple syrup, some edible nuts (cashew, brazil, and pistache), coconut meat, feeds and fodders, oats and rye, some oilseeds (poppy and sesame), nursery and greenhouse stocks, and field and garden seeds.

Ad valorem rates between 5 and 10 percent are applied to fresh or frozen beef and veal, casein, fresh eggs, fresh milk and cream, prepared cocoa products, raw cotton, fresh grapes, pears, and certain berries, canned mandarin oranges and pineapples, barley and barley malt, wheat, hops, assorted bakery products, raw sugar, and some crude natural drugs.

Items with ad valorem equivalent rates between 10 and 20 percent consisted mainly of dutiable cattle, canned beef, cheeses, wines and malt beverages, filler and wrapper tobacco, fresh tomatoes, and olive oil. A few commodities had rates of 20 percent or above, such as long-staple wool, melons, oranges, orange juice concentrate, walnuts, some vegetables (canned tomatoes, beans, cucumbers, olives, mushrooms, and onions), and raw opium.

Imports of butterfat mixtures containing more than 20 percent and less than 45 percent butterfat by weight had an ad valorem rate of 20 percent.

Duty-free commodities accounted for \$2,129 million, or just under half the value of U.S. agricultural imports. Duty-free imports are mainly green coffee, tea, cocoa beans, cotton linters, natural rubber, bananas, copra, coconut oil, short-staple wools, hard vegetable fibers, essential oils, crude drugs, and spices. Other duty-free commodities included cattle for breeding purposes, sausage casings, casein, hides and skins other than bovine, raw silk, and miscellaneous crude animal products such as hair, bones, horns, etc., tung oil, edible rootstocks, bread, yeast, and vegetable waxes.

Agreements were recently concluded among 46 countries at the "Kennedy Round" of tariff negotiations in Geneva, Switzerland, under the sponsorship of the General Agreement on Tariffs and Trade (GATT). The average of tariff reductions was about 35 percent on total goods amounting to about \$40 billion in world trade; most of the duty reductions affected industrial goods. In return for concessional reductions, the United States lowered duties on about 370 agricultural items with a total 1966 import value of \$639 million.^{2/} Bindings were imposed on an additional 30 items with a total import value of \$456 million. Reductions will take place for the bulk of items affected in equal steps over a 5-year period beginning in January of 1968.

Among the commodity groups affected by lower duties, certain U.S. tariff schedule codes of the following categories were included: meats, cheeses, vegetables, edible nuts, fruits, chocolate, malt beverages, wines, oriental tobacco leaf, oilseeds, essential oils, hops, bakery products, feathers, bristles, hides, spices, seeds, rough wools, animal hair, and crude drugs. A complete listing of tariff concessions appears in the "Report on United States Negotiations" published by the Office of the Special Representative for Trade Negotiations. Agricultural commodities are included in Volume II of this report, which is available from the Superintendent of Documents, U.S. Government Printing Office, Washington, D. C. 20402.

Quantitative measures governing U.S. agricultural imports are: (1) absolute quotas limiting the quantity of some commodities under Section 22 of the Agricultural Adjustment Act of 1935, as amended, including wheat, cotton, dairy products, and peanuts; under the Sugar Act of 1948, as amended; and under the Philippine Trade Agreement Revision Act of 1955 for raw sugar, hard fibers, tobacco, and coconut oil; (2) tariff quotas under the three aforementioned acts and under trade agreement concessions permitting specified quantities of merchandise to enter at a set rate of duty during a given time period (imports in excess of specified quantities are subject to higher rates); (3) prohibitions against goods from Mainland China, North Korea,

^{2/} For the "Kennedy Round" of trade negotiations, agricultural commodities were defined in a special manner. This definition in some cases deviates from the conventional definition. For example, raw hides and skins, and ale and beer -- included in these statistics -- were defined as industrial goods for the purposes of these tariff negotiations.

North Vietnam, and Cuba; and (4) regulations prohibiting imports of certain live-stock and meats from areas having foot-and-mouth disease or rinderpest present; plant quarantine regulations prohibiting entry of plants or soils carrying harmful insects or diseases; regulations governing the import of eggs and feathers of most wild birds; and health regulations restricting imports of adulterated or mislabeled foods, drugs, and cosmetics.

These quantitative restrictions and tariff quotas are described in detail in U.S. Tariff Commission Publication Number 165, issued in November 1965. Authority to impose absolute quotas on imports of beef, mutton, and goat meat exists under provisions of Public Law 88-482.



U.S. AGRICULTURAL EXPORTS BY DESTINATION, CALENDAR YEARS 1961-66

Over the last 5 years, exports of U.S. farm products increased 37 percent. The value of these exports in 1966 reached a new record of \$6,879 million compared with \$6,229 million in 1965 and \$5,030 million in 1961. Higher commercial farm exports accounted for this increase; commercial sales rose to \$5,318 million in 1966 from \$3,547 million in 1961. Agricultural exports under Government programs rose only slightly to \$1,561 million from \$1,483 million.

U.S. farm exports to all world regions were higher in 1966 than 5 years ago. The gain was most rapid in shipments to Asia and Africa. Exports to Canada and Europe rose less than the overall average, and those to Latin America were up only slightly. Hence, the proportion of U.S. farm exports to Asia over the past 5 years has increased (table 12).

Exports by Commodity

Grains and preparations made up 46 percent of the value of U.S. agricultural exports in 1966, up from 40 percent in 1961. A sharp increase in feed grains to \$1,367 million from \$548 million was mainly responsible for this rise; rice exports more than doubled during this period, and wheat shipments were 18 percent higher (tables 13 and 21).

Exports of oilseeds and oilmeals rose in value 119 percent and 388 percent, respectively, from 1961. Oilseed exports reached \$802 million, of which soybeans made up \$760 million; oilcake and meal sales totaled \$232 million, of which soybean meal comprised \$217 million. EEC countries are the leading destinations for oilcake and meal. The 6 members took 65 percent of the exports by value and Canada 9 percent.

Tobacco exports in 1966 reached a record value of \$431 million, up from \$383 million a year earlier and \$391 million in 1961. Flue-cured leaf was the most important type. Larger shipments to the United Kingdom, West Germany, Sweden, Switzerland, and Ireland accounted for most of the increase.

Raw cotton exports contracted to \$432 million from \$875 million in 1961. Shipments to most markets were lower, especially to the largest ones -- Japan, the EEC, EFTA, and Canada.

Exports of animals and animal products have declined as a proportion of total agricultural exports since 1961. A fall in the value of dairy products and poultry meat, combined with slower growth of fats and oils, contributed most to this decline. Exports of hides, tallow, variety meats, and live animals were all considerably above 1961.

A higher level of exports for fruits, vegetables, edible nuts, mixed feeds, and many other products contributed to the increase in shipments of U.S. farm commodities abroad over the last 5 years.

Exports by Regions

Europe.--European countries continued to be the largest outlet for U.S. farm exports. The value of these exports in 1966 stood at \$2,912 million compared with \$2,301 million 5 years earlier. Three regional trade groupings -- the European Economic Community, the European Free Trade Association, the Committee on Mutual Economic Cooperation -- include 20 countries and accounted for 85 percent of the value of U.S. agricultural exports to Europe in 1966. Such exports to other European countries not members of regional trading organizations also expanded significantly, especially to Spain, Yugoslavia, and Finland. Of the 1966 total, commercial exports to Europe accounted for \$2,706 million; the remaining Government programs were chiefly credit sales (Title IV, P.L. 480) and barter (Title III).

U.S. agricultural exports to the European Economic Community (EEC) reached a high of \$1,564 million in 1966, 35 percent above the 1961 total (table 14). An estimated \$62 million of commodities, chiefly feed corn and soybeans, moved through Canadian ports to EEC countries. Increased exports were reported to all 6 member countries over the period. West Germany and the Netherlands are the principal EEC member purchasers of U.S. farm products. Of the total, \$1,550 million were commercial exports and \$14 million were under Government programs. Government shipments were all under barter programs.

European Free Trade Association (EFTA) countries stepped up purchases of U.S. farm products over the last 5 years. Exports rose to \$777 million in 1966 from \$662 million in 1961 (table 15). An additional \$28 million moved to EFTA countries through Canadian ports in 1966, principally feed corn to the United Kingdom. Government programs in 1966 were barter transactions of just under \$30 million, mostly with the United Kingdom.

Exports to members of the Committee on Mutual Economic Cooperation (Comecon) amounted to nearly \$137 million in 1966, up \$34 million from the year before and \$47 million above the 1961 total (table 16). The 5-year average of \$147 million in 1961-65 was swelled by a high of \$300 million in 1964. Of the 1966 total, \$7 million was under Government programs to Poland; barter made up \$3 million and donations by private agencies \$4 million.

Asia.--U.S. farm exports to Asia amounted to \$2,286 million in 1966 compared with \$1,431 million 5 years earlier. Commercial sales accounted for \$1,351 million of the 1966 total, up from \$785 million in 1961. Japan was the largest Asian buyer, taking \$942 million in 1966, a 70 percent increase over the \$554 million exported in 1961.

In 1966, \$539 million in U.S. farm exports went to India. All of these shipments were under concessional programs, such as foreign currency sales (Title I), donations (Title III), and emergency relief (Title II).

Shipments of farm products to the Republic of Vietnam were up sharply in 1966 to \$143 million from \$75 million a year earlier. In 1966, \$122 million of the total was under Government programs, principally foreign currency sales and emergency relief.

Exports to the Philippines were up to \$76 million in 1966 from \$68 million a year earlier, and equaling the 1961 total. Of the 1966 total, \$66 million were commercial sales, compared with \$48 million in 1961. Most (\$8 million) of the concessional programs in 1966 consisted of barter under Title III, P.L. 480.

Shipments to the Republic of Korea amounted to \$83 million in 1966; Government programs made up \$52 million and commercial exports \$31 million. Exports to South Korea in 1966 were the lowest since 1960.

Exports of farm products to Taiwan in 1966 rose to \$76 million from \$74 million the year before and \$71 million in 1961, but slightly less than the record \$80 million in 1964. Commercial sales in 1966 amounted to \$43 million, compared with \$18 million in 1961.

Sharp increases in exports to other Asian countries were reported for Lebanon (to \$23 million from \$8 million), Israel (to \$85 million from \$54 million), Saudi Arabia (to \$21 million from \$8 million), Burma (to \$23 million from \$1 million), Thailand (to \$23 million from \$15 million), Malaysia and Singapore (to \$17 million from \$12 million).

Canada.--U.S. farm exports to Canada -- including transshipments of grains to other destinations -- amounted to \$626 million in 1966. An estimated \$140 million of the total was wheat, feed grains, and soybeans that moved through Canadian elevators on the St. Lawrence River in transit to other countries (table 17). Canada is a leading market for U.S. fruits, vegetables, soybeans, cotton, soybean meal, hides, and miscellaneous farm products.

Latin America.--Exports of U.S. farm products to Latin American countries totaled \$575 million compared with \$510 million a year earlier and \$491 million in 1961. In 1966, 9 member countries of the Latin American Free Trade Association (LAFTA) took 53 percent of U.S. agricultural shipments to the Latin American area. An increase in exports to Brazil last year resulted in that country becoming the largest Latin American destination for U.S. farm products. Commercial sales of agricultural commodities to Brazil amounted to \$11 million of the \$101 million total in 1966, while in 1961 commercial sales accounted for \$5 million out of \$112 million. Wheat dominated the list of agricultural exports to Brazil.

Mexico was the largest commercial farm sales destination in LAFTA, taking \$72 million of such products in 1966 compared with \$57 million in 1961.

Venezuela, a member of LAFTA only since early 1967, was the largest Latin American destination for commercial U.S. agricultural products in 1966. U.S. farm shipments to Venezuela in 1966 totaled \$82 million against \$76 million in 1965, \$83.5 million in 1964, and \$89.6 million in 1961. Shipments consisted largely of wheat.

The 5 members of the Central American Common Market together took \$42 million of U.S. farm products in 1966 compared with \$28 million in 1961 (table 19). Guatemala is the principal outlet in CACM, with El Salvador second. Exports to all CACM countries are growing, except for those to Costa Rica, which remained stable at \$5.0 million to \$6.0 million.

Oceania.--Exports of U.S. farm products to Oceania were down slightly in 1966 to \$50 million from \$52 million the year before, but well above the 1961 total of \$35 million. Australia is the principal market in Oceania, accounting for \$35 million in 1966 and \$26 million in 1961. Tobacco was the most important single farm commodity exported.



Export Highlights

U.S. AGRICULTURAL EXPORTS: JULY-JUNE 1966/67

U.S. agricultural exports for 1966/67 surpassed the record volume of agricultural exports in 1965/66 by 1 percent, reaching \$6,766 million (table 22). The record level of exports during 1966/67 resulted from greatly expanded shipments of cotton and tobacco and smaller gains in oilseeds and products, and vegetables and preparations. These increases offset the substantial declines in animals and animal products, grains and preparations, and fruits and preparations.

In the August issue of Foreign Agricultural Trade of the United States, agricultural exports for June 1967 were estimated at \$532 million. Actual June exports were \$520 million, about 2 percent below the estimated agricultural exports for June. However, June 1967 exports were 6 percent below those of June 1966. Smaller exports of fruits and vegetables, grains and preparations, and oilseeds and products contributed to this decline. Cotton and tobacco exports were higher in June 1967 than in the preceding June. Poultry and dairy products increased, surpassing those of June 1966 by 29 percent, while exports of hides and skins declined 46 percent. Exports of grains and preparations were down substantially, falling from \$267 million in June 1966 to \$214 million in June 1967. Corn, barley, and oats contributed substantially to this decline. Wheat and wheat flour was also substantially below the level of June 1966. Although sorghum exports have been running higher than the levels set in 1966, those of June 1967 were down 20 percent from June 1966. Rice exports continued at the high levels set during the previous months and exceeded those of June 1966 by \$23 million, or 143 percent. Exports of oilseeds and products were slightly higher than those in June 1966. Soybean exports were 14 percent below those of the year earlier, but increased exports of cottonseed and soybean oil and protein meal nearly offset the decline. Tobacco exports continued at a high level, surpassing those of June 1966 by 40 percent.

Exports of animals and animal products were \$716 million during July-June 1966/67, about 8 percent below the \$779 million of 1965/66. Exports in dairy products accounted for most of the decline and for 1966/67 were nearly one-third lower than a year earlier. Smaller exports of nonfat dry milk accounted for this decline. During 1966/67, exports of nonfat dry milk totaled 372 million pounds, compared with 738 million pounds in 1965/66.

Shipments of fats, oils and greases, and poultry products were also below those of a year earlier. Exports of fats, oils, and greases for 1966/67 totaled 2,347 million pounds, up 7 percent from those of 1965/66. However, due to the lower prices, value was down \$12 million from \$203 million in 1965/66. Poultry product exports in 1966/67 were 12 percent lower than those of the previous year. Smaller exports of fresh and frozen chickens and turkeys accounted for much of this decline. Increased competition in the world poultry market brought on by increased production -- especially in Western Europe -- has resulted in a reduction in U.S. exports of poultry products. Exports of hides and skins reached 20.3 million units in 1966/67, 5 percent higher than the previous record of 19.3 million units in 1965/66.

Cotton exports rose sharply to meet the record high demand in foreign Free World countries and to help replenish foreign stocks. Cotton exports declined substantially from 5.1 million bales in 1963/64 to 3.1 million bales in 1965/66, but rose 50 percent this past fiscal year to 4.6 million bales. Due to the lower unit price, the value of cotton exports for the year was 41 percent higher than in the previous year. The 5 largest markets -- Japan, Taiwan, Republic of Korea, Canada, and Italy -- received over half of the U.S. cotton exports.

U.S. exports of fruits and vegetables in 1966/67 were slightly below those of the previous year. Combined, their value was \$492 million, 1 percent below that of 1965/66. This decline was attributed to exports of fruits and preparations. They slipped 2 percent to \$320 million in 1966/67 from \$327 million the year earlier. However, lower prices were the primary factor in this decline. For instance, canned fruit increased in quantity but the value of exports was slightly below that of 1965/66. The quantity of fruit cocktail exports was up 14 percent, but the value only increased 4 percent. Fresh fruits -- grapes, lemons, and limes -- were down 3 percent from 1965/66 in quantity but, due to higher unit values, their total export value was up 6 percent. Such factors as larger production in other countries affected available markets for our exports of fruits and preparations. Italy reported a record pear and apple crop while larger supplies of citrus were available from South Africa, Australia, and Brazil.

Exports of vegetables and preparations were \$172 million, about 1 percent higher than those of the previous year. Canned vegetables and fresh vegetables were down. However, substantial increases in exports of dried beans and peas were more than sufficient to offset the declines and resulted in the overall increase. Dried beans were up 31 percent, and dried peas increased by 11 percent.

Exports of grains and preparations moved at a higher volume during the earlier months of 1967; but in the last half of the year, reduced exports reflected the shrinking supplies in the United States and the abundance of grains available for export in other producing countries. Corn exports for July-June 1967 dropped substantially. Exports of barley declined 42 percent from \$94 million in 1965/66, while oats declined 53 percent from \$27 million in 1965/66.

The value of oilseeds and products exported by the United States was about 2 percent higher in 1966/67 than the value of the previous year's exports, but the quantity was down. Soybeans declined 4 percent to 247 million bushels in 1966/67. Exports of protein meal, which totaled 2.7 million short tons in 1966/67, were 5 percent below those of 1965/66.

U.S. exports of unmanufactured tobacco rose 39 percent above those of fiscal 1965/66. The sharp increase that occurred last year resulted partly from the United Nations sanctions against Rhodesian tobacco, and partly from increased demand for the improved quality and quantity of flue-cured varieties produced in the United States. In addition, tobacco exports under Government programs were higher.

Explanatory Note

U.S. foreign agricultural trade statistics in this report include official U.S. data based on compilations of the Bureau of the Census. Agricultural commodities consist of (1) nonmarine food products and (2) other products of agriculture which have not passed through complex processes of manufacture such as raw hides and skins, fats and oils, and wine. Such manufactured products as textiles, leather, boots and shoes, cigarettes, naval stores, forestry products, and distilled alcoholic beverages are not considered agricultural.

The trade statistics exclude shipments between the 50 States and Puerto Rico, between the 50 States and the island possessions, between Puerto Rico and the island possessions, among the island possessions, and intransit through the United States from one foreign country to another when documented as such through U.S. Customs.

EXPORTS The export statistics also exclude shipments to the U.S. armed forces for their own use and supplies for vessels and planes engaged in foreign trade. Data on shipments valued at less than \$100 are not compiled by commodity and are excluded from agricultural statistics but are reflected in nonagricultural and overall export totals in this report. The agricultural export statistics include shipments under P.L. 87-195 (Act for International Development), principally sales for foreign currency; under P.L. 83-480 (Agricultural Trade Development and Assistance Act), and related laws; and involving Government payments to exporters. (USDA payments are excluded from the export value.) Separate statistics on Government program exports are compiled by USDA from data obtained from operating agencies.

The export value, the value at the port of exportation, is based on the selling price (or cost if not sold) and includes inland freight, insurance, and other charges to the port. The country of destination is the country of ultimate destination or where the commodities are to be consumed, further processed, or manufactured. When the shipper does not know the ultimate destination, the shipments are credited to the last country, as known to him at time of shipment from the United States, to which the commodities are to be shipped in their present form. Except for Canada, export shipments valued \$100-\$499 are included on the basis of sampling estimates; shipments to Canada valued \$100-\$1,999 are sampled.

IMPORTS Imports for consumption consist of commodities released from U.S. Customs custody upon arrival, or entered into bonded manufacturing warehouse, or withdrawn from bonded storage warehouse for consumption. The agricultural statistics exclude low-value shipments from countries not identified because of illegible reporting, but they are reflected in nonagricultural and overall import totals in this report.

The import value, defined generally as the market value in the foreign country, excludes import duties, ocean freight, and marine insurance. The country of origin is defined as the country where the commodities were grown or processed. Where the country of origin is not known, the imports are credited to the country of shipment.

Imports similar to agricultural commodities produced commercially in the United States and others that are interchangeable in use to any significant extent with such U.S. commodities are supplementary, or partly competitive. All other commodities are complementary, or noncompetitive.

Further explanatory material on foreign trade statistics and compilation procedures of the Bureau of the Census is contained in the publications of that agency.
