Ecological engineering has been defined as the design of ecosystems for the mutual benefit of humans and nature. Applications of ecological engineering (or ecotechnology) include wetland creation and restoration, pollution control by ecosystems, restoration and rehabilitation of forests, grasslands, lakes, reservoirs and rivers, and the development of sustainable agro-ecosystems. Based on the conservation of both renewable and non-renewable resources, the field of ecological engineering is of relevance to those involved in global change, alternative energy policies, ecological economics, environmental conservation, and global geopolitics.

Scheduled for quarterly publication commencing in 1992, *Ecological Engineering* will be of invaluable interest to applied ecologists, environmental scientists, managers and regulators, natural resource specialists (e.g. foresters, fish and wildlife experts), environmental and civil engineers, agroecologists, landscape planners and designers. It will appeal to ecologists involved in the designing, monitoring and construction of ecosystems, and engineers who have been trained or have subsequently gained experience in the biological/ecological sciences and who are now concerned with designing and building ecosystems. Practising environmental managers will also find the journal of particular interest.

Specific topics to be covered in *Ecological Engineering* include: ecotechnology; synthetic ecology;



bioengineering; sustainable agroecology; habitat reconstruction; restoration ecology; ecosystem conservation and rehabilitation; biomanipulation; stream and river restoration; wetland restoration and construction; reclamation ecology; non-renewable resource conservation.

Ecological Engineering will welcome full papers, short communications, comments, letters to the Editor, and will publish review articles upon invitation.

Papers, published in the English language, will be subject to peer review and will be dealt with as rapidly as possible, whilst still maintaining a high standard of presentation. There will be no page charges and the senior author of each contribution will receive fifty free reprints.
