A Statement from Joachim von Braun

Chair, Program Committee

IAAE's Purpose

The IAAE is the worldwide association of agricultural economists, and others concerned with agricultural economic problems, organized to:

- foster the application of agricultural economics to improve rural economic and social conditions;
- advance knowledge of agriculture's economic organization; and
- facilitate communication and information exchange among those concerned with rural welfare

IAAE was founded in 1929 and has about 1800 members from 90 countries.

Renewed Attention to Food and Agricultural Economics and Toward a Broader Agenda

The conference takes place in the context of renewed attention to food and agriculture issues by policymakers, and the general public. This growing attention has different reasons, say in rich and poor countries, in rapidly growing economies, and in economies contracting under economic transformation. However, there has never been a larger potential benefit to learn from different regional experiences with food and agriculture than in the rapidly globalizing world food economy of today. At the same time, the applicability and limitations of past theories, concepts, and methods require our renewed attention as agricultural economic researchers. The agenda we have to cover is broadening from "Agriculture" toward "Food Security, Diversification, and Resource Management." The XXIII IAAE Conference in Sacramento is the academic world forum for the economic aspects of this agenda.

IAAE Research and Policy Issues Addressed in the XXIII International Conference

The XXIII Conference addresses a set of important inter-related research and policy issues challenging world agriculture well into the next century.

- World food demand is projected to double in the next thirty years.
- There are challenges for sustaining the natural resource base while meeting future food demands.
- Land and water scarcity in many regions call for efficient institutional arrangements.
- Changing diets in rapidly developing countries increase demand for a broader range of food choices.
- Increasing market segmentation in response to new demand requires renewed attention to demand analysis.
- Rapid urbanization requires consideration of rural-urban linkages.
- Rapid changes in technology, both biological and informational, present new opportunities for managing agricultural production and marketing.
- Evolving agricultural policies create a need for new institutional arrangements at local, national, and international levels.
- Market policy changes require attention to new concepts, program design, and approaches to policy analysis.
- Increasing off-farm activity, providing production inputs, and adding value to agricultural products will continue to broaden what has traditionally been referred to as agriculture.
- Rapid communications and world economic linkages create new dynamics in agriculture that are increasingly complex to analyze.

Thanks to Colleagues and Donors

IAAE is broadly based in our profession. At the beginning of 1997, there are about 150 colleagues in many different countries committing considerable time and effort on organizational and review matters to make this conference a professional success for all participants. IAAE's functioning largely depends upon professional cooperation. The service to our profession by the local organizing committee, the plenary and panel session organizers, the contributed paper, the poster/computer session, and discussion group organizers and their review teams spread over the world is greatly acknowledged.

A number of countries and organizations have contributed funds to assist us in bringing colleagues from low-income countries and transforming economies, unable to obtain funding from other sources, to the conference. We gratefully acknowledge the related support of Denmark, Japan, Germany, United Kingdom, Switzerland, Ford Foundation, Rockefeller Foundation, and possible others to join the growing group of IAAE donors.

Overview of Conference Structure

The international community of agricultural economists will actually shape the conference content through Plenary Sessions, Invited Panel Discussions, Contributed Paper Sessions, Poster and Computer Sessions and Discussion Groups/Minisymposia.

Plenary Sessions

There will be four plenary sessions with three presentations each. Each plenary session will consist of a team of leading agricultural economists from various regions of the world including chairperson, three paper presenters, and discussion openers.

Invited Panel Discussions

The panels are mostly related to aspects of the conference theme. They are mechanisms to provide opportunity for more discussion, especially with users of agricultural economics research findings, include room for methodological focus (in a few panels), and provide a means to focus the themes of the conference on main developing country regions.

Contributed Paper Sessions

These are papers addressing any agricultural economics these. On four conference days, there will be eight contributed paper time slots, with four concurrent sessions each. The number of appears in each session is expected to be three or four. The Contributed Paper Sessions are organized by Peter Hazell and will be refereed by an international panel of subject matter experts using a blind review process. A total of about 100 contributed papers will be selected for presentation at the conference, more than twice as many as previously.

Poster and Computer Sessions

Poster sessions are redesigned to substantially upgrade their role in the conference. These sessions are scheduled in prime time to create a marketplace for exchange of ideas and research findings. Computer-based presentations and relevant software information will be a new feature, supplementing the poster presentations. The Post and Computer sessions are organized by Arie Oskam.

Discussion Groups/Minisymposia

The highly stimulating discussion groups and minisymposia facilitate professional exchange as well as friendship among members. The discussion Group/Minisymposia sessions are organized by Larry Sivers.

Procedure for Selecting Blue Book and Special Issue Manuscripts

Our decision on publication of the contributed papers from the 23rd International Conference were guided by the following process:

- 1. Screening by the Contributed Papers Selection Committee headed by Peter Hazell. Over three hundred papers were submitted. One hundred eleven of the submitted papers were selected for presentation at the IAAE Conference, and 72 of the 111 papers were identified for further review for possible publication.
- 2. The 72 papers identified for possible publication were then blind reviewed under the auspices of the Editorial Board of Agricultural Economics.
- 3. Written comments were received from the discussants of the contributed papers at the IAAE meetings.
- 4. At the 23rd International Conference in Sacramento, California, Peter Hazell, George Peters, and Stanley Johnson selected a final set of 45 contributed papers. Twenty-two papers were selected to be published in the Conference Blue Book, edited by George Peters. Twenty-three papers were chosen for publication in the Special Issue of the Journal, which is to be guest edited by Peter Hazell.
