## Will Martin



Will Martin is Research Manager, Agriculture and Rural Development, in the Development Research Group of the World Bank. He has published widely on agricultural trade policy and developing countries, with a particular focus on the World Trade Organization (WTO) and economic development. He has made extensive use of quantitative models such as the Global Trade Analysis Project (GTAP) and has a particular interest in using detailed data to build up a complete picture of the welfare impacts of policies at the national and household levels. He has been a member of the GTAP Advisory Board since its inception in 1994, and in 1997 was awarded the Alan A. Powell Award in recognition of his outstanding contributions to GTAP. Will has published fifteen books and edited volumes, more than forty chapters in edited volumes and more than seventy papers in refereed journals.

Will spent his formative years on a dairy farm at Biddaddaba, near Beaudesert, in south-east Queensland. He obtained an honours degree in agricultural sciences from the University of Queensland in 1974 before taking up a position as Research Officer at the Bureau of Agricultural Economics (BAE) in Canberra in 1975. He successfully combined paid employment with study and received an honours degree in economics from the Australian National University (ANU) in 1979. He commenced postgraduate study at Iowa State University in 1979 and was subsequently awarded his MS (Agr Econ) in 1981 and his PhD in 1982. Will returned to the BAE in 1982 where he spent the next several years applying his especially strong skills in econometrics, agricultural production, finance and policy. In 1988, he left the BAE to take up the position of Senior Research Fellow in the National Centre for

Development Studies at the ANU. In 1991, he commenced a long career with the World Bank, initially as an economist in the International Economics Department, then as Lead Economist, Trade, in the Development Research Group.

Will's areas of expertise include agriculture, textiles and apparel, and nonagricultural trade policy, with a special focus on East Asia. In a series of recent studies, he has examined the implications of the growth of China and India for other regions, and particularly for other developing countries. Recent studies have examined the implications of high food prices and of agricultural productivity growth for poverty in developing countries. His work has been widely cited in major news media, including the Economist and the Financial Times. In 2006, his book with Kym Anderson on the Doha Agenda received a Quality of Communication Award from the American Agricultural Economics Association (AAEA), and in the same year, he received the Quality of Research Discovery Award from AARES. He is ranked in the top 5% of economics authors by Research Papers in Economics (RePEc) and is frequently invited to give plenary lectures at major international meetings, most recently the triennial meetings of the International Association of Agricultural Economists (IAAE) and the European Association of Agricultural Economists (EAAE).
