This book is the sixth in the IAAE *Occasional Paper* series. It contains the 45 contributed papers—together with the discussion opening and summary of the general discussion—presented at the Twenty-First International Conference of Agricultural Economists, Tokyo, Japan, 22–29 August 1991. A companion publication—*Sustainable Agricultural Development: The Role of International Cooperation*—contains the invited papers presented at the conference, and also appears under the imprint of Dartmouth Publishing Company.
