#### The Drought in Context

Genesis of on-going Federal coordination begins with the 2012 Drought:

- USDA: disaster designations for 2,245 counties.
- U.S. SBA: disaster designations for 2,331 counties.
- 2012 drought coverage peaked at 65.45 percent of the continental U.S. on September 25.
- Peak coverage of moderate to extreme drought greatest since 1930s.

#### Drought as an Administration Priority

#### White House Rural Council (WHRC):

- August 2012: President convenes the WHRC.
- Directs Federal agencies to take an "all hands on deck" approach to support State, Tribal, and local partner efforts to mitigate the impact of drought.
- Application of the National Disaster Recovery Framework (NDRF) to coordinate the response.

### Application of the NDRF & Transition to National Drought Resilience Partnership (NDRP)

- Activation for the 2012-2013 Nation-wide drought demonstrated the usefulness and flexibility of the NDRF applied to Non-Stafford Act events.
- FEMA aided USDA in applying NDRF principles, engaging affected stakeholders in drought stricken states.
- President's Climate Action Plan was released in June 2013. NDRP announced later that year.







#### NDRP Purpose

- Emphasizes long-term drought resilience.
- Works collaboratively with states, tribes and local communities, supporting their efforts.
- Deliverables:
  - Single Federal point of contact for drought.
  - Support a Soil Moisture Network.
  - Host regional forums.
  - Create online tools to access Federal resources.
  - Create Demonstration Projects.



#### NDRP Activities in California

- President visited California in February 2014, Federal agencies committed \$200M for a range of drought-resilience building activities.
- Real time coordination with the White House, Federal agencies and California State Agencies through what began as weekly coordination calls with the California Governor's office.
- November 2014 meetings in Sacramento to define the parameters of proposed demonstration project in the near term.
- Enhanced coordination towards development of the Drought Contingency Plan.

#### Federal Support to California and Beyond

The NDRP tracks and coordinates multiple initiatives in California and other drought impacted areas of the Nation. Highlights in California include:

- NOAA: Real-time weather and Hydrologic Information.
- USDA: NRCS EQIP, \$25 million in California for conservation assistance.
- DOI: \$50 million in funds available immediately for drought relief projects throughout the West including nearly \$20 million for California's Central Valley Project.
- EPA: Tools and technical assistance to local and tribal governments to respond to the impacts of drought.
