SOME IMPLICATIONS OF GROWTH IN THE MINERAL SECTOR: ERRATA

D. Frearson of the Western Australian Institute of Technology has drawn my attention to some corrections that need to be made to the text of my article, 'Some implications of the growth of the mineral sector', Vol. 20, No. 2.

1. Equations (4) and (5) in Appendix 1 (p. 90) should be written as:

$$(4) \quad y = 0.25(1+z+y^*)$$

$$(5) \quad \frac{y^*}{y} = \frac{wc}{0.25(1+z+wc)}$$

2. The elasticities of the mineral export supply curve, included for expositional purposes only in Table 4, p. 87, should read:
(0.75), (1.51), (4.43), (0.83), (3.33), (6.66), (0.53), (2.13),
(5.03).

Calculations and points of analysis are not affected by these changes.
