Teaching cases will be considered. Issues on special topics may be published based on requests or on the editor's initiative. Potential usefulness to a broad range of agricultural and business economists is an important criterion for publication.

The Journal of Food Distribution Research is a publication of the Food Distribution Research Society, Inc. (FDRS). The JFDR is published three times a year (March, July, and November). The JFDR is a refereed Journal in its July and November Issues. A third, non-refereed issue contains papers presented at FDRS' annual conference and Research Reports and Research Updates presented at the conference.
