WTO domestic support in agriculture


- Not through border measures
 - Some DS subject to limits
 - Other DS <u>exempt</u> from limits
 - » Green box, blue box, some input & investment subsidies
- AMS = MPS + Payments
 - Aggregate Measurement of Support
 - = WTO Market Price Support + Non-exempt payments +
 - + Revenue forgone

- WTO MPS
 - Administered price
 - Fixed external reference price FERP
 - "Eligible production"
- Different from economic MPS

WTO limits and dispute


- China: Limit on each product's AMS
 - 8.5% of product's value of production in each year
- US claims:
 - AMSs for wheat, corn and rice exceeded ...
 - ... limits in 2012, 2013, 2014, 2015
- WTO dispute settlement
 - Dispute initiated in September 2016
 - Process now underway to establish a Panel
 - » Can take a year or more to settle
 - One of very few agriculture domestic support disputes

Support <u>prices</u> were raised, <u>production</u> grew and grain <u>imports</u> increased

But corn and wheat imports <u>from the US</u> <u>dropped</u> drastically in recent years

Possible issues to be resolved

- Guessing at issues no info in US documentation so far
 - What is "eligible production" in WTO MPS?
 - » Total production as in economic MPS
 - » Total production in states where support prices apply
 - » Some implied limit on how much is to be procured
 - » Actual procurement quantity
 - Adjust reference price from milled to unmilled rice?
 - » Domestic support price is for unmilled rice
 - Other issues?
- Resolve by interpreting Agreement on Agr, not economics
 - E.g, "taking into account" or "in accordance with"
 - » Some guidance from *Korea-Beef* on eligible production

Stakes are high

- US says excess MPS in 2015 nearly \$100 billion
- Implications
 - Many countries with price support
 - » Will more of them be in danger of being challenged?
 - » Doha domestic support revival?
 - "Public stockholding" negotiations (i.e., stock acquisition)
 - » Stronger push to shelter excess MPS from legal challenge?
 - Legal or economic meaning of "eligible production"
 - » Affirmation of narrow legal reading?
 - => Erode WTO power to curb trade-distorting support
