INTRODUCTION

Data contained in this handbook rank the value and economic impact of agricultural production during 1981 through 1983 in Texas, and from major production regions within the state as defined by Texas A&M University as Texas Agricultural Extension Service (TAEX) Districts. The state is subdivided into the following TAEX districts.

The relative importance of the several commodities within regions is one important element in economic development and is useful in establishing policies by this University on such items as research and extension directions, and staffing at regional centers. Commodity groups will find the documentation of economic importance and relative rank of their specific commodity useful

in formulating policy or position statements.

Estimates of cash receipts by commodities for each region were obtained from Dr. Carl Anderson, TAMU Extension Economist in charge of the TAEX county income projections.

The multipliers used in this handbook were derived from the input-output coefficients, by Wright, et.al., in "Texas Input-Output Model, 1979", L-189, Texas Department of Water Resources, Austin, Texas.<sup>1/</sup> Additional research conducted by the authors also supported development of these coefficients.

Production multipliers as presented in this report are estimates of the total change in the value of production in the Texas economy that results from a change in the value of production in an agricultural sector. For example, the wheat sector production multiplier for Texas of 2.93 indicates that a \$1.00 change in production of wheat stimulates a total change in economic output of \$2.93 within the Texas economy (Table 1). Other State multipliers are interpreted similarly.

Also included in the following tables are estimates of the impacts of agricultural production on the State's personal income and employment. For example, it is estimated that the cow-calf and stocker sector leads all other sectors in its value of production and impact on the Texas economy. The value of the Texas cow-calf and stocker production averaged just over \$2.3 billion during 1981-1983. This production creates (directly and indirectly) over \$2 billion of personal income (Table 2) and supports a total of 133,479 man-years of employment (Table 3). This income and employment includes both that directly within the cow-calf and stocker ranches and that portion in supporting sectors such as feed and fertilizer, agricultural input services,

and marketing services that is necessary to support the cow-calf and stocker sector. Hence, production of agricultural products requires production, either directly or indirectly, from virtually all other sectors of the regional and state economy. Production multipliers within regions also indicate the impact of commodity production within a specific region upon the Texas economy. Hence, the total production, income and employment impacts shown may not all be included within the region as interregional trade occurs throughout the state.

The data are presented in both graphic and tabular form. Three-year averages of agricultural commodity prices and output values were used in all calculations of impacts. These three-year averages should provide estimates that are useful for longer range planning since some of the annual price variation is removed.

The overall production multiplier for the output of Texas agriculture was 3.12 and compares very favorably with those of other major sectors in the Texas economy. In total, the three-year average of \$9.8 billion of agricultural production generated annual impact of our \$30 billion of production in the state's economy, almost \$7 billion in personal income and over 615 thousand man-years of employment.

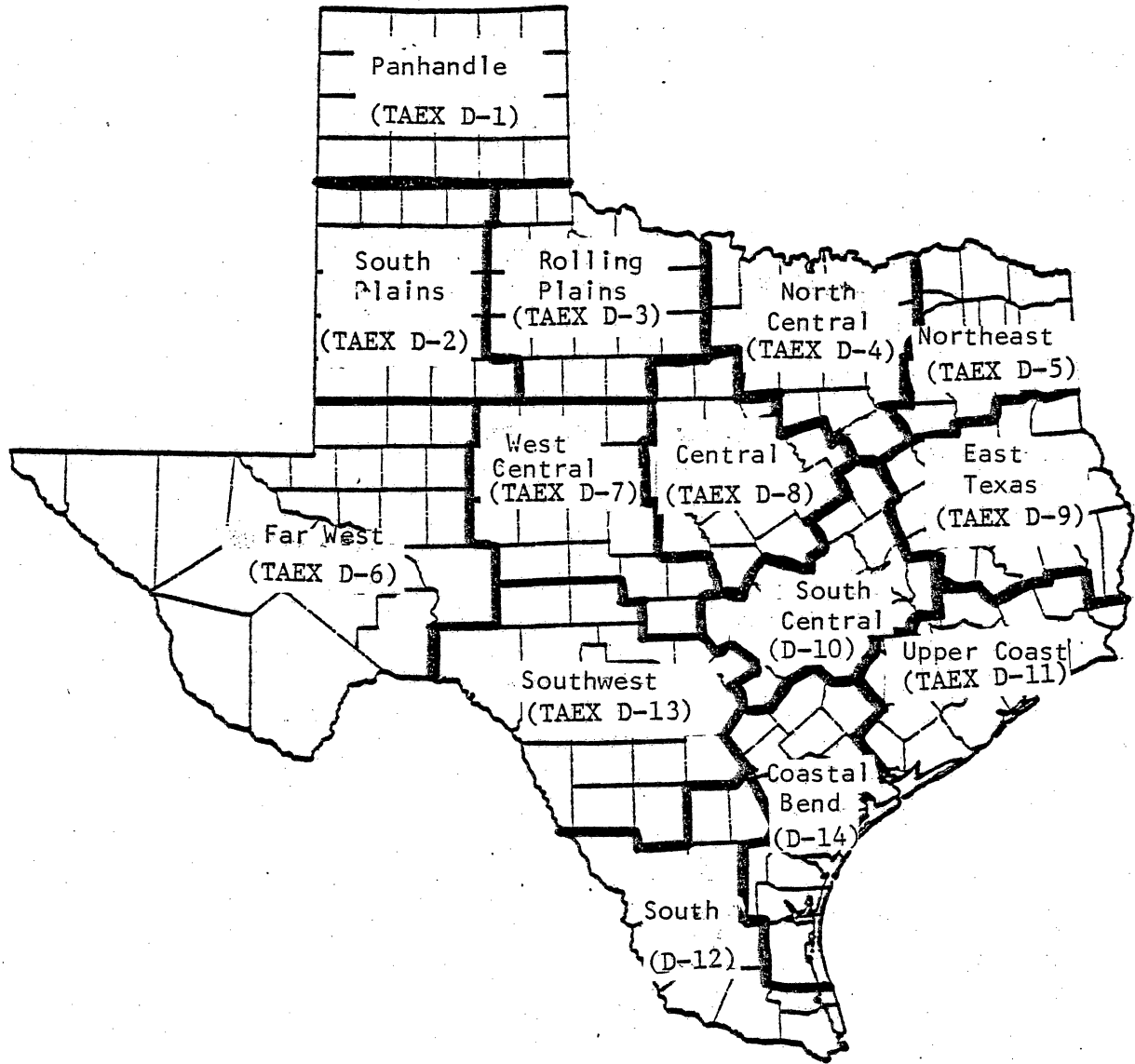

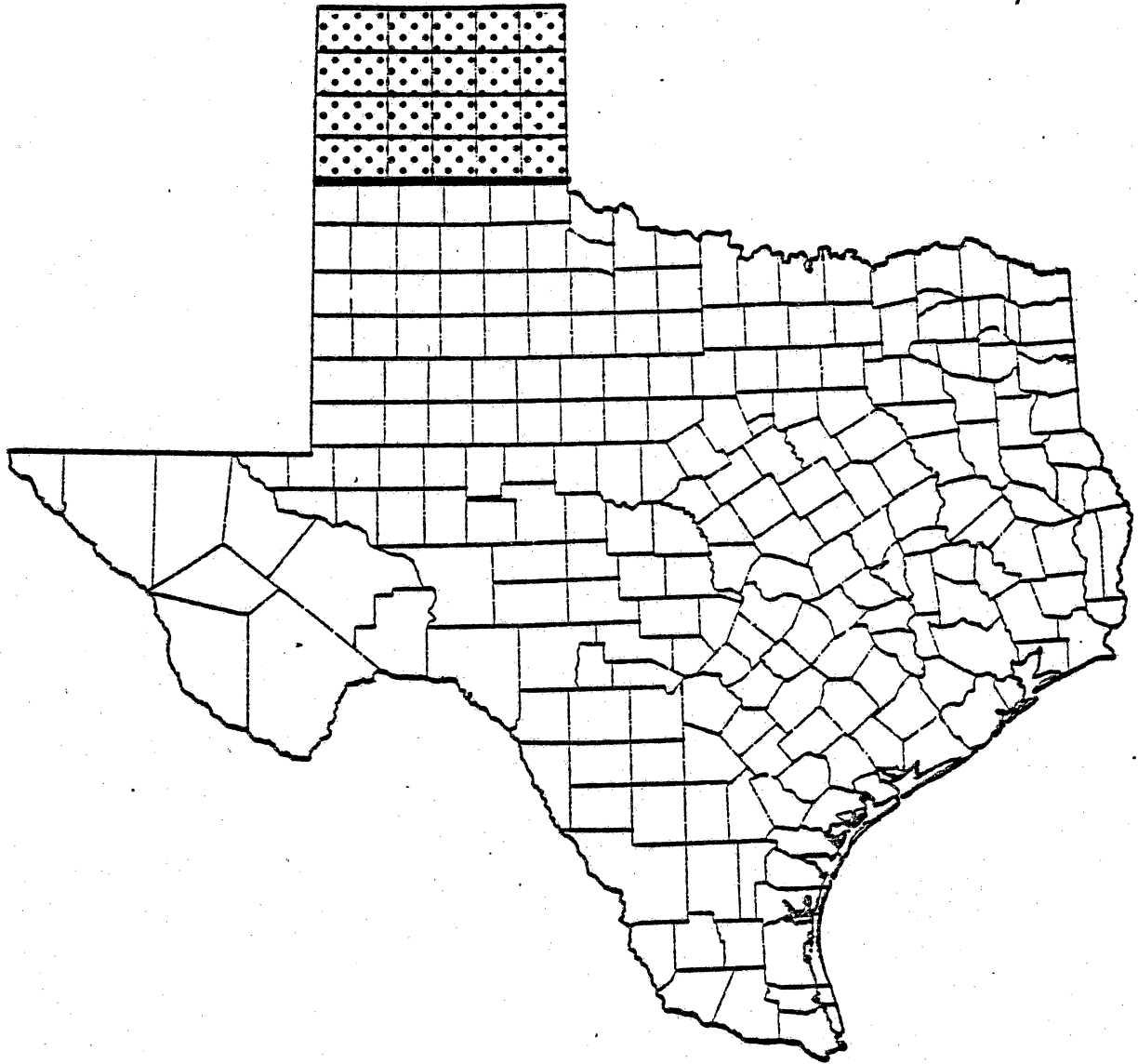

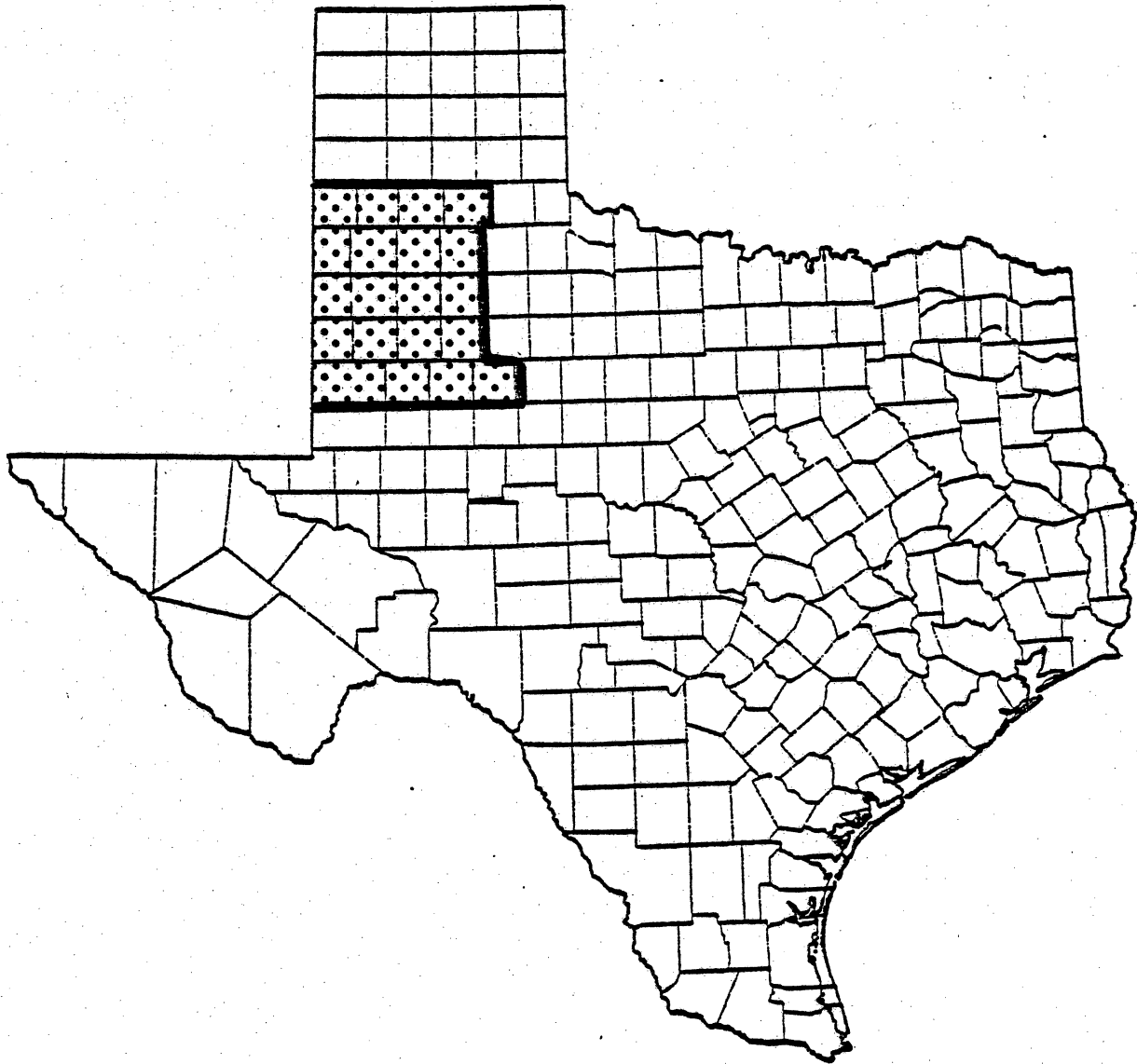

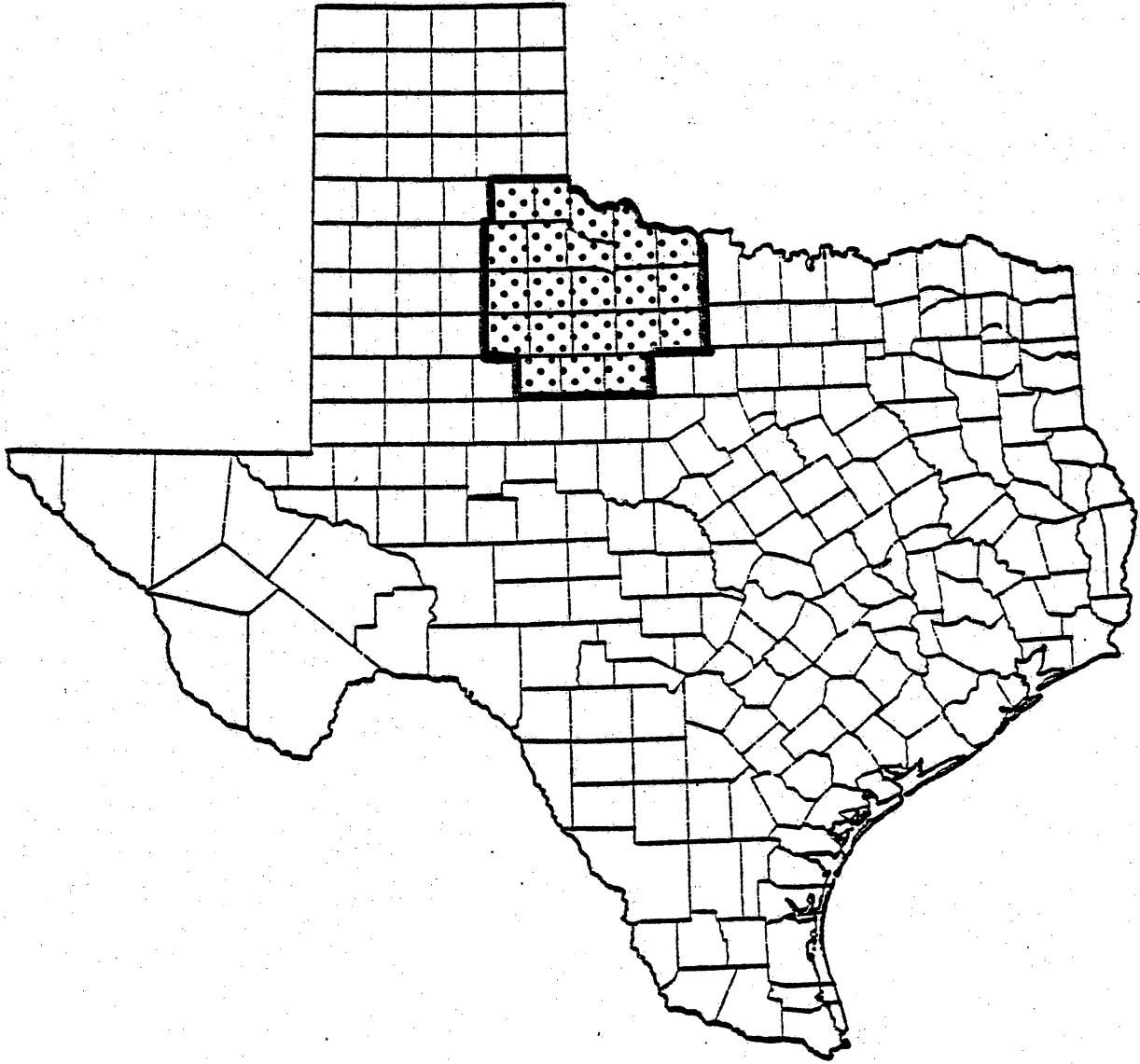

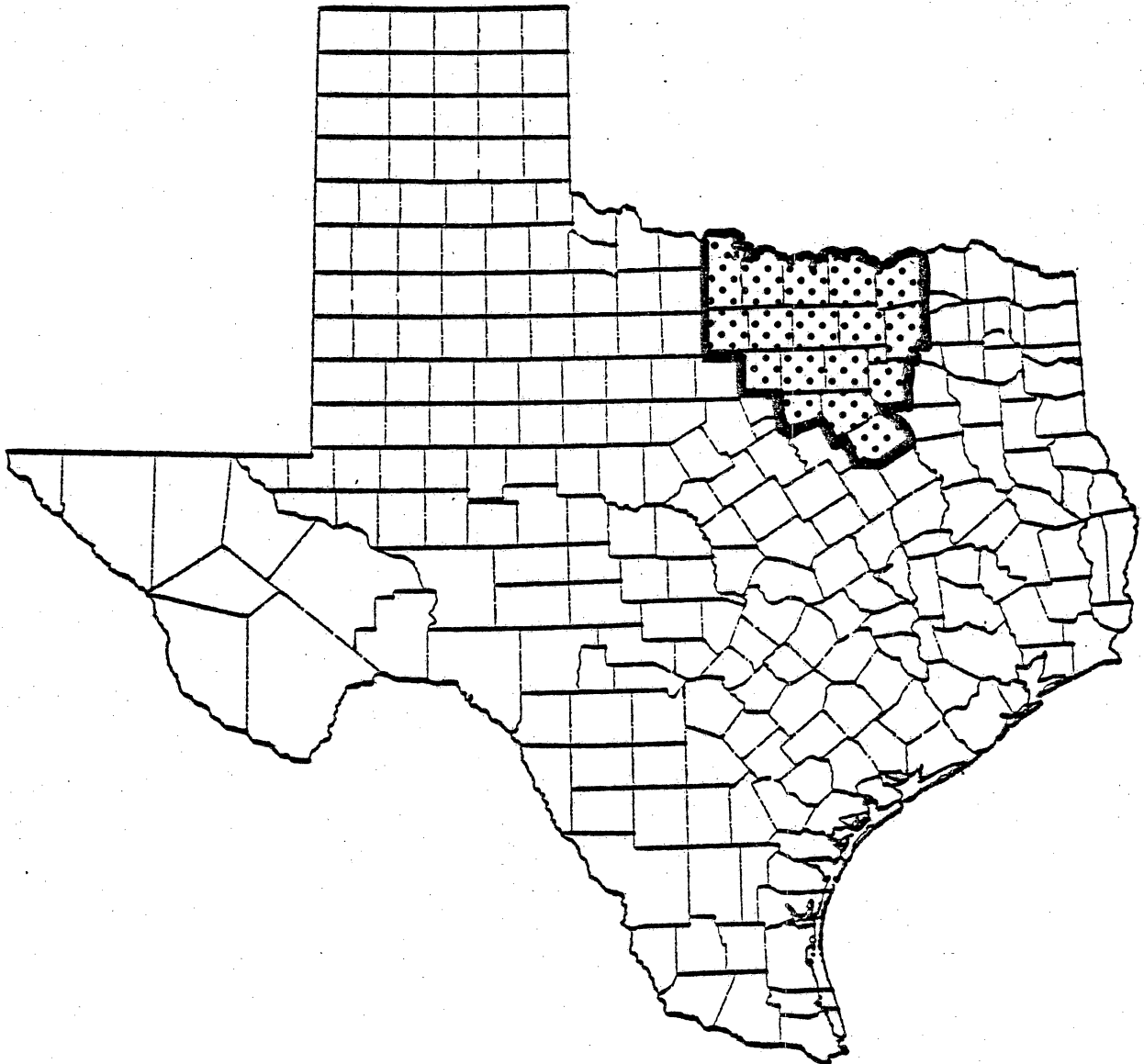

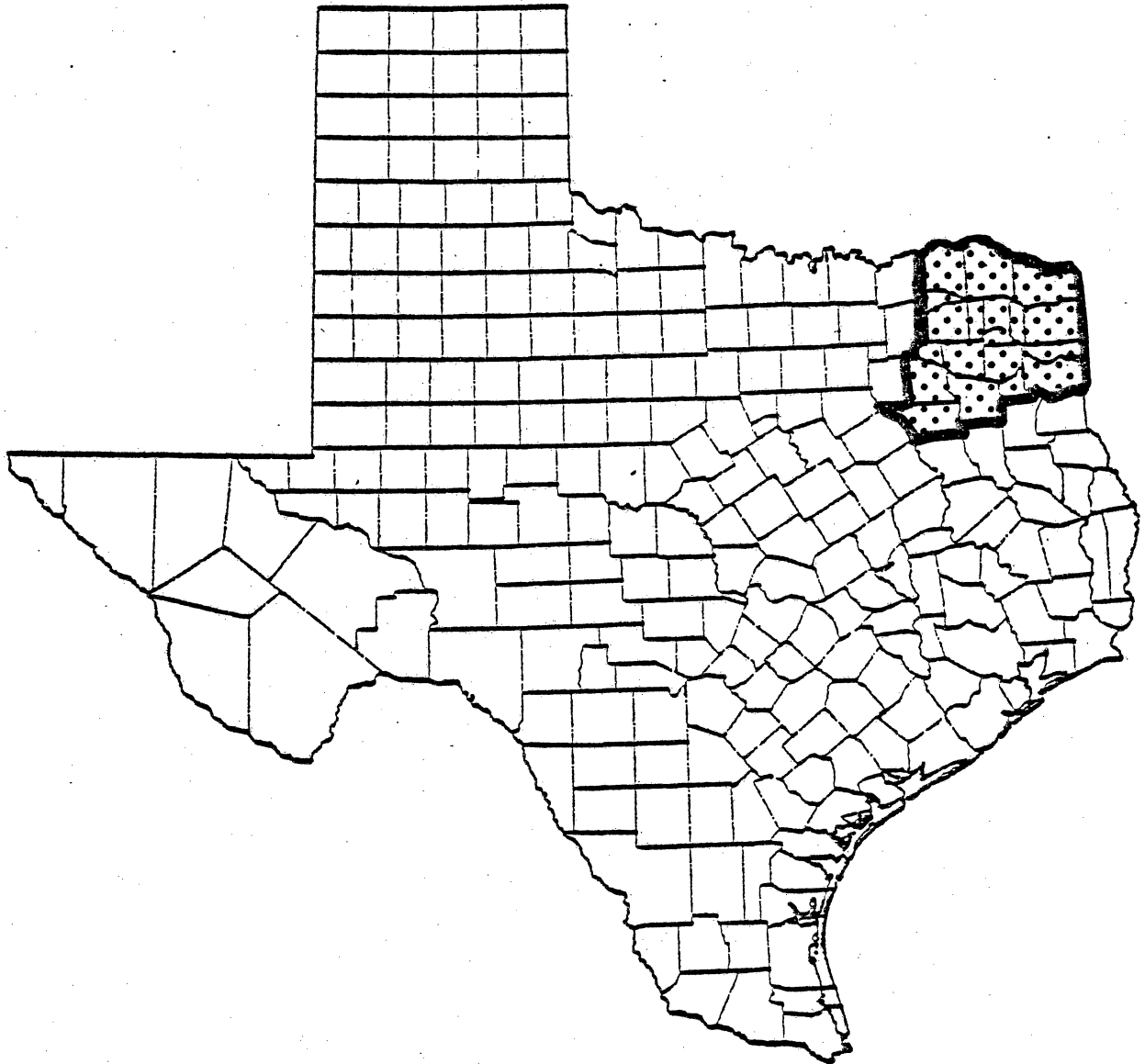

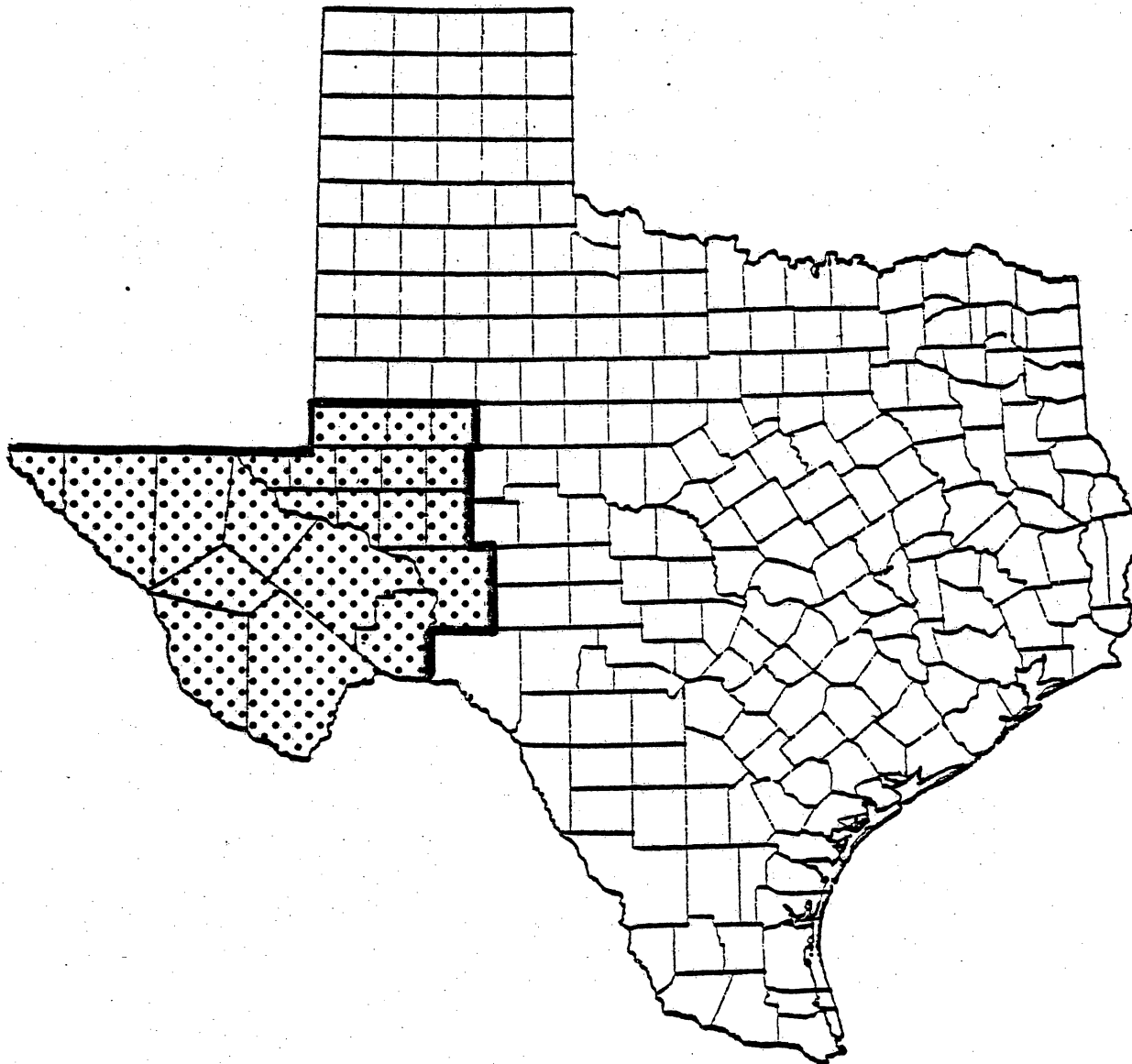

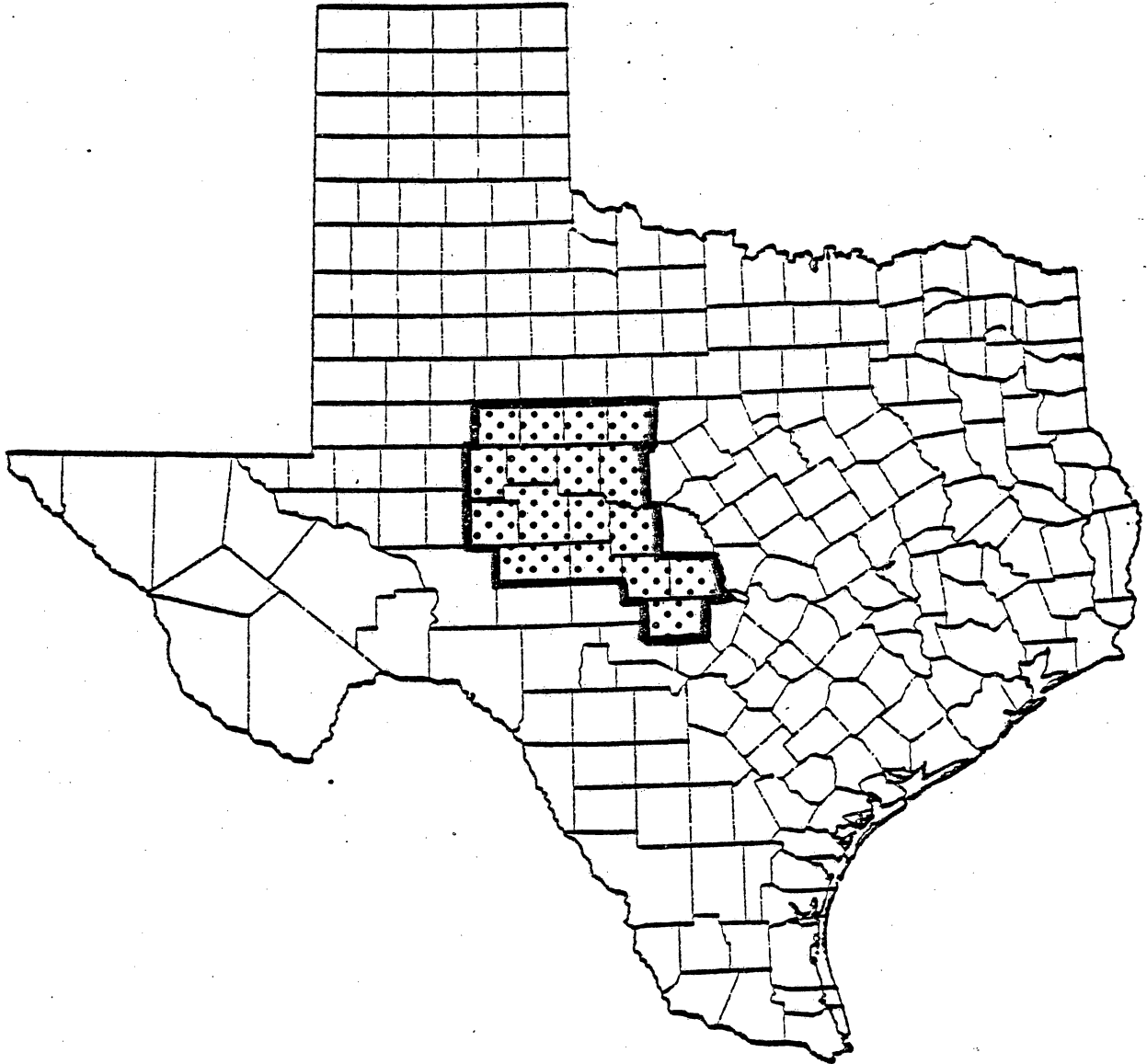

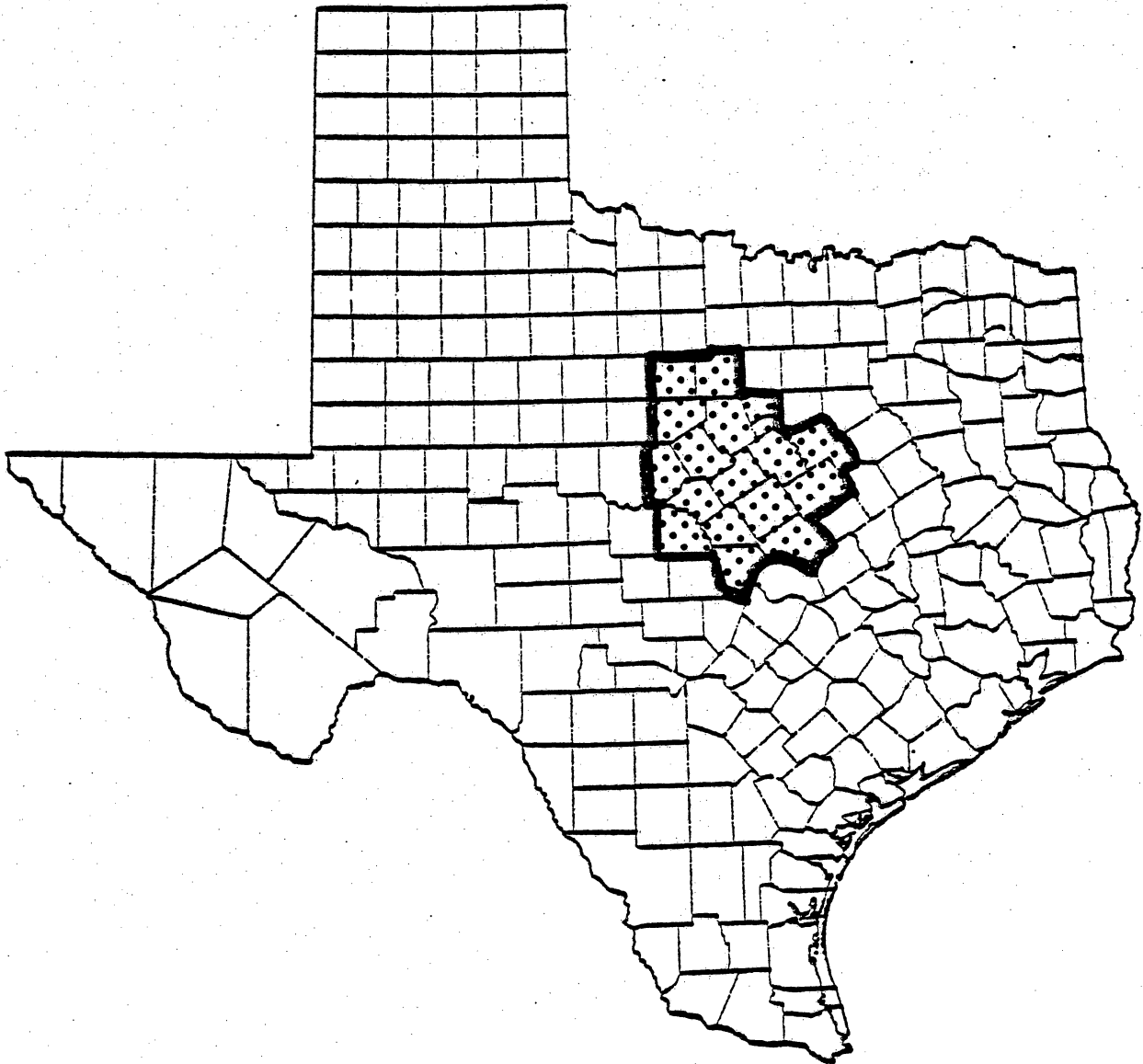

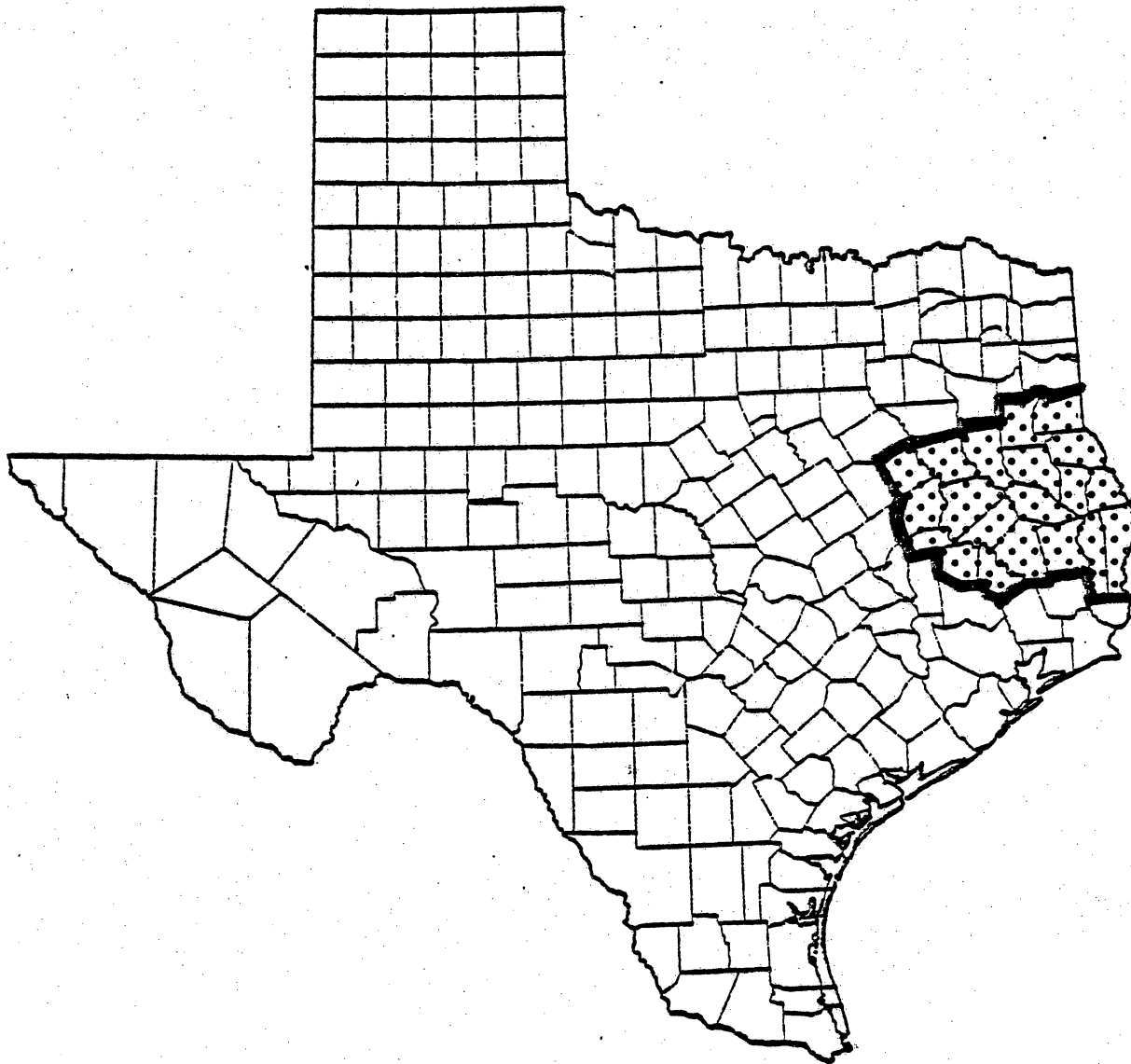

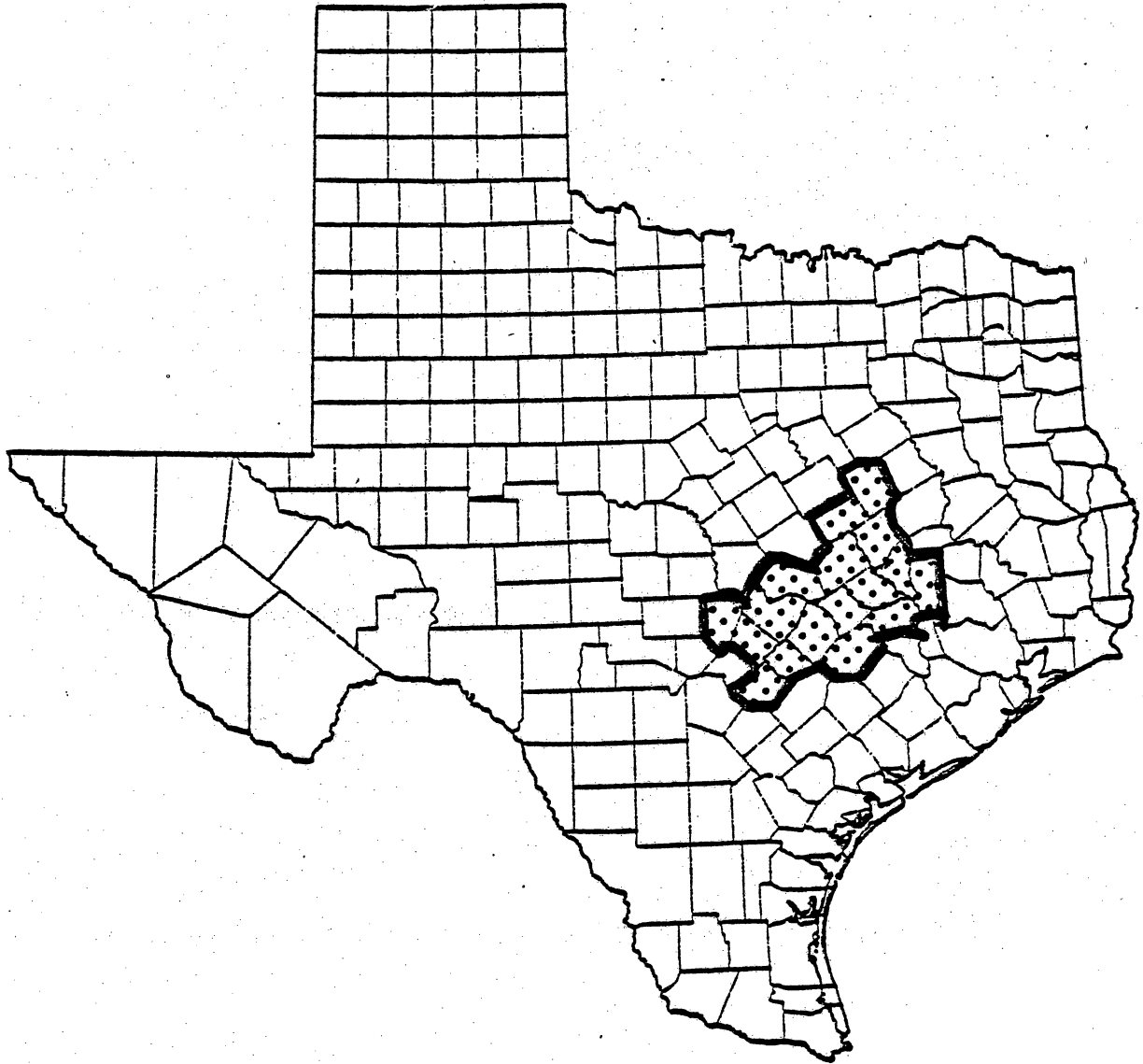

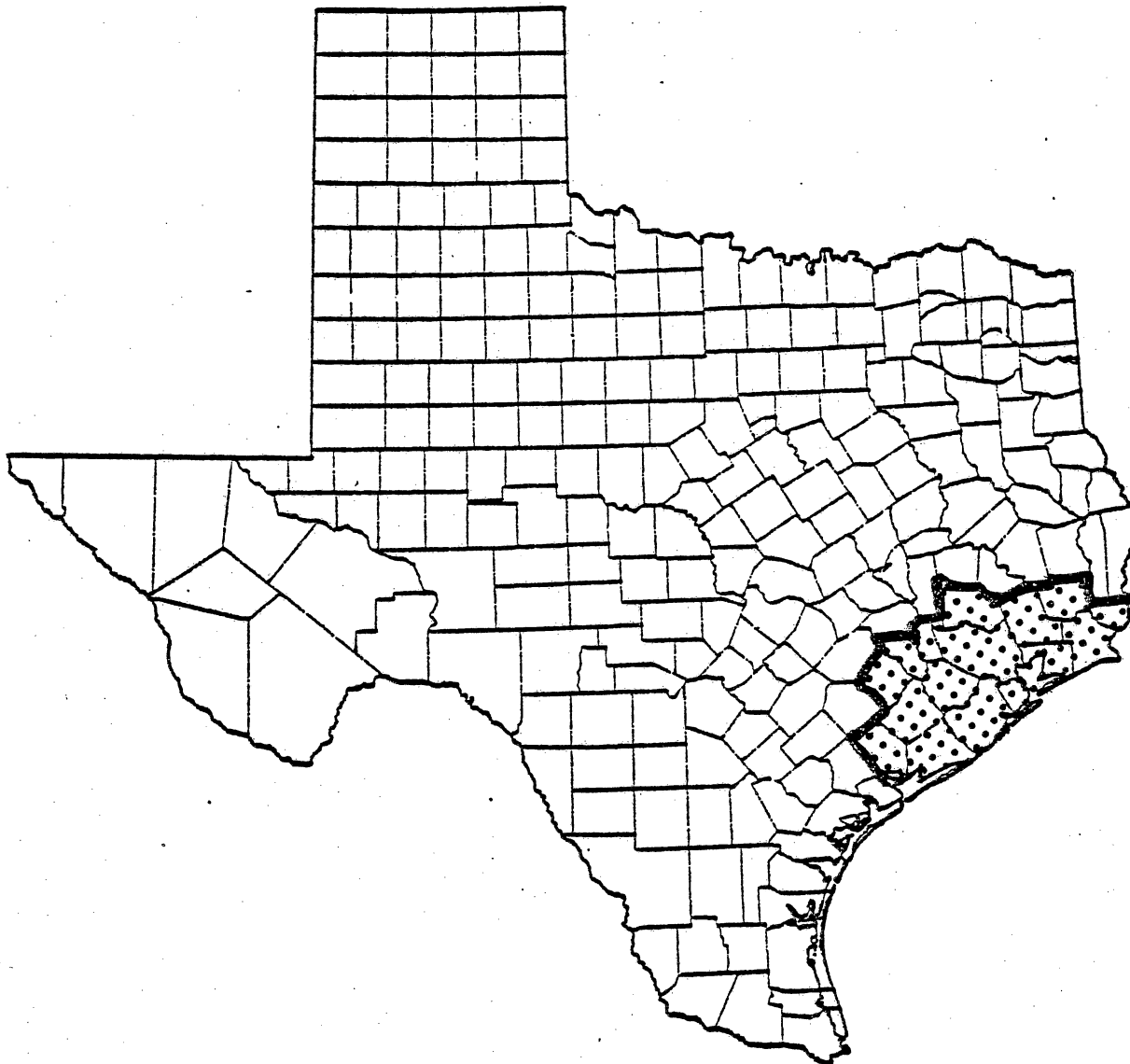

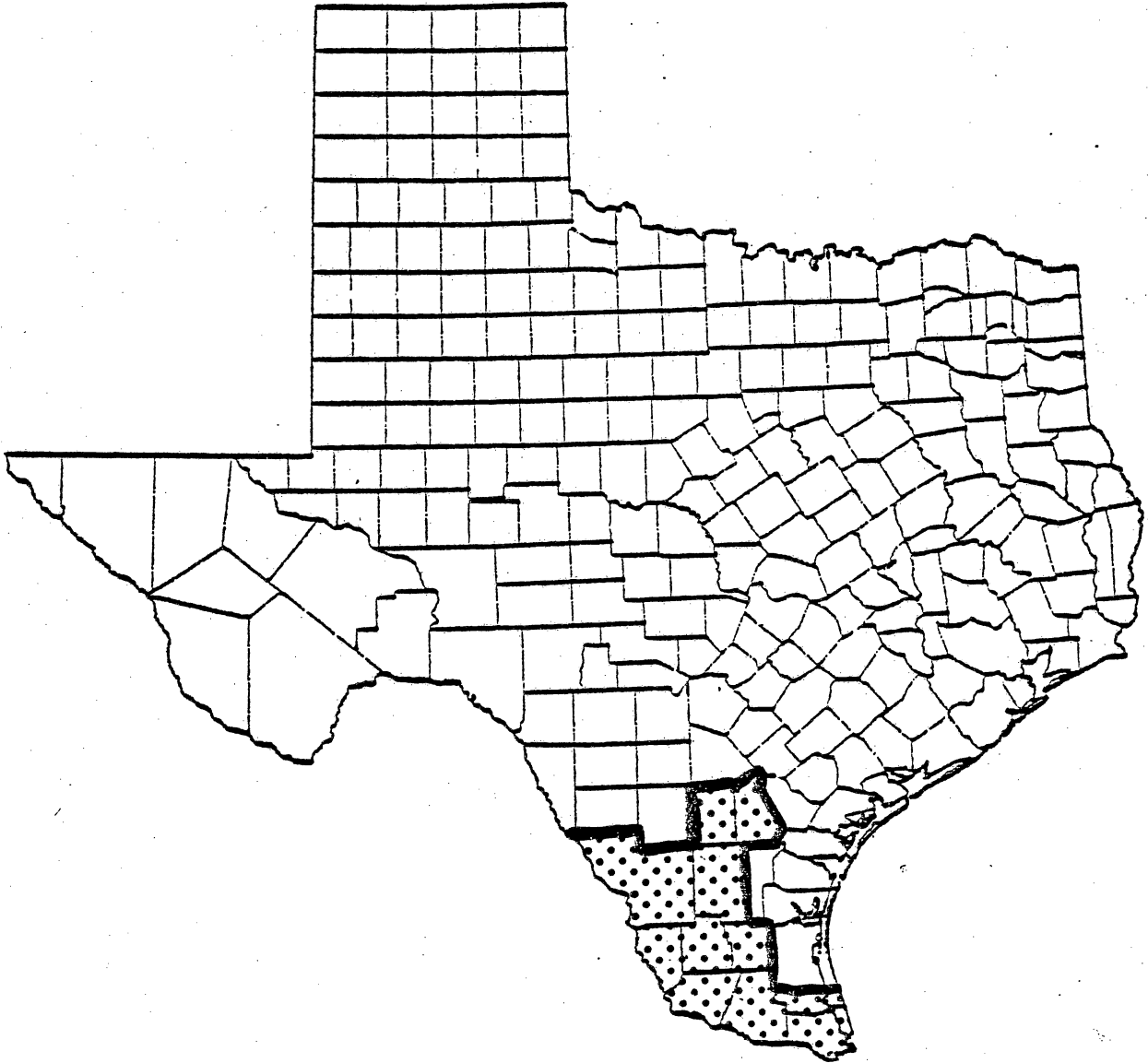

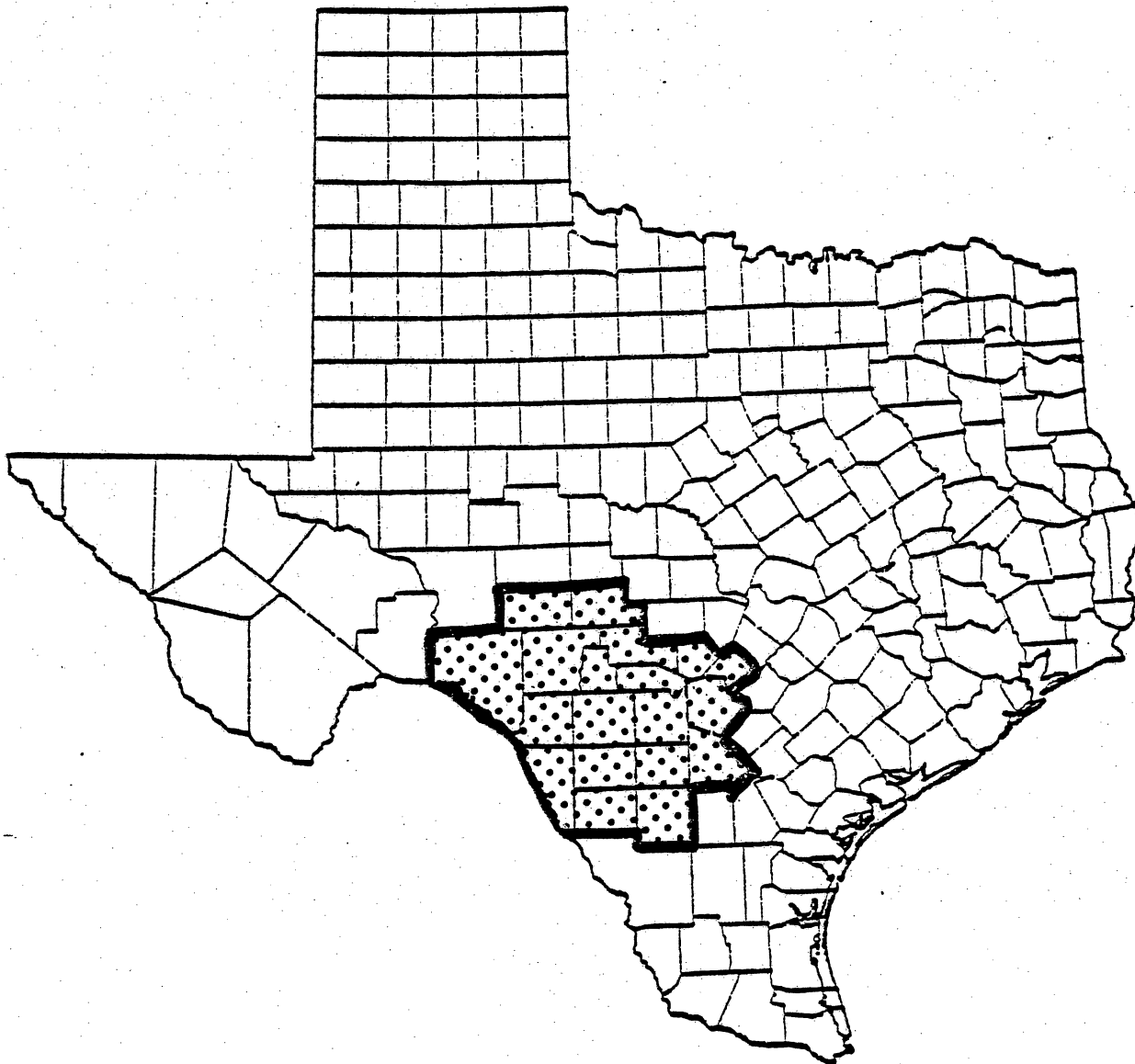

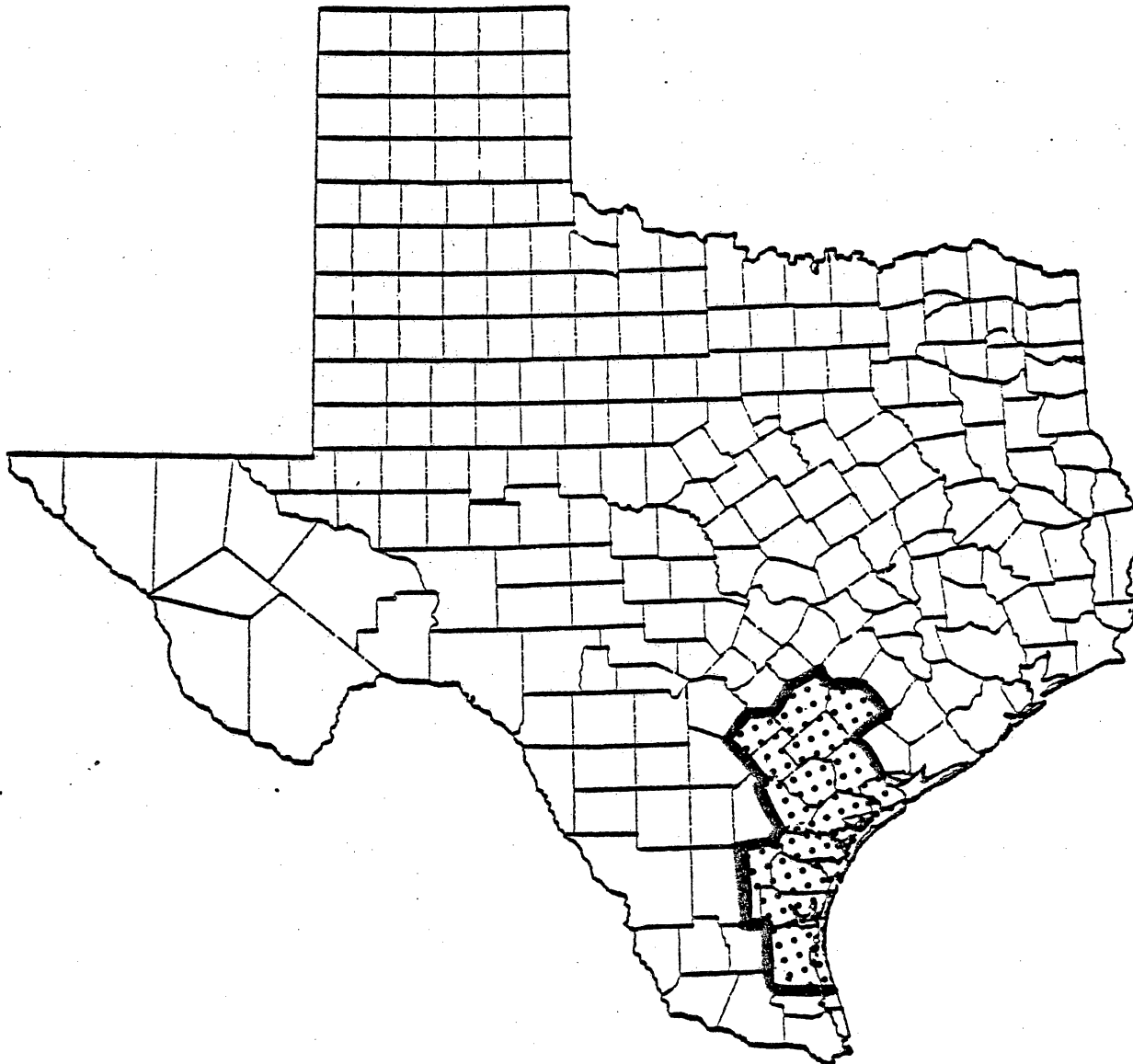
