# **A BIBLIOGRAPHY ON THE ECONOMICS OF WORLD GRAIN TRADE**

## **INTRODUCTION**

The following bibliography is intended to assist people interested in studying the economics of world grain trade. The intended audience is professional economists and students with a research interest. The bibliography includes material on analytical techniques, history, and institutions related to grain trade. A separate list of data sources follows the main entries. The subject is limited to economic aspects of grain rather than to technical agriculture. Coverage is more extensive for wheat than for other grains. The list emphasizes international trade in grain, although for some countries domestic agriculture and trade are inseparable. Interdependence between the domestic and foreign sectors is particularly prominent in the area of trade policy.

The bibliography was compiled from professional journals in general economics and agricultural economics, books, and documents from national governments and international agencies. Material related to all the major grain-producing and consuming countries is

presented, but only English language sources are included. An attempt was made to include the relevant material available as of the middle of 1984. Obviously the list cannot be exhaustive. It is intended to be a small improvement on existing sources. The potential benefit of the bibliography is the time saved by future researchers.

My own interest in the subject began with a collaborative effort with Paul R. Johnson and Marie Thursby that culminated in 1978 in the book, The Economics of World Grain Trade. The present work contains some basic references from that book, but it is much more comprehensive as well as more current. John Brown performed ably as research assistant on the project.
