JARE Editors' Report

June 1, 2016–May 31, 2017

The *JARE* editorial team of David K. Lambert, Tian Xia, Hikaru Hanawa Peterson, and Jeffrey M. Peterson began their three-year term with manuscript 2015-2055, submitted April 1, 2015. Their first issue as an editorial team was Volume 41, Issue 2, published in May 2016. As of May 31, 2017, the Kansas/Minnesota team has handled 621 manuscript submissions and published 37 papers in four issues.

Publication details for the three issues published by in the past year are reported below.

JARE Publication Costs: *JARE* publication costs are incurred in three general areas: Editorial Team, Publications Editing, and Printing. The Editorial Team manages the review and publication process. The Team's costs are fixed on an annual basis. Assuming that each volume (a total of three issues) contains 500 printed pages, these costs total \$40/page.

Publications Editing involves both copyediting and formatting final documents into pdfs that are used by Sheridan Press during the printing process. This process involves formatting text and figures, checking references, resolving technical errors, and formatting figures/tables to maintain consistency and fit within available space. These costs are approximately \$25/page.

Finally, Sheridan Press prints, binds, and mails print versions of the Journal to members and other subscribers. Some of these costs are fixed and some are variable. Total costs for the most recent issue were approximately \$31/page.

In summary, *JARE*'s costs per printed page are approximately \$96/page. These costs are met through a combination of page charges (\$79–89/page), member dues, subscriptions, royalties, and WAEA assets.

JARE Manuscript Management: Submission details from June 1, 2016, to May 31, 2017, are reported in table 2. A total of 237 manuscripts were entered into the FastTrack system and reviewed during the year. Of these, 17 were resubmissions, for a total of 220 unique manuscripts (ignoring multiple submissions of the same manuscript).

Of these 220 manuscripts, 16 papers are currently under review and 221 have been completed (i.e., a publication decision has been made). The Journal's acceptance rate for the past year was 8.60% of all completed submissions, and 8.02% of all submissions.

To situate these numbers in some historical context, table 3 provides the same information beginning with the 2009–2010 journal year. Please note that these numbers are not directly comparable, as all of the submissions from these previous years have been completed.

Distinguished Scholars

Jayson Lusk, Purdue University



Jayson Lusk is in the midst of transitioning from Regents Professor and Willard Sparks Endowed Chair in the Department of Agricultural Economics at Oklahoma State University to Professor and Head of the Department of Agricultural Economics at Purdue University. He has a BS in Food Technology and a PhD in Agricultural Economics from Kansas State University. He held previous faculty appointments at Mississippi State and Purdue. Lusk is a food and agricultural economist who studies what we eat and why we eat it. Since 2000, Lusk has published more than 190 journal articles in peer reviewed journals, including several of the most cited papers in the profession. He has served on the editorial councils of eight academic journals including the *Journal of Agricultural and Resource Economics*. He was elected to and served on the executive committees of the Southern Agricultural Economics Association, the Western Agricultural Economics Association, and most recently the Agricultural and Applied Economics Association for which he currently serves as the president. Lusk was named a fellow of the AAEA in 2015.

Vicki A. McCracken, Washington State University

Vicki A. McCracken, Professor and past Associate Director in the School of Economic Sciences at Washington State University (WSU), and current Chair of the Department of Apparel Merchandising Design and Textiles. She has spent her entire career since 1984 at WSU, serving as a faculty member and in various administrative positions – Associate Director of the Agricultural Experiment Station, Associate Dean of Academics, and Vice Provost for Enrollment Management. She has taught courses in quantitative methods, intermediate micro, applied marketing analysis, and international trade and finance. Her research and extension interests range from analyzing social and economic issues of importance in agricultural production contexts to alternative agricultural markets and human health to identifying determinants of student academic success. Dr. McCracken has a steady stream of external grant funding that has supported her research resulting in a steady flow of conference presentations and publications. Dr. McCracken has been active in service throughout her career, in her department and university as well as within the profession and is a former WAEA president.
