Study on China's Natural Rubber Import

Abstract China is a large importer of natural rubber. In 2016, China's natural rubber import reached 2.5 million t, the amount of import was up to 3.35 billion USD. China imported 1.593 million t natural rubber (2040 million USD) mainly from Thailand, 0.288 million t (400 million USD) from Malaysia, 0.28 million t (390 million USD) from Indonesia, and 0.168 million t (230 million USD) from Vietnam. According to the import classification, in 2016, China imported 1.658 million t technical natural rubber, accounting for 66.3% of China's total natural rubber import volume; China imported 0.424 million t natural rubber, accounting for 16.9% of China's total natural rubber import volume; China imported 0.214 million t other shape of natural rubber, accounting for 8.6% of China's total natural rubber import volume; China imported 0.205 million t natural rubber smoked sheets, accounting for 8.2% of China's total natural rubber import volume. According to the import situation, China still needs importing large volume of natural rubber.

1 Introduction

Production areas of natural rubber are mainly distributed in Asia, Africa and South America. Asia accounts for 93% of total production. The main production countries in Southeast Asia accounts for 90% of the world's total production. Natural rubber is mainly produced in Thailand, Indonesia, Vietnam, Malaysia, China, India, Myanmar, Sri Lanka, Côte d'Ivoire, Nigeria, Liberia, Cameroon, Ghana and Gabon. The Asian-Pacific area accounts for 70% of total consumption. China is the world's largest consumer of natural rubber. China's natural rubber consumption accounts for about 36% of the world market, showing that China takes up a lead

ing role in the consumption of natural rubber. According to data of the General Administration of Customs of People's Republic of China, China imported 5.81 million t natural rubber and synthetic rubber (including latex)^[1], showing a big gap between supply and demand. In this study, we mainly analyzed China's natural rubber import.

2 Analysis of import volume and amount

China is a natural rubber producer, but also a large importer of natural rubber. According to statistics of China Customs, China imported 2.5 million t natural rubber, the import volume increas-




ing by 38.4% (Table 1), the months with minimum import volume were February and April with monthly import volume of 0.14 million t; the month with maximum import volume was December, up to 0.35 million t (Fig. 1). In 2016, China's natural rubber import amount reached 3.35 billion USD^[2], the month with minimum import amount (160 million USD) was February, and the

month with maximum import amount (580 million USD) was December (Fig. 2.)

3 Analysis on countries from which China imported natural rubber


Fig. 3 Top 4 countries from which China imported natural rubber in 2016

According to statistical data of China Customs Information Website, China mainly imported natural rubber from 20 countries and regions (as listed in Table 2), mainly including Thailand, Malaysia, Indonesia, and Vietnam (Fig. 3). In 2016, the import volume from these four countries accounted for 93.2% of China's total natural rubber import volume. China imported 1.593 million t natural rubber (2040 million USD) mainly from Thailand, 0.288 million t (400 million USD) from Malaysia, 0.28 million t (390 million USD) from Indonesia, and 0.168 million t (230 million USD) from Vietnam.



4 Analysis on type of imported natural rubber

4.1 Type of China's natural rubber import in 2016 According to the statistical classification of custom trade, in 2016, China imported 1. 658 million t technical natural rubber, accounting for 66.3% of China's total natural rubber import volume; China imported 0. 424 million t natural rubber latex, accounting for 16. 9% of China's total natural rubber import volume; China imported 0. 214 million t other shape of natural rubber, accounting for 8. 6% of China's total natural rubber import volume; China imported 0. 205 million t natural rubber smoked sheets, accounting for 8. 2% of China's total natural rubber import volume, as shown in Fig. 4.

4.2 Imported technical natural rubber In 2016, China imported 1. 658 million t of natural rubber products with import amount up to 2230 million USD (as shown in Table 3); in the same year, China imported technical natural rubber mainly from five countries: Thailand, Malaysia, Indonesia, Vietnam, and Côte d'Ivoire (Fig. 5). Among them, China imported 0. 955 million t technical natural rubber from Thailand, accounting for 57.60% of total import volume, and the import amount was about 1270 million USD, accounting for 56.93% of the import amount. China imported 0. 275 million t technical natural rubber (about

380 million USD) from Malaysia, 0.269 million t technical natural rubber (about 370 million USD) from Indonesia, 0.118 million t technical natural rubber (about 160 million USD) from Vietnam, and 0.003 million t technical natural rubber (about 40 million USD) from Côte d'Ivoire.

Fig. 4 Type of China's natural rubber volume in 2016




Fig. 6 Top 5 countries from which China imported natural rubber latex in 2016

4.3 Imported natural rubber latex In 2016, China imported 0.424 million t natural rubber latex (with import amount of 442. 68 million USD), as listed in Table 4. In 2016, top 5 countries from which China imported natural rubber latex were Thailand, Vietnam, Malaysia, Laos, and Myanmar, as shown in Fig. 6. Among them, China imported 388170t natural rubber latex from Thailand, accounting for 91.53% of total import volume, and the import amount was about 401.21 million USD, accounting for 90. 63% of the import amount. China imported 19642 t natural rubber latex from Vietnam with import amount of 18.87 million USD; China imported 10486 t natural rubber latex from Malaysia with import amount of 15.89 million USD; China imported 2509 t natural

ral rubber latex from Laos with import amount of 3.2 million USD; China imported 18.39 million t from Myanmar with import amount of 1.72 million USD.





Imported smoked sheets In 2016, China imported 0. 2 million t natural rubber smoked sheets with the import amount of 324.77 million USD (as listed in Table 5). In the same year, top 6 countries from which China imported natural rubber smoked sheets were Thailand, Myanmar, Vietnam, Laos, Indonesia, and Cambodia (as shown in Fig. 7). Specifically, China imported 134538 t natural rubber smoked sheets from Thailand, accounting for 65.65% of the total import volume, and the import amount was 195. 16 million USD, accounting for 60. 09% of the total import amount: China imported 32487 t natural rubber smoked sheets from Myanmar with the import amount of 67.08 million USD; China imported 18638 t natural rubber smoked sheets from Vietnam with the import amount of 27.85 million USD; China imported 7421 t natural rubber smoked sheets from Laos with the import amount of 16.75 million USD; China imported 6726 t natural rubber smoked sheets from Indonesia with the import amount of 10.46 million USD; China imported 18638 t natural rubber smoked sheets from Cambodia with the import amount of 6.04 million USD.

Fig. 7 Top 6 countries from which China imported natural rubber smoked sheets in 2016


4.5 Other shape of natural rubber imported In 2016, China imported 0.21 million t other shape of natural rubber with the import amount of 352.68 million USD (as listed in Table 6). In the same year, top 6 countries from which China imported other shape of natural rubber were Thailand, Laos, Myanmar, Vietnam, Côte d'Ivoire, Indonesia, and Malaysia (as shown in Fig. 8). Among them, China imported 115884 t other shape of natural rubber from Thailand, accounting for 54.05% of total import volume,

and the import amount was about 167.44 million USD, accounting for 47.48% of the import amount. China imported 42751 t other shape of natural rubber from Laos with the import amount of 78.64 million USD; China imported 34752 t other shape of natural rubber from Myanmar with the import amount of 71.17 million USD; China imported 11511 t other shape of natural rubber from Vietnam with the import amount of 20.52 million USD; China imported 3966 t other shape of natural rubber from Côte d'Ivoire with the import amount of 5.42 million USD; China imported 3966 t other shape of natural rubber from Côte d'Ivoire with the import amount of 5.42 million USD; China imported 2031 t other shape of natural rubber from Indonesia with the import amount of 3.31 million USD; China imported 2159 t other shape of natural rubber from Malaysia with the import amount of 2.89 million USD.

Fig. 8 Top 7 countries from which China imported other shape of natural rubber in 2016


5 Trend of China's natural rubber import

5.1 Stage import trend According to the FAO statistical database, China's import of natural rubber was: 84 t in 1961, 522 t in 1970, 1199 t in 1980, 33292 t in 1990, 83136 t in 2000, 262089 t in 2010, and 345330 t in 2013^[3]. From 1961 to 2013, the growth rate of China's natural rubber import reached the peak in 1990, compared with 1980, reaching 2676. 6% (as indicated in Table 7), China's natural rubber import volume reached the maximum in 2013, up to 345330 t (as shown in Fig. 9).

Fig. 9 Volume of China's natural rubber import



5.2 Current import trend According to the statistical data of

China Customs, in 2007-2016, the volume of China's natural rubber import showed an increasing trend, from 1.65 million t in 2007 to 2.50 million t in 2016. Over the past 10 years, the growth rate of volume of China's natural rubber import reached the highest in 2013, up to 13.3% (as indicated in Table 8). The largest volume of natural rubber import reached the maximum in 2015, up to 2.74 million t, as shown in Fig. 10.

6 Conclusions

The maximum consumption of natural rubber comes from the industrial demands, and about 69% is used for the tire manufacturing, daily necessities account for less than 20%. The consumption of rubber tube, medical care, and special rubber fields accounts for a small and steady portion. The demands for tire manufacturing are mainly driven by the automobile manufacturing industry, China's automobile manufacturing industry is showing an excellent development trend, especially the sales terminal market preferences of heavy truck industry. Excellent domestic automobile and heavy truck market increases the utilization of capacity of tire enterprises, accordingly increases the demands for natural rubber. Thus, China's automobile manufacturing industry still demands large volume of natural rubber. Due to the relatively limited domestic production of natural rubber, it is difficult to change the situation of China's high dependence on import of natural rubber in a short term, and China still needs to import large volume of natural rubber. Thailand, Vietnam, Malaysia, and Indonesia are the main sources of natural rubber in China. In the next 10 years, these countries will still be countries from which China imports natural rubber.
