GUIDELINES FOR SUBMISSION OF PAPERS/ABSTRACTS

- 1. Research articles and research notes based on basic and applied research on economic aspects of Agriculture and Rural Development, abstracts of M.Sc./Ph.D. theses and short communications may be accepted for publication.
- 2. Authors should be members of the Society, although it will be the discretion of the Editor to consider papers submitted even by non-members.
- 3. Three copies of manuscript typed in double space on good quality paper should be sent to the Editor, Agricultural Economics Research Association (India), Div. of Agril. Economics, IARI, New Delhi-110012. Research articles must include an abstract of about 100-150 words.
- 4. The length of papers should not be more than 20 (double space) typed pages including tables, diagrams and appendices. The title of the manuscript should be in capital letters followed by the names of authors and the place of work. M. Sc. and Ph. D. theses abstract should not exceed 2 and 4 typed pages, respectively.
- 5. Name(s) and affliation(s) of the author(s) should be provided on a separate page along with the title of the article.
- 6. Only essential mathematical notations may be used. All statistical formulae should be neatly typed.
- 7. Footnotes should be numbered consecutively in plain arabic superscripts.
- 8. Only cited works should be included in reference list. The citation of references should be in the following order: author(s) name(s); year; title of article; name of journal; volume; number; and pages.
- 9. Papers sent for publication should have been exclusively written for this journal and should not have been published or sent for publication elsewhere.
- 10. No free reprints will be supplied. Reprints may be ordered, along with full advance payment, in multiples of 25. The rates for a unit of 25 reprints will be decided by the Association.
- 11. All remittances may be sent to the Treasurer, Agricultural Economics Research Association (India), Divn. of Agril. Economics, IARI, New Delhi-110012, India.
