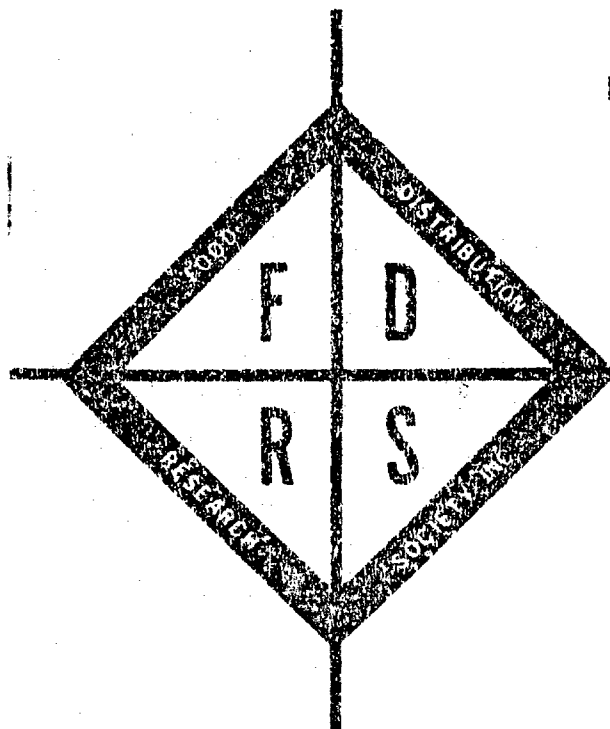

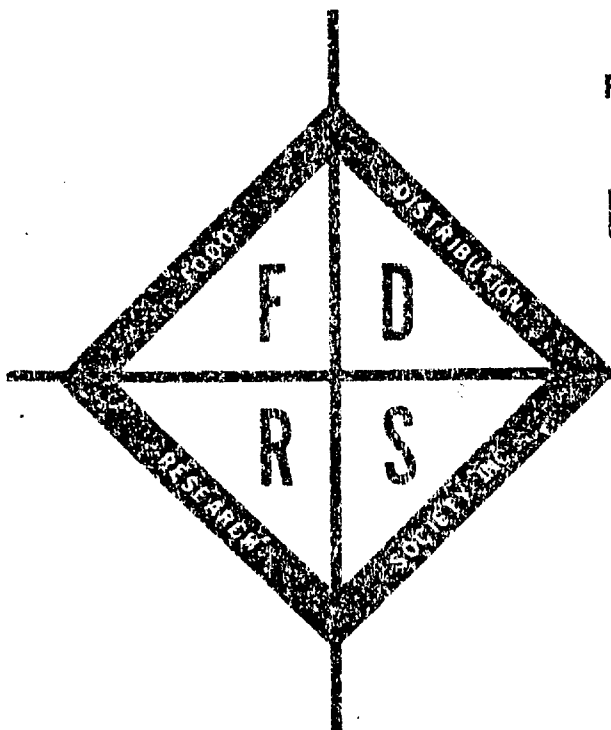

- Statement of Problem (a short paragraph)
- Objectives
- Methodology - (major points only)
- Results and Conclusions
- Implications - (pertinent to the food industry)

Limit the entire paper to 10 to 12 pages, double spaced (including tables, charts, references, etc.). Tables and charts should be numbered consecutively throughout the text and should follow the first reference to the table. Omit color visuals, as we are not in a position to utilize them at this time. Send two copies of your paper to the Vice President for publication.
