PREFACE

The 54th Annual Conference of the Indian Society of Agricultural Economics is scheduled to be held from 26th to 28th November, 1994 under the auspices of Shivaji University, Kolhapur (Maharashtra). The subjects selected for discussion at this Conference are:

1. Agricultural Production Relations in the Context of the New Technology in Agriculture.
2. Prices, Marketing including Agro-Processing, and International Trade.
3. Agricultural Finance in the Context of Technology-led Development of Agriculture.

This Conference Number of the Journal includes one Keynote paper on the first subject and two Keynote papers each on the second and third subjects.

A large number of papers has been received on the first subject. The President of the Conference, on the recommendations of the Rapporteurs, has accepted in all 91 papers for discussion at the Conference. Out of these, 8 papers are published in full and 82 papers in the form of Summaries in this issue, which also includes the Rapporteurs' Reports on the three subjects.

We regret it has not been possible to publish, in full length, a large number of papers because of the exorbitant increase in the cost of printing. We do hope the contributors whose papers could not be published in full would appreciate our difficulty and bear with us. We are grateful to all the paper-writers for sending their papers and to the Rapporteurs for preparing their Reports embodying the main points made in the papers and also for outlining the issues for discussion.
