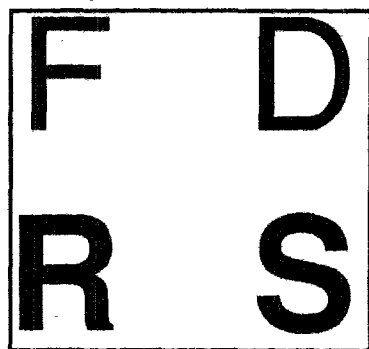

Please submit an abstract of not more than 100 words. The Society has a page charge of \$35 per page and it also requires that at least one author of an accepted paper be a member of the Society. Send four copies of your paper to the Vice President for Publication.
