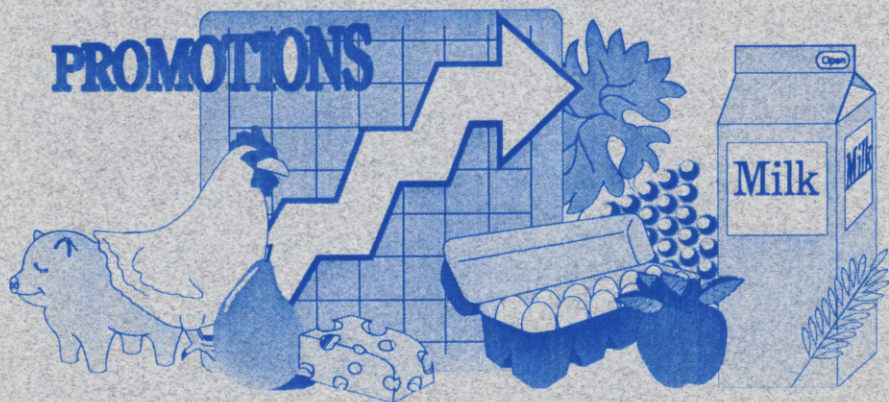

Editors:

Harry M. Kaiser is an associate professor of Agricultural Economics at Cornell University and director of the National Institute for Commodity Promotion Research and Evaluation. Since his arrival at Cornell in 1985, Kaiser has conducted research in commodity promotion economics and has authored numerous articles in academic journals in the United States, England, Holland, and Japan. In 1991, Kaiser was co-recipient of the *Northeastern Journal of Agricultural and Resource Economics* Article of the Year award. Kaiser received his B.A. in Economics from the University of Wisconsin and his M.S. and Ph.D. in Agricultural Economics from the University of Minnesota. At Cornell, Kaiser has taught classes in linear programming, price analysis, and agricultural policy, and has research interests in agricultural policy and marketing.

Henry W. Kinnucan is a professor of Agricultural Economics at Auburn University. He has been a student of commodity promotion programs for 15 years. His publications on the topic have appeared in scholarly journals in the United States, the United Kingdom, Canada, Korea, and Australia. He is co-editor of the volume *Commodity Advertising and Promotion* published by Iowa State University Press. Educated at the University of Illinois (B.S.) and the University of Minnesota (M.S., Ph.D.), Kinnucan spent three years as a post-doctoral research associate at Cornell University prior to joining the Auburn faculty in 1983, where he teaches courses in price analysis and market theory and maintains an active resesarch program in commodity promotion.

Jennifer L. Ferrero is an editor in the department of Agricultural, Resource, and Managerial Economics at Cornell University. She received her B.A. in International Relations from the University of California, Davis and prior to coming to Cornell in the fall of 1995, worked for three years on the UCD campus newspaper and in the information technology department of a capital investment firm in San Francisco. Her current work focuses on technical editing and design work in the commodity promotion resesarch area.
