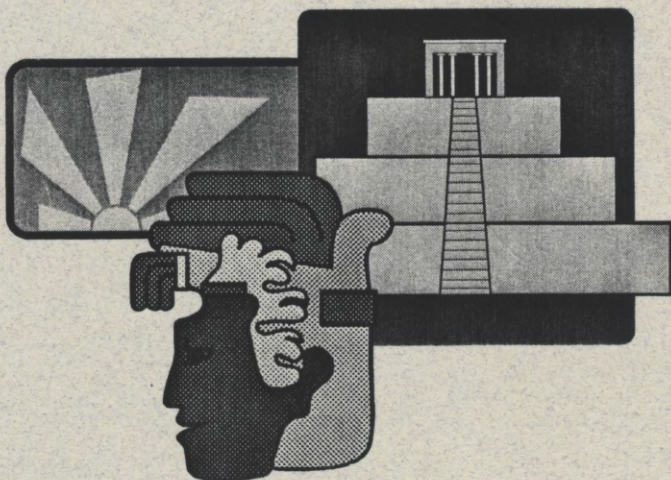

### *Editors:*

Jennifer L. Ferrero is an editor in the Department of Agricultural, Resource, and Managerial Economics at Cornell University. Dr. Nichols completed his Ph.D. at Cornell University in agricultural economics. He is currently chairman of NEC-63 and serves on the Board of the

International Food and Agribusiness Management Association (IAMA). In addition to research and teaching in marketing and policy, Dr. Nichols serves as Associate Department Head for Research Programs.
