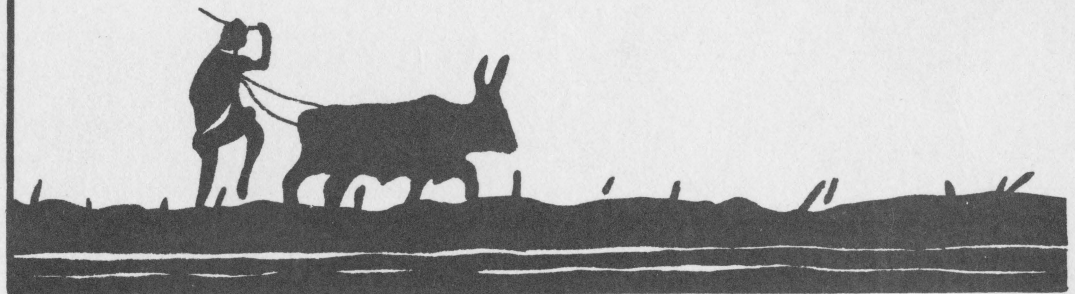

-FOREWORD-

Women in development is an important theme in the farming systems orientation of development projects. A number of publications on the subject, including some fine bibliographies, are cataloged in Farrell Library. Upon discovery that few of the bibliographies' cited documents were available at Kansas State University, the Resources on Developing Countries department began seeking them out. The response we received from our donor agencies and organizations was generally gratifying. Our current collection, while small, offers a wide variety of subjects and will continue to expand.

As we received the documents, we found that many were shorter than the minimum length for cataloging in the general library, so would need to be maintained in a pamphlet file. From this situation sprang the impetus for the bibliography -- to make it known that Farrell Library has these documents, to encourage research on the subject, and to support the work of development efforts such as the USAID/KSU Farming Systems Project.

The citations refer to works from non-commercial publishers and journal articles which are not otherwise available in the KSU library system. They are generally hard-to-locate or fugitive in nature. The bibliography focuses on women's work during economic development, especially in relation to agriculture and rural development. Recent works (since 1975) form the majority of the citations, however earlier works appear if deemed especially relevant.

Some are: Development as if Women Mattered : an Annotated Bibliography with a Third World Focus; Women and World Development : an Annotated Bibliography; Tillers of the Soil and Keepers of the Hearth : a Bibliographic Guide to Women and Rural Development.

The materials are arranged by subject. A location code, often for the Developing Countries vertical files, appears after the citation. Those publications which are cataloged in the general library carry the Library of Congress call number as location code. Some publications await cataloging in the general library, and they are coded with **. (To use those materials, request an in-process-search form from a librarian. Once the form is submitted, the publication will become available to you within two weeks.) All other materials are arranged by location code within the Developing Countries vertical files.

We invite persons from the Mid-America Agricultural Consortium universities, as well as other institutions, to use these materials, while visiting KSU or through interlibrary loan.
