## Editors' Report for 1992–93

This report provides cumulative information through the second year of the Montana State University–University of Arizona editorship. July 1992 was the first journal issue under this editorship. Several changes were implemented with that issue, including the name change from *Western Journal of Agricultural Economics* to *Journal of Agricultural and Resource Economics*. In addition, to further reduce publication costs, a single-column format was adopted (which also provides a more convenient and readable presentation of mathematical notations), the print size and left/right margins were reduced, and end-notes were substituted for footnotes. Following the publication of the July 1992 issue, an informal survey of several members of the readership was conducted. Two requests consistently were made by those surveyed concerning the journal format: (a) return to the original (larger) typeface, and (b) use wider left/right margins. Those suggestions have been incorporated into the succeeding *JARE* issues (commencing with the December 1992 issue). The editors believe that the current *JARE* format is now easily readable, attractive, and cost effective.

Three journal issues have been produced under this editorship (July 1992, December 1992, and July 1993). The following represent the formulas for author double-spaced manuscript pages submitted converted to actual typeset journal pages (based on font size and left/right margins used for actual typesetting of each issue of the journal):

- *July 1992 issue*: 9-point font size and  $5\frac{13}{16}$ " horizontal line of text; 2.967 double-spaced manuscript pages = 1 typeset journal page.
- *December 1992 issue*: 11-point font size and  $5\frac{7}{16}$ " horizontal line of text; 2.440 double-spaced manuscript pages = 1 typeset journal page.
- *July 1993 issue*: Same format as December 1992; 2.457 double-spaced manuscript pages = 1 typeset journal page.

The actual dimensions of a journal page are  $6\frac{3}{4}$ "  $\times$  10". Table 1 summarizes the publication costs experienced under the different formats.

As in our first year of editorship, we have continued to request only two reviews per manuscript submission, due to the heavy burden placed on reviewers by the increased number of submissions to agricultural and resource economics journals. Although the editors initially requested a four-week turnaround time from reviewers, a six-week time frame for reviewer evaluation has proven more realistic.

During the first two years of the current editorship (through 31 June 1993), 187 new manuscripts have been submitted for publication consideration, plus 23 carryover submissions from the previous editorship. This represents a total of 210 manuscripts. In addition to the 187 new manuscript submissions to this editorship, 71 manuscript revisions have been submitted for further reconsideration. To date, the average time from initial manuscript receipt to written notification to corresponding authors regarding manuscript disposition is 84 calendar days. The cumulative acceptance rate is 24% (based on 42 acceptances out of a total of 173 "processed" manuscripts where reviews have been completed and authors notified of the editorial decision). Currently, 27 manuscripts are in "revise-and-resubmit" status.

The editors appreciate the cooperation of the authors and the many referees who have contributed to the continuing excellence of the journal. We particularly would like to thank Colin Carter, member of the Editorial Council, who has on several occasions provided valuable referee assistance.

## Guidelines for Submitting Manuscripts

To aid in reviewing manuscripts and for efficient publication of the *Journal*, contributors are requested to use the following guidelines in preparing manuscripts for submission to the *JARE*.

1. *Cover letter.* In a cover letter accompanying the manuscript, the author must indicate (a) why the manuscript would interest *JARE* readers; (b) whether the material in the manuscript (or modification thereof) has been published, is being published, or has been submitted for publication elsewhere; (c) that the material in the manuscript, to the best of the author's knowledge, does not infringe upon other published material protected by copyright; and (d) that the author has read and agrees to the policy outlined in the next paragraph.
2. *Data access and estimation procedures.* Authors should report, describe, and/or reference the complete estimation process undertaken to derive the results presented in the manuscript. This should include data documentation as well as model specifications estimated but not reported in the manuscript. Authors are expected to make data used available at cost upon request for five years.
3. *Typing.* Manuscripts should be typed on good quality 8½-by-11-inch paper, with margins of at least one inch on all sides. Double space all material throughout the paper, including the abstract, acknowledgments, footnotes, references, and tables. Type only on one side of the paper. **Do not submit ditto or thermofax reproductions.**
4. *Style.* Use a consistent style throughout the document. The *JARE* currently accepts the style format in *The Chicago Manual of Style* by the University of Chicago Press as the standard for the *Journal*.
5. *Title page.* Provide a separate title page that includes the title of the manuscript and author name(s) and title(s), placing institutional affiliation(s) and acknowledgments of colleague reviews and institutional support as an unnumbered footnote at the bottom of the page. Place the manuscript title at the top of the first page of the text. **Do not place the name(s) of the author(s) on the first page of the text.**
6. *Abstract.* On a separate page, include an abstract not to exceed 100 words followed by no more than eight key words, listed in alphabetical order.
7. *Endnotes.* Number endnotes consecutively through the manuscript. Type the content of the endnotes on separate pages placed immediately after the main text.
8. *Tables.* Prepare tables in the form desired and place each table on a separate page at the end of the text, immediately following the last endnote page. Begin each table's title at the left margin above the table's body using the following format:  
Table 1. Regression Results  
Table titles and headings should have the first letter of all words capitalized except conjunctions, prepositions, and articles. Review of tables for accuracy is the author's responsibility.
9. *References.* Citations may appear parenthetically or as part of the text. Use parentheses instead of brackets within the text to identify references. Identify citations by reference to the author's last name. Do not specify the year of the reference unless there is more than one reference with the same author. List all references cited in the text in alphabetical order of the author's last name on separate pages after the text, immediately following the last table page. Do not number references.
10. *Figures.* Submit final drafts of camera-ready copies of figures, charts, and graphs drawn in a professional manner. Immediately following the last reference page, place each figure on a separate sheet of heavy white paper or acetate sheet using black india ink for photographic reproduction, or submit a black-and-white glossy photograph. Typescript is not acceptable. Type the figure title on a separate sheet of paper and append to camera-ready copy using the following format:  
Figure 1. A Supply Curve  
Review of figures for accuracy is the author's responsibility.
11. *Mathematical formulation.* Use Arabic numbers enclosed in parentheses and placed flush left on the first line of the equation for displayed equations. Number equations consecutively throughout the manuscript. Indent the equation proper after the equation number. Punctuate all mathematical material. To eliminate confusion between symbols, use proper and distinctive fonts in the manuscript and make notes in the left-hand margin spelling out the Greek name of symbols that may be difficult to interpret. Include a list of symbols used in the manuscript on a separate sheet of paper.
12. *Publication costs.* Publication costs for the *JARE* are largely financed by page charges levied on authors of manuscripts accepted for publication. Hence, authors submitting manuscripts are expected to assume obligation for payment of page charges at the time their manuscripts are published. Page charges currently are \$70 per printed page. Additional information on page charge policies can be obtained from the editors.
