## **JARE Editor's Report**

### **October 2001**

The University of Arizona editor and co-editors began receiving submissions on April 1, 2000. By the end of October 2001, we had received a total of 173 manuscripts. Of those submitted, 13 were forwarded to us in various stages of review at different dates by the previous editor, Scott Shonkwiler. Four manuscripts have been retracted or returned to the author(s).

Just over half of the submissions (51%) came from corresponding authors residing in the West. Other domestic submissions were distributed as follows: Northeast (13%), South (14%), and Midwest (14%). Another 3% of the submissions originated in Canada, while Europe, Asia, Australia, and Israel jointly accounted for the remaining 4%.

To date, 33 manuscripts have been accepted for publication, and 76 have been rejected. The remaining 64 submissions are at various stages of review. While it is premature to calculate an acceptance rate for our term as editors, if we consider only the 109 manuscripts either rejected or accepted, the current acceptance rate is about 30%. Of course, the outcome of the 64 manuscripts still under review could significantly alter the final acceptance rate.

From April 2000 through June 2001, the median time from first receipt of manuscript until an editorial decision was sent to the author(s) was 90 days. By contrast, Scott Shonkwiler averaged 61 days from first receipt to mailing of the first editorial decision. After approval from the WAEA membership, we implemented a payment to referees for on-time reviews. Since adoption of the payment incentive, average response time is now 60 days.

Our technical editor, Judith Harrison, continues to perform a superb job of editing manuscripts. Her attention to detail, grammar, logical consistency, and timeliness are second to none. The bonus of dealing with Judy is her cheerful attitude and willingness to accommodate changes, omissions, and additions even at the last minute. As new co-editors and editor, we owe Judy thanks for guiding us to final production of our first two issues of the *Journal*.

We would also like to thank all those who support the *Journal* in diverse ways. Our editorial assistant, Ricardo Cavazos Cepeda, has deftly handled much of the *Journal's* correspondence. Our Secretary/Treasurer, E. Bruce Godfrey, has consistently provided prompt payment for services, and processed reprint requests, memberships, and page charges with never a complaint. We would like to thank our editorial council members for their invaluable contributions, particularly when time was running short. Last, we are indebted to our reviewers for their conscientious efforts and critical judgments.

## WAEA 2000 Award Winners

### Outstanding Master's Thesis

DONGMEI ZHOU, "Import Demand for U.S. Beef By-products and Effects on Domestic By-product and Live Cattle Prices," Montana State University.

JOHN M. MARSH, Advisor

The thesis evaluates the effects of macroeconomic factors on the import demand for U.S. beef by-products and, ultimately, on the U.S. beef slaughter prices. The importance of this topic to U.S. beef producers should not be overlooked, as exports account for 45% of all beef by-product sales. It was found that the recent deterioration in Asian income and currency values had a significant economic impact on U.S. beef prices. The analysis upon which these results were obtained is thorough and reported in a very effective manner.

### Outstanding Extension Program

#### Career Award:

NEIL MEYER, University of Idaho

Over the past 28 years, Neil has been involved in Extension Education. He has focused on rural economic development and public policy topics important to rural citizens by developing programs that vary from problems associated with hasty expansion to those related to rapid contraction. Neil is not afraid to tackle controversial issues and serves as a champion for rural America.

#### Program Award:

JOHN LEATHERMAN, Kansas State University: Kansas State University's Office of Local Government

Kansas State's Office of Local Government, under the direction of John Leatherman, developed a number of analytic tools and education programs to be used by local government to assist in local economic development, provision of public services, and local natural resource management. One component of this program is the development of the state's first detailed database of county government revenue and expenditures by category.

### Outstanding Published Research

JULIAN M. ALSTON (University of California-Davis), MICHELE C. MARRA (North Carolina State University), CONNIE CHAN-KANG (IFPRI), PHILIP G. PARDEY (IFPRI), and TJ WYATT (IFPRI). "A Meta-Analysis of Rates of Return to Agricultural R&D: 'Ex Pede Herculem?'" IFPRI Research Report No. 113, International Food Policy Research Institute, Washington, DC, 2000.

This study provides important insights about rates of return to agricultural research through an exhaustive assessment of 292 previous empirical studies. The study concludes that there is no evidence of declining rates of return to agricultural R&D, but that sample averages of rates of return estimates stressed in previous studies provide little meaningful information for either policy makers or researchers.

## **JARE Published Research Award**

S. ANDREW STARBIRD (Santa Clara University). "Designing Food Safety Regulations: The Effect of Inspection Policy and Penalties for Noncompliance on Food Processor Behavior." *Journal of Agricultural and Resource Economics* 25,2 (December 2000): 616–635.

Food safety regulations that set standards for food processors usually include inspection policies for monitoring performance, and penalties for processors who do not comply with regulatory standards. Using a model of the processor's expected annual costs, the author finds that under a given inspection policy, internal penalties are only relevant under specific conditions. These results imply that regulators should utilize internal penalties for noncompliance rather than rely on market or court-imposed penalties.

## **Outstanding Undergraduate Instructor**

### **Less than 10 years:**

MICHAEL BOLAND, Kansas State University

Mike teaches agribusiness marketing and management courses to undergraduate and master's level students, is active within his department and college in improving instruction and cohesiveness of programs, advises 30–35 students, has organized numerous internships, and works with the department's NAMA team and AAEA Case Study Competitions students. Dr. Boland is best known for bringing his courses to life through real-world agribusiness experience. He uses case studies, industry speakers, simulation exercises, and other creative activities to provide students a unique opportunity to bridge the gap between their academic experience and business applications.

### **More than 10 years:**

SCOTT MATULICH, Washington State University

Scott has shined as a star instructor since he began teaching in 1976. His contributions to the department's teaching program are critical in that he lays the rigorous theoretical foundation for all of the department's classes. He also serves on the Undergraduate Advisory Committee and mentors Ph.D. students interested in teaching. Scott experimented with multi-media technology over the years but found that "refining his classroom presence" made a much greater impact on student learning. He clearly exudes passion and devotion within the classroom without sacrificing rigor.

## AUTHOR GUIDELINES FOR SUBMITTING MANUSCRIPTS TO *JARE*

Contributors are requested to use the following guidelines in preparing manuscripts for submission:

1. *Cover Letter.* In a cover letter accompanying the manuscript, indicate (a) why the manuscript would interest *JARE* readers; (b) whether the material in the manuscript (or modification thereof) has been published, is being published, or has been submitted for publication elsewhere; (c) that the material in the manuscript, to the best of the author's knowledge, does not infringe upon other published material protected by copyright; and (d) that the author has read and agrees to the policy on data access and estimation procedures outlined below.
2. *Data Access and Estimation Procedures.* Authors are expected to document their data sources, data transformations, models, and estimation procedures as thoroughly as possible. Authors are also expected to make data available at cost for replication purposes for up to five years.
3. *Title Page.* On a separate page, provide the title of the manuscript and author(s) name(s) centered and in boldface type. At the bottom of the same page, provide university title(s), institutional affiliation(s), acknowledgments of colleague reviews and assistance, and institutional support as an unnumbered footnote. **Do not place the name(s) of the author(s) on the first page of the text.**
4. *Abstract.* Include an abstract of 100 words or less, followed by up to eight key words (or short phrases) listed in alphabetical order.
5. *Text.* Double space all text, including the abstract, acknowledgments, endnotes, and references. Use a 12-point Times Roman font and allow 1" margins on all sides. **Do not use right-justified margins** (i.e., use jagged right margins). **Do not use end-of-line hyphenation feature.**
6. *Style, Grammar, and Punctuation.* The *JARE* uses *The Chicago Manual of Style* by the University of Chicago Press, and *Webster's Third New International Dictionary* for style, format, and spelling.
7. *Footnotes.* Manually insert superscript numbers within the text to denote footnotes, numbered consecutively throughout the manuscript. **Do not use software footnote/endnote feature.** Combine all footnotes on a separate page immediately following the manuscript text. **Do not place footnotes at bottoms of manuscript pages.**
8. *References / Text Citations.* In a reference section immediately following the footnotes page, list all works cited in the text, alphabetized by author last name. Refer to current issues of the *JARE* for format. For within-text citations (either parenthetical or as part of narrative), spell out up to three author last names; use first author's name followed by "et al." for works with four or more authors. Include the publication year only if there is more than one work by the same author(s). When citing a direct quotation, include page number(s) from the author's work.
9. *Figures and Tables.* Place each figure and table on a separate page at the end of the manuscript. Computer-generated graphics for figures (Microsoft Excel, Corel Presentations, Corel Quattro Pro, Power Point, Word Perfect) are preferred. **Do not place figure title/caption within graphics box.**
10. *Math / Equations.* Consecutively number equations throughout the text. When displaying equations, place equation number within parentheses at flush-left margin; center the equation. Use *italic* typeface for all *variables*, and use **boldface** (no italics) for all **vectors** and **matrices**—both within equations and within narrative.
11. *Publication Costs.* Authors submitting manuscripts are expected to assume obligation for payment of page charges at the time their manuscripts are published. Current page charges are \$60/printed page for WAEA members and \$70/printed page for nonmembers.
12. *Submissions.* Electronic submission of manuscripts is highly encouraged. Please submit a cover letter and the manuscript in separate files formatted as Adobe Acrobat (\*.pdf) files, attached to an e-mail to [jare@ag.arizona.edu](mailto:jare@ag.arizona.edu). If using standard mail for your submission, send **four** good quality hard copies to the address below. Receipt of manuscripts will be acknowledged by return mail.
