Editor's Note: In its 1992 annual business meeting, the NAREA Executive Committee and the general membership voted to change the name of the *Northeastern Journal of Agricultural and Resource Economics* (NJARE) to *Agricultural and Resource Economics Review* (ARER). The *NJARE* was published starting with volume 13, number 2, October 1984 and ending with volume 21, number 2, October 1992. The name change to *ARER*, effective with the April 1993 issue, was undertaken to broaden the scope of the journal and communicate theoretical, applied, and empirical findings in agricultural and resource economics to regional as well as national and international audiences. It is the editorial policy of the *ARER* to encourage manuscript submission without regard to author(s) affiliation and/or location.

In this issue, there are 12 regular articles accepted, one invited article focusing on industrialization in U.S. agriculture, and one comment and reply on an article. All manuscripts were reviewed by at least two reviewers. Three new editorial board members begin their three-year term with this issue. They are Jorge Fernandez-Cornejo (USDA-ERS), Rodolfo M. Nayga, Jr. (Rutgers) and Lois Schertz Willett (Cornell). I would like to thank John Halstead (New Hampshire), Ralph Heimlich (USDA-ERS), and Harry Kaiser (Cornell) for their three-year service as editorial board members. Finally, I would also like to take this opportunity to welcome Linda K. Lee (Connecticut) who has been appointed as the next editor of *ARER*. Her term will begin on June 1, 1995 when she will start to receive new manuscript submissions. I will continue to receive manuscript submissions until May 31, 1995.

THEME: New Issues and Fresh Approaches for Agricultural and Resource Economics

The Agricultural and Resource Economics Review will publish papers on the theme "New Issues and Fresh Approaches for Agricultural and Resource Economics" as a special section of its Spring 1996 issue. In the papers, author(s) are expected to identify and discuss emerging issues and/or research methods and approaches of interest to the profession. Idea papers are welcomed as well as theoretical and empirical work. Papers will be subject to blind-review. There will be page charges on published articles.

General areas that might be addressed by author(s) include current and emerging issues that could be relevant for future analysis by the profession, applications of promising techniques and tools from other disciplines, and theoretical and analytical developments and challenges.

Papers could address applications and analysis relevant to specialty areas including international development and agriculture, resource and environmental economics, regional and community development, and agricultural production, marketing, finance, and policy.
