FROZEN FOOD LOCKER AND FREEZER PROVISIONING FIRMS
IN THE UNITED STATES¹

Twenty-Third Annual Count, January 1960

A total of 9,875 frozen food locker and freezer provisioning firms were reported operating in the United States in January 1960.² Of this total, the survey showed that 8,965 firms provided locker rental service in addition to processing and merchandising. It also showed that 910 firms had no lockers but specialized in processing and merchandising frozen food for home freezer users, institutions, and wholesale and retail outlets.

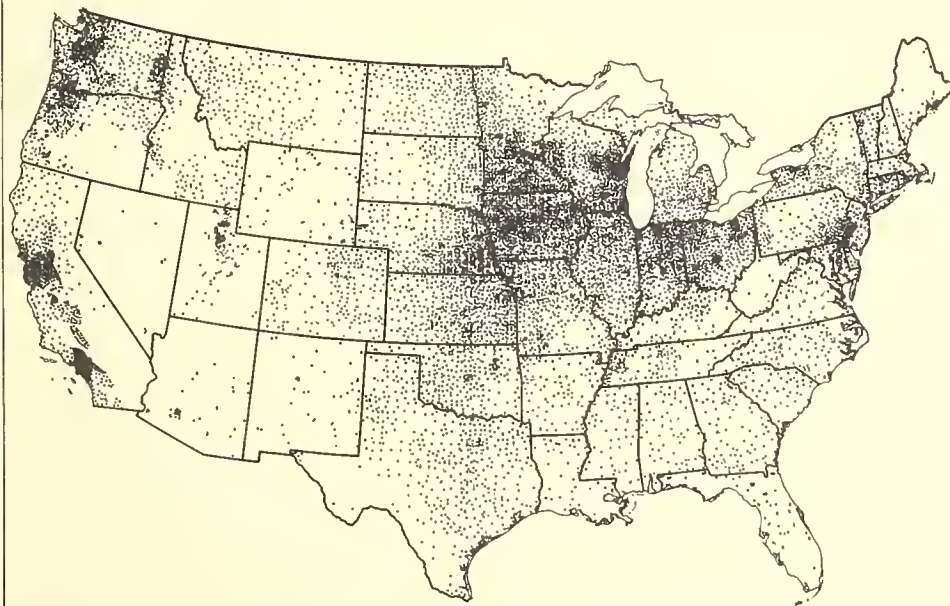
The volume of food processed and the number of patrons served have increased 50 percent during the past 10 years. One out of every seven families is being served by this industry. The value of food sold reached \$550 million in 1959 which was double that of 5 years ago. Total sales of food, freezers, supplies, and services reached \$844 million.

While the number of locker firms showed a decline of 306 as compared with last year, the total number of firms was substantially ahead of a year ago due to the inclusion of freezer provisioning firms for the first time this year. Iowa again led with 689 firms, Wisconsin came second with 616, and Minnesota third with 613 (table 1).

The frozen food locker industry is continuing to change the nature and scope of its activities from custom processing and renting lockers to commercial processing and merchandising for home freezer users, institutions, and other outlets.

While the number of locker plants has declined by about 2,600 since the peak year of 1951, over 900 new "Freezer Provisioning" firms have been established during the past 10 years and many locker plants have greatly expanded their own commercial processing and merchandising activities (table 2).

Net zero storage space in locker and home freezers totaled approximately 213 million cubic feet in January 1960, a 50 percent increase over 1955. This large zero storage space is capable of holding at one time approximately 6.4 billion pounds of perishable food.

Locker and freezer provisioning firms are becoming increasingly important as processors and suppliers of frozen food in quantity lots to consumers.
