Information for JTRF Contributors

I. EDITORIAL POLICY

The *Journal of the Transportation Research Forum* (JTRF) seeks original manuscripts (i.e., articles, industry issue papers, comments, and book reviews), which are timely in scope and germane to transportation. Articles are predicated in empirical and/or theoretical research of transportation problems and issues. Industry issue papers may be descriptive in nature, addressing current issues that affect or will affect transportation industries (e.g., air, rail, and truck). Comments to articles and industry issue papers are encouraged. Sales presentations for products veiled as articles, industry issue papers, or comments are not suitable for the JTRF.

II. PUBLICATION INFORMATION

Articles and industry issue papers are refereed in a double blind process, not including an associate editor and the general editor. Comments to articles and industry issue papers are reviewed by the general editor along with the appropriate associate editor(s). Authors should send a disk in Microsoft Word format and four (4) copies of their article, industry issue paper, or comment to:

The text of manuscripts is to be double-spaced. Articles are limited to a **maximum length of 30 pages**; industry issue papers and comments are limited to a **maximum length of 15 pages**. To insure the integrity of the double blind review process, the author or authors (along with manuscript title, mailing and E-mail addresses, telephone, and fax numbers) should be identified on a separate cover sheet and not on the manuscript itself.

The abstract should briefly describe the contents, procedures, and results of the manuscript, not its motivation. Endnotes are to be used rather than footnotes; figures (noting where to insert in the text) are to be included on disk (the preferred format) or submit original artwork, drawn in black ink on separate sheet(s) of paper, in camera-ready format.

The Harvard system of references is to be used. In the body of the text, a reference is referred to by the author's surname with the year of publication in parentheses. At the end of the manuscript, complete references are given alphabetically by authors surnames; journal titles should not be abbreviated, e.g.:

Corsi, T., Dresner, M. and Windle, R. (1997) Air Passenger Forecasts: Principles and Practices. *Journal of the Transportation Research Forum* 36, 42-62.

DeVany, A. and Walls, W.D. (1994) Network Connectivity and Price Convergence: Gas Pipeline Deregulation. In *Research in Transportation Economics*, ed B.S. McMullen, pp. 1-36. JAI Press, London.
