**Two TRF Bylaw Amendments Approved at the TRF Annual Membership Business Meeting
held October 11, 1989, at Williamsburg, Virginia**

FIRST AMENDMENT:

The bylaws of the Transportation Research Forum are hereby amended by removing from the bylaws the language that is circled, and by adding the language that is underlined:

ARTICLE VI – Officers

- Sec. 4 The Vice President – Program, with the assistance of the Program Committee and the guidance of the Council, shall be responsible for program development of the Annual Meeting, and the editing and selection of papers for publication.
- Sec. 5 The Vice President Elect – Program shall preside at meetings of the Program Committee in the absence of the Vice President – Program and otherwise assist in the development of the program for the Annual Meeting, and the editing and selection of papers for publication.
- Sec. 8 The Vice President – Academic Affairs shall undertake programs to involve academic persons in TRF; shall encourage subscriptions to the Journal and other TRF publications; shall encourage the contribution of student papers for the Annual Meeting; shall select those student papers to be published and presented at the Annual Meeting; and with the Vice President-Membership, shall assist in developing student membership.

ARTICLE VII – Council

- Sec. 1 The management of the Forum and the authority for the conduct of its affairs shall be vested in a Council consisting of twelve (12) Officers, the immediate Past President, the Chapter Presidents, and eight (8) Council members at large who shall be selected to represent a broad range of transportation research interests, and the editors of the Journal and the Newsletter.

Sec. 5 At the TRF Annual Forum in 1989, and at the TRF Annual Forum each three (3) years thereafter, during a meeting of the TRF Council, the TRF Council shall elect an editor of the Newsletter for a term of office of three (3) years. At the TRF Annual Forum in 1991, and at the TRF Annual Forum each three (3) years thereafter, during a meeting of the TRF Council, the TRF Council shall elect one (1) or more editors of the Journal for a term of office of three (3) years. Editors may be removed, and vacancies may be filled, by a majority of the TRF Council during any meeting of the TRF Council. Editors may service only one (1) consecutive term. Editors may appoint and remove associate and book review editors.

SECOND AMENDMENT:

The bylaws of TRF are hereby amended by adding at the end of article VII, section 5, the following sentence: "Editors shall be voting members of the TRF Council."
