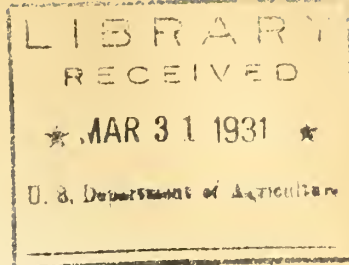

RICE AND RICE PRODUCTS: ANALYSIS OF FOREIGN TRADE
OF THE UNITED STATES

The United States exports rice in considerable volume but the quantity is small in comparison with the exports from Burma, Siam and Indo-China, the three most important surplus producing countries. With the growth in production, rice is becoming a more important factor in our foreign trade. Average net exports during 1926-1930 amounted to 216,029,000 pounds as compared with a net import of 184,739,000 pounds during 1910-1914. Prior to 1911, rice bran, meal and polish made up the major portion of the exports but since that date a much smaller per cent of the total consists of this type of rice. Several radical changes have taken place in our foreign trade since 1790. For purposes of discussion the years since 1790 have been divided into three periods as follows: 1790-1861 when exports were large; 1862-1916 when imports exceeded exports, and 1917-1930, a second period of heavy exports.

1790-1861

Even during the Colonial period rice was an important crop in the Carolinas and Georgia, and because the population was small more rice was produced than could be consumed at home. However, there was a ready market in England to which country the greater part of the crop was sent. Except for 1808 and 1814 when exports were unusually low and in 1828 and 1829 when they exceeded 100,000,000 pounds, the quantity sent to foreign countries ranged between 34,000,000 pounds and 86,000,000 pounds annually. In addition to the United Kingdom considerable quantities of rice were also sent to Cuba and the other West Indies.

1862-1916

Production of rice was greatly affected by the Civil War. As a result of the destruction of property and the scarcity of money and labor production was greatly reduced in the South Atlantic States. We were no longer able to supply our own needs and it became necessary to import practically as much as had formerly been exported. By the aid of irrigation large areas in Louisiana, southeastern Texas and eastern Arkansas were given over to the production of rice. This gave considerable impetus to the export trade in the latter part of the 80's but a large portion of the exports consisted of rice bran, meal and polish and it was necessary to import large quantities of higher grade rice in order to supply domestic demands. As a result net imports moved rapidly upward and reached a maximum of 249,994,000 pounds in 1914.

Oriental countries, more especially Burma, Indo-China and Siam supplied most of our imported rice. Much of it was sent to Germany, the Netherlands and the United Kingdom as rough rice where it was milled and then reshipped to the United States.

1917-1930

About 1917 another shift in our foreign trade in rice took place. In 1912, production of rice in California had been placed on a commercial basis. Expansion was rapid, exports began to climb and again exceeded imports.

Because of the changes in marketing methods and the rearrangement of the great trade routes which followed the World War most of the cleaned rice imported into this country is now received direct from the primary markets of Burma and Indo-China instead of being sent to European countries to be milled. Most of the uncleaned rice received from foreign sources comes from Mexico and Japan. Orientals on the Pacific coast consume most of the rice imported from Japan.

The United Kingdom, Cuba, Canada and Argentina take most of our exports of rice produced in the southern states. Japan is the leading foreign market for California rice which is of the same type as that grown in Japan. About one-fourth of the total exports of rice from the United States consists of rice flour, meal and broken rice.

Shipments to Alaska, Hawaii and Porto Rico

In addition to domestic exports, continental United States sends large quantities of rice to her outlying possessions, shipments to Porto Rico and Hawaii being especially large and showing a very marked upward trend. Shipments to these non-contiguous territories frequently exceed the total exports to foreign countries.

Hawaii is the most important outlet for California rice, most of which leaves the country through the port of San Francisco. During 1925-1930 shipments to Alaska, Hawaii and Porto Rico averaged 258,047,000 pounds or nearly double the quantity shipped to these outlying possessions during 1910-1914. Approximately 73 per cent of the shipments go to Porto Rico, 26 per cent to Hawaii and less than 1 per cent to Alaska.

EXPLANATION OF TERMS

DOMESTIC EXPORTS - Goods produced or manufactured in this country from either domestic or imported raw materials and which are shipped to foreign countries. The kind, quantity and value of exported merchandise are ascertained from the shipper's export declarations filed by the exporters with the collector of customs at the port of exportation.

Include exports to the Philippine Islands and Virgin Islands of the United States. Since 1902, excludes shipments from the United States to Alaska, Hawaii and Porto Rico.

1790-1802 - Include reexports or exports of foreign merchandise.

IMPORTS, GENERAL - Embrace articles entered at the customhouses for immediate consumption and imported articles entered for warehouse. Imports prior to 1821 are incomplete, as imports paying ad valorem duties were reported in value, but not in quantity and prior to 1817 the imports paying specific duties were reported in quantity but not in value.

Include imports from the Philippine Islands and Virgin Islands of the United States. Since 1902, exclude shipments to the United States from Alaska, Hawaii and Porto Rico.

IMPORTS FOR CONSUMPTION:- Embrace articles entered for immediate consumption and imported articles withdrawn from warehouse for consumption. The statement of general imports and the statement of imports entered for consumption for any period will always differ to the extent that the value of entries for warehouse for the period differs from the value of withdrawals from warehouse for consumption. The term "entry for consumption" is the technical name of the import entry made at the customhouse and implies that the goods have been delivered into the custody of the importer and that the duties have been paid on the dutiable portion. Some of them may be afterward exported.

Imports for consumption were first reported in 1867 and published in 1868.

KIND, QUANTITY AND VALUE OF IMPORTS - The kind, quantity and value of imported merchandise are ascertained from the entry filed by the importer at the customhouse.

The value of imported merchandise as shown in the statistical tables is the foreign value or the export value, whichever is higher; that is, the market value or the price at which the merchandise, at the time of exportation to the United States, is offered for sale in the principal markets of the country from which exported, including the cost of containers or coverings and all expenses incident to placing the merchandise in condition ready for shipment to the United States.

REEXPORTS OR EXPORTS OF FOREIGN MERCHANDISE - Goods which have been imported into this country either for reexport or consumption and are afterward exported having undergone no change in form or condition or enhancement in value by application of labor in the United States.

1790-1802 - Combined with domestic exports.

NET EXPORTS - Domestic exports and reexports minus imports.

NET IMPORTS - Imports minus domestic exports and reexports.

AVERAGE EXPORT VALUE PER UNIT - These have been computed by dividing the total export value each year by the total quantity and are not to be regarded as a quotation of prices.

The value upon which a given average in this table was based is composed of items which represent shipments possibly of different grades of the articles mentioned from different parts of the United States and at different seasons of the year. The actual value of any one shipment included in this total is its value at the time and place of exportation.

CONVERSIONS - 1 tierce = 600 pounds (1790-1865).
1 barrel = 400 pounds (1865-1865).
1 bushel of rough rice (unhulled) = 45 pounds.
1 bushel of cleaned rice = 61 pounds.
100 pounds of cleaned rice = the product of 162 pounds of rough.

YEARS - The years end as follows: September 30, 1790-1842; nine months, October 1, 1842 - June 30, 1843; June 30, 1844-1930.

LEADERS - Indicate no information exists but do not necessarily signify that there were no reports for that period as they may have been included with "all other" or with the "unenumerated".

NONCONTIGUOUS TERRITORY - In the statistics of foreign commerce of the United States, the Philippine Islands and Virgin Islands of the United States are treated as foreign countries.

The statistics of foreign commerce include the trade of the customs districts of Alaska, Hawaii and Porto Rico with foreign countries but do not include the trade of these territories with the United States.

In 1903, the trade with Alaska, Hawaii and Porto Rico was for the first time fully and definitely recorded (See Commerce and Navigation of the United States, 1903, Vol. 1, page 31). Therefore separate tables have been compiled showing the trade between the United States and Alaska, Hawaii and Porto Rico, 1903-1930.

The collection of statistics of trade with all noncontiguous territories was authorized by an act of Congress, April 29, 1902.

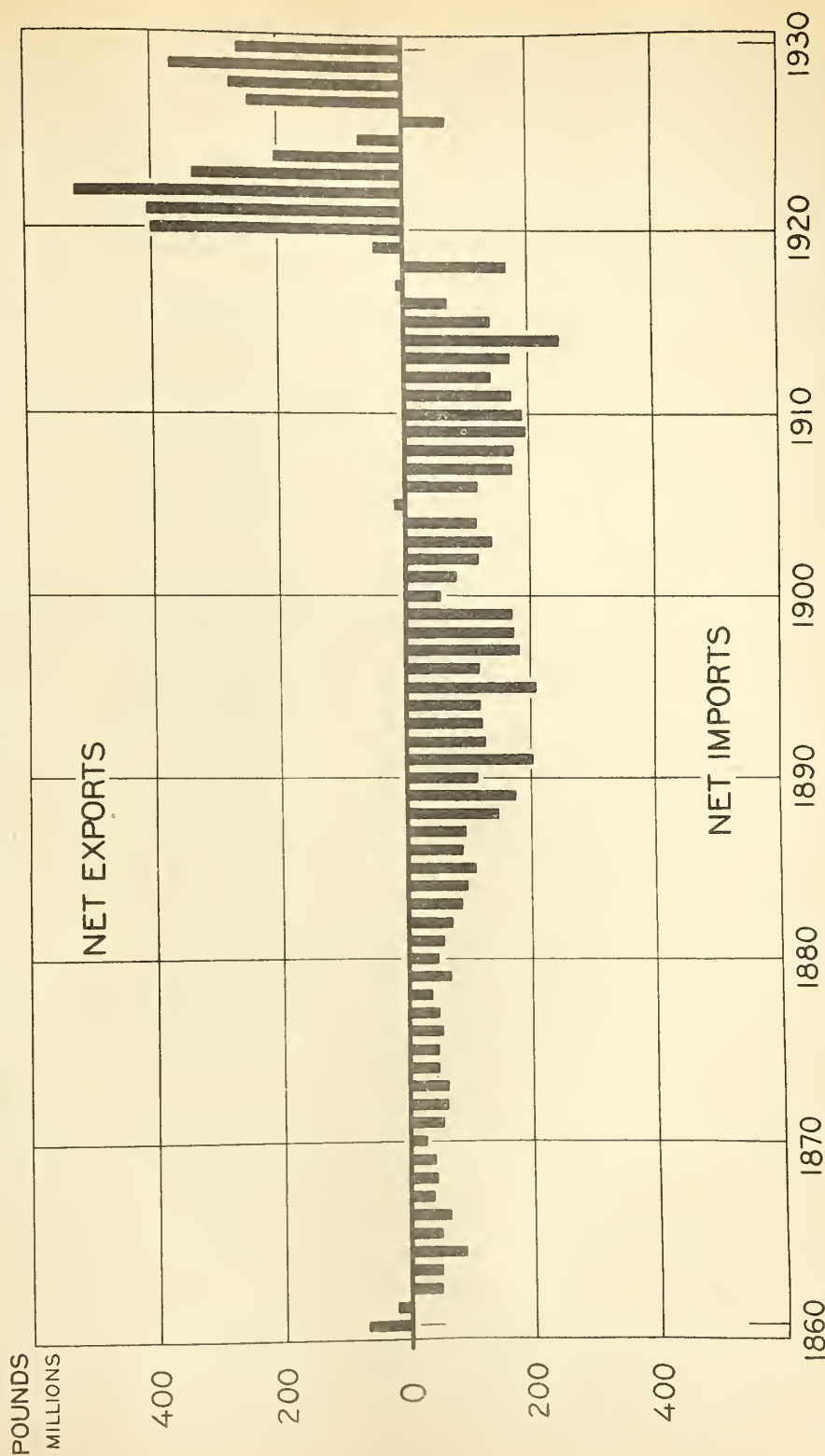
