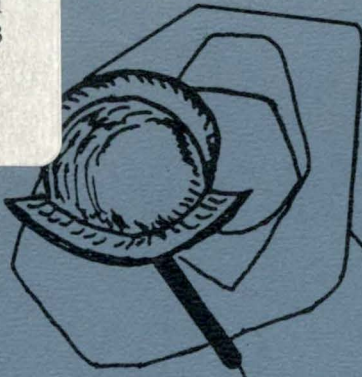

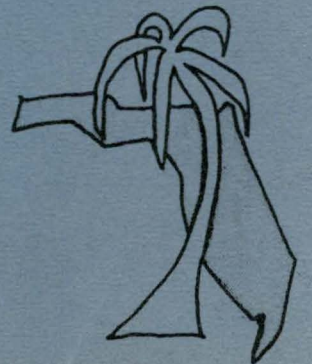

## Foreward
