This special issue of the *International Food and Management Review* is dedicated to teaching cases. Case studies have long been an important tool in the teaching of business management. Unfortunately, cases addressing problems in the food and agribusiness industry are difficult to find. A parallel issue for authors of case studies is that they have relatively few outlets for the cases that they write. Editors and publishers continue to struggle with how to evaluate the quality of case studies.

This special issue, edited by James Beierlein of Pennsylvania State University, addresses all of these issues. The lead article, "Scholarship and Decision Cases: Pedagogy and Standards for Publication," clearly identifies the role of case studies in student learning and criteria for evaluating the quality of "decision case studies." This article will be useful to people writing case studies, particularly if they are to be submitted for publication in this journal. This issue also contains several new case studies in diverse areas including food processing, meat, food distribution, and dairy.

All of the case studies published in this issue are available for use by educators.
