Editorial Policy

The Journal of Agricultural and Resource Economics seeks to publish creative and scholarly economic studies in agriculture, natural resources, and related issues. Manuscripts dealing with the economics of food and agriculture, natural resources and the environment, human resources, and rural regions are encouraged. The Journal seeks to provide a forum for topics of interest to those performing economic research as well as to those involved with economic policy and education. Submission of comments on articles previously published in the Journal is welcomed.

Editorial Communications

All initial submissions and accompanying editorial correspondence should be submitted electronically to editor David K. Lambert at our *JARE* internet website. (Refer to Author Guidelines, inside back cover of this journal issue, for full information.)

AUTHOR GUIDELINES FOR SUBMITTING MANUSCRIPTS TO JARE

Contributors are requested to use the following guidelines in preparing manuscripts for submission. Please note that the *JARE* accepts only electronic submission submitted in PDF format at http://www.jareonline.org (additional information on submissions is provided below).

- 1. Author Certifications. Authors submitting manuscripts to the JARE certify that the material in the manuscript (or modification thereof) has not been published, is not being published, and is not currently being considered for publication elsewhere. Authors also certify that the material in the manuscript, to the best of the author's knowledge, does not infringe upon other published material protected by copyright. Authors also certify they have read and agree to the policy on data access and estimation procedures outlined below.
- 2. Data Access and Estimation Procedures. Authors are expected to document their data sources, data transformations, models, and estimation procedures as thoroughly as possible. Authors are also expected to make data available at cost for replication purposes for up to five years.
- 3. Title Page. Provide the title of the manuscript and author(s)' name(s) centered and in boldface type. At the bottom of the same page, provide professional title(s), institutional affiliation(s), acknowledgments of colleague reviews and assistance, and institutional support as an unnumbered footnote. Do not place the name(s) of the author(s) on the first page of the text. The title page will be removed from the manuscript before it is sent to reviewers.
- 4. Abstract. Include an abstract of 100 words or less, followed by up to eight key words (or short phrases) listed in alphabetical order.
- 5. Text. Suggested manuscript length is no more than 25 text pages (not including reference list, tables, and graphics). Double space all text, including the abstract, acknowledgments, footnotes, and references. Use a 12-point Times Roman font and allow 1" margins on all sides. Do not use right-justified margins or end-of-line hyphenation feature.
- 6. Style, Grammar, and Punctuation. The JARE uses The Chicago Manual of Style by the University of Chicago Press, and Webster's Third New International Dictionary for style, format, and spelling.
- 7. Footnotes. Insert superscript numbers within the text to denote footnotes, numbered consecutively throughout the manuscript. Combine all footnotes on a separate page immediately following the manuscript text.
- 8. References/Text Citations. In a reference section immediately following the footnotes page, list all works cited in the text, alphabetized by author last name. Refer to current issues of the JARE for format. For within-text citations (either parenthetical or as part of narrative), spell out up to three author last names; use first author's name followed by "et al." for works with four or more authors. Include the publication year with all text cites. When citing a direct quotation, include page number(s) from the author's work.
- 9. Figures and Tables. Place each figure and table on a separate page at the end of the manuscript. Whenever possible, preferred (but not required) software for figure generation is Microsoft Excel. **Do not place figure title/caption within the figure graphics box.**
- 10. *Math/Equations*. Consecutively number equations throughout the text. When displaying equations, place equation number within parentheses at flush-left margin; center the equation. Use *italic* typeface for all *variables*, and use **boldface** (no italics) for all **vectors** and **matrices**.
- 11. Publication Costs. Authors submitting manuscripts are expected to assume obligation for payment of page charges at the time their manuscripts are published. Current page charges are \$60/printed page for WAEA members and \$70/printed page for nonmembers.
- 12. Submissions. All submissions to the Journal of Agricultural and Resource Economics must be submitted electronically to the editorial team. Submissions can be made at the JARE URL: http://www.jareonline.org.

 To ensure author anonymity, the JARE accepts submission only in PDF format. Each submission will be stripped of author and institutional identification by the editorial team before it is sent to reviewers. Receipt of manuscripts will be acknowledged by e-mail.

Penelope (Penny) L. Diebel

WAEA President, 2008-2009



Penelope (Penny) L. Diebel is associate professor in the Department of Agricultural and Resource Economics at Oregon State University's off-campus program, OSU Agriculture at EOU. Penny received a B.S. (1983) in Outdoor Recreation Management and an M.S. (1986) in Agriculture and Natural Resource Economics, both from Colorado State University. In 1990, she received her Ph.D. in Agricultural Economics from Virginia Tech.

Dr. Diebel teaches a variety of courses, from freshman orientation to a natural resource economics capstone. She serves as Ag Club and Ag Ambassador Program advisor, undergraduate recruiter, and curriculum advisor. Penny is profiled on Oregon State University's Best Teaching Practices Faculty website and the Registry of Distinguished Teachers. She has been the recipient of numerous teaching awards from Oregon State University (2006, 2002, and 1999), the Western Agricultural Economics Association (2000), and the National Association of Colleges and Teachers of Agriculture (1997).

Her current teaching research program includes distance education pedagogy and

student retention issues. She also has research projects involving the economics of grass seed field burning alternatives and Christmas tree best management practices. As a faculty member in the Department of Agricultural Economics, Kansas State University (1990–1994), she was active in the Economic and Environmental Implications of Cropland Subject to Expiring Conservation Reserve Contracts Project (1991–1998), was co-recipient of a *Journal of Soil and Water Conservation* Best Research Article Award (1996), and Berg Fellow (1992).

Penny has served the WAEA for many years—as Vice-President (2005–2006), Awards Chair (2004–2005), director (2003–2005), and in many other positions. She has also served the American Agricultural Economics Association, including Policy Award Committee Chair (2004–2005) and Student Section-AAEA Advisor (1995–1998).

As WAEA President, Penny hopes to encourage increased participation of the WAEA Executive Committee and Council representatives throughout the year and increase communication with members. As a long-time member, Penny recognizes the attraction of the WAEA as a small, professional organization and hopes to foster its collegial but professional atmosphere through continued support of the Journal of Agricultural and Resource Economics, the Western Economics Forum, and by encouraging the use of the WAEA annual meetings as a discussion forum for developing research ideas and partnerships.
